AN ACT

- Expanding the natural gas infrastructure throughout this Commonwealth through competitive sealed bidding; and
- providing for powers and duties of the Pennsylvania Public
- 4 Utility Commission.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Natural Gas
- 9 Infrastructure Expansion and Access Act.
- 10 Section 2. Findings.
- 11 The General Assembly finds that:
- 12 (1) This Commonwealth is fortunate to have one of the
- 13 most abundant and diverse mineral resource fields in the
- 14 world, including the Marcellus Shale natural gas reserves.
- 15 (2) Marcellus Shale offers tremendous economic and
- energy independence opportunities for this Commonwealth.
- 17 (3) The responsible development of natural gas resources
- will position this Commonwealth in the global marketplace as
- 19 a world leader in energy supply and reduce our dependence on

- 1 foreign oil.
- 2 (4) Expanding access to natural gas throughout this
- 3 Commonwealth will enable more residents and businesses to
- 4 benefit from this abundant, clean, low-cost domestic energy
- 5 source.
- 6 Section 3. Definitions.
- 7 The following words and phrases when used in this act shall
- 8 have the meanings given to them in this section unless the
- 9 context clearly indicates otherwise:
- 10 "Commission." The Pennsylvania Public Utility Commission.
- "Competitive sealed bidding." The process specified in 62
- 12 Pa.C.S. § 512 (relating to competitive sealed bidding).
- "Distribution system." A system owned and operated by a
- 14 natural gas distribution utility.
- 15 "Expansion project." Modification to an existing pipeline,
- 16 main extension or service line to one or more residential,
- 17 commercial or industrial entities not receiving natural gas
- 18 service within an existing certificated service area.
- 19 "Extension project." New construction of a service line,
- 20 main extension or pipeline to provide natural gas service to one
- 21 or more residential, commercial or industrial entities not
- 22 receiving natural gas service and for which a certificate of
- 23 public convenience is required under 66 Pa.C.S. § 1102 (relating
- 24 to enumeration of acts requiring certificate) that is not within
- 25 the current certificate of public convenience territory issued
- 26 by the Pennsylvania Public Utility Commission to the natural gas
- 27 distribution utility.
- "Natural gas distribution utility." As defined in 66 Pa.C.S.
- 29 § 1403 (relating to definitions).
- 30 Section 4. Identification and designation of corridors.

- 1 (a) Identify and designate. -- Within six months after the
- 2 effective date of this section, the commission shall identify
- 3 and designate corridors throughout this Commonwealth for
- 4 construction of natural gas infrastructure extension and
- 5 expansion projects to unserved or underserved areas.
- 6 (b) Publish corridors for bidding. -- The commission shall
- 7 publish as a notice in the Pennsylvania Bulletin a listing of
- 8 corridors and specifications by which a person, company or
- 9 natural gas distribution utility may make a competitive sealed
- 10 bid for one or more of the corridors. The commission shall
- 11 follow any requirements under 62 Pa.C.S. § 512 (relating to
- 12 competitive sealed bidding).
- 13 Section 5. Construction of natural gas infrastructure.
- 14 (a) Construction. -- The person, company or natural gas
- 15 distribution utility awarded the bid must construct in the
- 16 corridor a natural gas infrastructure extension or expansion
- 17 project.
- 18 (b) Exclusive rights. -- The person, company or natural gas
- 19 distribution utility awarded the bid shall have the exclusive
- 20 right in the corridor as it relates to the natural gas pipeline
- 21 and any potential customers that may be served by the pipeline.
- 22 (c) Existing gas lines. -- The person, company or natural
- 23 gas distribution utility awarded the bid shall have the ability
- 24 to tap into an existing natural gas pipeline for a fee to be
- 25 regulated and determined by the commission.
- 26 Section 6. Commission.
- 27 (a) Powers, duties and regulations. -- The commission shall
- 28 promulgate regulations to implement the provisions of this act.
- 29 The regulations shall cover any fees or prices as it relates to
- 30 the natural gas infrastructure project, including, but not

- 1 limited to, customer connection fees and the laying of pipes.
- 2 (b) Reporting. -- The commission shall require a filing of
- 3 information by the person, company or natural gas distribution
- 4 utility awarded the bid to ensure full compliance with this act.
- 5 Section 7. Deposit of revenue.
- 6 Any revenue raised from the bidding of corridors shall be
- 7 deposited into the General Fund.
- 8 Section 8. Effective date.
- 9 This act shall take effect immediately.
