AN ACT

1 Authorizing the release of Project 70 restrictions on certain
2 lands owned by the City of Lancaster, Lancaster County, in
3 exchange for the imposition of Project 70 restrictions on
4 other lands owned by the City of Lancaster, Lancaster County,
5 and other consideration.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. Authorization.

9 (a) Authorization.--Pursuant to the requirements of section
10 20(b) of the act of June 22, 1964 (Sp.Sess., P.L.131, No.8),
11 known as the Project 70 Land Acquisition and Borrowing Act, the
12 General Assembly hereby authorizes the release of Project 70
13 restrictions on land owned by the City of Lancaster, described
14 in subsection (b) in return for the imposition of Project 70
15 restrictions on land described in subsection (c) and additional
16 consideration described in subsection (e).

17 (b) Land to be released from Project 70 restrictions.--

18 The land to be released from Project 70 restrictions is as
19 follows:

20 All that certain tract of land situate in the Township of

1 Lancaster, County of Lancaster, and Commonwealth of Pennsylvania
2 being more particularly described as follows, to wit:

3 Beginning at a Point in the northeasterly Right of Way line
4 (ROW) of Ranck Road, corner to lands of the City of Lancaster
5 (City), and proceeding thence;

6 1. Along the ROW of said Ranck Road North $28^{\circ}00'10''$ West
7 a distance of 360.15 feet to a point in same, thence;

8 2. Along same North $28^{\circ}22'10''$ West a distance of 49.14
9 feet to a point in same, thence;

10 3. Along same North $61^{\circ}44'07''$ East a distance of 26.98
11 feet to a point in same, thence;

12 4. Along same North $28^{\circ}15'53''$ West a distance of 14.03
13 feet to a point of curvature in same, thence;

14 5. Along same curving to the right with a radius of 60.00
15 feet an arc distance of 56.87 feet to a point of tangency in
16 same, the chord of said curve bearing North $1^{\circ}06'34''$ West for
17 a distance of 54.77 feet, thence;

18 6. Along same North $26^{\circ}02'46''$ East a distance of 125.74
19 feet to a point, thence;

20 7. Leaving said ROW and passing through lands of the City
21 of Lancaster of which this tract is a part, South $82^{\circ}41'02''$
22 East a distance of 43.74 feet to a point, thence;

23 8. Through same North $74^{\circ}33'48''$ East a distance of 84.16
24 feet to a point, thence;

25 9. Through same South $80^{\circ}39'16''$ East a distance of 90.95
26 feet to a point, thence;

27 10. Through same South $55^{\circ}53'54''$ East a distance of 48.52
28 feet to a point, thence;

29 11. Through same South $38^{\circ}08'48''$ East a distance of 35.84
30 feet to a point, thence;

1 12. Through same South 11°12'31" East a distance of 49.54
2 feet to a point, thence;

3 13. Through same South 1°39'26" West a distance of 61.74
4 feet to a point, thence;

5 14. Through same South 11°52'03" East a distance of 27.04
6 feet to a point thence;

7 15. Through same South 21°19'52" West a distance of 23.30
8 feet to a point, thence;

9 16. Through same South 12°08'06" East a distance of 32.75
10 feet to a point, thence;

11 17. Through same South 9°02'48" West a distance of 88.97
12 feet to a point, thence;

13 18. Through same South 6°15'38" East a distance of 29.90
14 feet to a point, thence;

15 19. Through same South 30°35'06" West a distance of 33.16
16 feet to a point, thence;

17 20. Through same South 13°01'15" West a distance of 40.78
18 feet to a point, thence;

19 21. Through same South 59°05'23" East a distance of
20 154.96 feet to a point in the line of lands now or formerly
21 of Wickersham Construction & Engineering, Inc., thence;

22 22. Along said Wickersham South 80°20'50" West a distance
23 of 267.16 feet to the Point and Place of Beginning.

24 Containing 3.5578 acres more or less.

25 (c) Land subject to the imposition Project 70
26 restrictions.--

27 The two parcels of land on which Project 70 restrictions are
28 to be imposed are as follows:

29 Parcel 1.A.

30 All that certain tract of land situated along the

1 northwestern bank of The Conestoga Creek in Manheim Township,
2 the County of Lancaster, and the Commonwealth of Pennsylvania
3 being bounded and described as follows:

4 Beginning at a point in the north or west bank of the
5 Conestoga Creek as it existed prior to the raising of the
6 Lancaster City Water Works Dam in 1933, and in the northeasterly
7 boundary line of the former Lancaster City Pump Station grounds,
8 now lands of The Pennsylvania Department of Transportation
9 (PennDOT), said lands having been acquired by deed dated
10 September 27, 1971 and filed at the Lancaster County Recorder of
11 Deeds Office in Deed Book X-61, at Page 242. Said lands being a
12 portion of Legislative Route 1124, AKA State Highway Route 23,
13 and also used as access to the Lancaster City Conestoga Water
14 Treatment Plant Bridge, said access also providing access to the
15 herein described property, thence;

16 1. Extending along PennDOT, North 6°36' East, 210.05 feet
17 to a stone, thence along remaining land of the Grantors the
18 following 8 courses and distances;

19 2. South 63°08' East, 194.35 feet, thence;

20 3. North 81°43' East, 105.06 feet, thence;

21 4. South 89°38' East, 102.11 feet, thence;

22 5. North 57°17' East, 63.15 feet, thence;

23 6. North 73°25' East, 199.69 feet, thence;

24 7. North 59°51' East, 96.62 feet, thence;

25 8. North 52°29' East, 98.18 feet, thence;

26 9. North 37°06' East, 18.65 feet to the inside edge of a
27 concrete dike around the Eagles Nest property of the
28 Grantors, at a point in the same 17.52 feet eastwardly from
29 the westernmost end of said dike, thence extending along the
30 inside wall of said concrete dike the following courses and

1 distances;

2 10. South 62°58' East, 27.08 feet, thence;

3 11. North 72°04' East, 35.31 feet, thence;

4 12. North 27°00' East, 136.91 feet, thence leaving said
5 dike;

6 13. North 69°05' West, 29.15 feet to a point inside said
7 dike, thence;

8 14. North 1°44' East, (crossing through or near the
9 northwestern most end of said dike) 92.03 feet, thence
10 extending further along remaining property of the Grantors
11 the following courses and distances;

12 15. North 4°13' West, 221.08 feet, thence;

13 16. North 7°39' West, 91.95 feet, thence;

14 17. North 20°05' West, 192.26 feet, thence;

15 18. South 74°17' East, 70.93 feet, thence;

16 19. South 34°34' East, 159.59 feet to a point in the West
17 Bank of the Conestoga Creek as it existed prior to the
18 raising of the City's Pumping Station Dam, aforesaid, thence
19 Southwardly along said West Bank (existing as aforesaid and
20 which bank may hereafter at times be underwater) the
21 following 12 courses and distances;

22 20. South 9°13' East, 253.11 feet, thence;

23 21. South 11°52' West, 339.10 feet, thence;

24 22. South 17°44' West, 254.68 feet, thence;

25 23. South 34°52' West, 101.87 feet, thence;

26 24. South 45°34' West, 70.09 feet, thence;

27 25. South 58°39' West, 92.70 feet, thence;

28 26. South 71°15' West, 122.48 feet, thence;

29 27. South 89°11' West, 124.68 feet, thence;

30 28. North 68°34' West, 260.16 feet, thence;

1 29. North 78°15' West, 128.30 feet, thence;
2 30. North 85°06' West, 94.22 feet, thence;
3 31. North 89°01' West, 117.10 feet to the Point and Place
4 of Beginning.

5 32. Containing 9.782 acres more or less.
6 Parcel 1.B.

7 All That Certain tract of land situate in the City of
8 Lancaster, County of Lancaster, and Commonwealth of Pennsylvania
9 being a portion of lands of the City of Lancaster located at 150
10 Pitney Road, Lancaster Pennsylvania being Lancaster County Tax
11 Parcel Number 336-61274-0-00000 and being more particularly
12 described as follows, to wit;

13 Beginning at a Point in the southeasterly bank of the
14 Conestoga River (left hand side going with the flow) where it
15 intersects the downstream or southwesterly line, or line
16 extended, of the Pleasure Road Bridge, running between Pleasure
17 Road and crossing said Conestoga River to lands of the City of
18 Lancaster being the Conestoga Water Treatment Plant (CWTP),
19 thence;

20 1. Through lands of the said City and along said extended
21 bridge line, South 28°49'45" East, a distance of 53.68 feet
22 more or less to a point on the southerly line of the roadway
23 leading from said bridge into the said CWTP, thence;

24 2. Along the edge of said roadway and the face of a
25 concrete retaining wall South 73°44'18" East, a distance of
26 33.88 feet to a point, thence;

27 3. Along said roadway and wall curving to the left with a
28 radius of 39 feet, an arc distance of 30.19 feet to a point
29 in both, the chord of said curve bearing North 84°30'54"
30 East, a distance of 29.79 feet, thence;

1 4. Along both and extending beyond both as they deviate
2 from a straight line North 62°19'03" East, a distance of
3 151.77 feet to a point in a chain link fence separating lands
4 of the CWTP from other lands of the City designated as
5 Conestoga Pines Park, thence;

6 5. Along said fence and Park South 82°49'10" East, a
7 distance of 97.79 feet to a point in same, thence;

8 6. Still along same South 57°22'40" East, a distance of
9 127.70 feet to a point in same, thence;

10 7. Still along same South 63°26'49" East, a distance of
11 42.86 feet to a point in same, thence;

12 8. Still along same South 83°51'30" East, a distance of
13 65.34 feet to a point same, thence;

14 9. Still along same South 66°18'49" East, a distance of
15 9.34 feet to a point in same, thence;

16 10. Leaving said fence and line and running mostly along
17 the approximate centerline of a bituminous roadway, this
18 course being set parallel to and 30 feet northwestwardly from
19 the face of the CWTP Old Filter Building, South 21°49'08"
20 West, a distance of 501.57 feet to a point in the
21 northeasterly Right of Way line (ROW) of the former
22 Pennsylvania Railroad Main Line (now AMTRAK) cited in the
23 index of the Lancaster County Recorder of Deeds Office to be
24 filed at Deed Book L-75, Page 385 (DB L-75/385), which deed
25 calls Conrail as the owner or record, thence;

26 11. Along said ROW North 68°43'38" West, a distance of
27 434.38 feet to a point in same, thence;

28 12. Leaving said ROW and mostly along a bituminous
29 roadway, this course being set parallel to and 30 feet
30 southeastwardly from the face of a brick building (adjacent

1 to 2 sheds) which building is approximately 220 feet from the
2 beginning of this course, North 21°56'21" East, a distance of
3 286.17 feet to a point where said line intersects the
4 extended line of the southwestwardly face of the brick Meter
5 Shop Building, thence;

6 13. Along said extended line North 68°42'05" West, a
7 distance of 177.26 feet to a point, thence;

8 14. Along a line deflecting to the left with an angle of
9 45°, South 66°17'55" West, a distance of 84.58 feet to a
10 point, thence;

11 15. Along a line set parallel to and 30 feet
12 northwestwardly from a line connecting the center points of
13 two open top round concrete tanks South 21°07'01" West, a
14 distance of 226.45 feet to a point in the aforesaid railroad
15 ROW, thence;

16 16. Along said ROW North 68°43'38" West, a distance of
17 142.59 feet to a point in same, thence;

18 17. Proceeding North 1°04'04" West, a distance of 26.78
19 feet more or less to a point in the aforesaid bank of the
20 Conestoga River, thence;

21 18. Along said river bank upstream in a northeasterly
22 direction a distance of 488 feet or such as the distance may
23 be to the Point and Place of Beginning. The Survey tie line
24 for this course, being for closure purposes only and not a
25 boundary line, bears North 59°19'08" East, a distance of
26 468.53 feet.

27 And Excepting and Reserving out the following lands:

28 Beginning at a Point said point being the following two
29 courses from the end of the tenth (10th) course of the above
30 description, to wit;

1 A. Along the above mentioned railroad ROW North 68°43'38"
2 West, a distance of 259.48 feet to a point, thence;

3 B. North 19°32'12" East, a distance of 30.41 feet to a
4 point being the corner of a one story steel storage building
5 for a Point of Beginning, thence;

6 1. Proceeding from said beginning point and along the
7 face of said building North 19°32'12" East, a distance of
8 26.64 feet to a point, thence;

9 2. Along same South 70°27'47" East, a distance of 48.50
10 feet to a point, thence;

11 3. Along same South 19°32'12" West, a distance of 26.64
12 feet to a point, thence;

13 4. Along same North 70°27'47" West, a distance of 48.50
14 feet to the Point and Place of Beginning.

15 Being a portion of lands of the City of Lancaster, said lands
16 consisting of an area of the Conestoga Water Treatment Plant.
17 The deed for said lands being recorded at DB B-44/500 in the
18 Lancaster County Recorder of Deeds Office.

19 Containing 255,596.13 square feet or 5.87 acres more or less.

20 CONTAINING a combined calculated area for Parcels 1.A. and
21 1.B. of 15.652 acres, more or less, of land.

22 (d) Deed restriction.--The deeds of conveyance for the
23 parcels described in subsection (c) shall contain the following
24 clause:

25 This indenture is given to provide land for recreation,
26 conservation and historical purposes, as said purposes are
27 defined in the act of June 22, 1964 (Sp.Sess., P.L.131, No.8),
28 known as the Project 70 Land Acquisition and Borrowing Act.

29 (e) Additional Consideration.--Within 5 years of the date of
30 conveyance of the above parcels described in subsection (c), the

1 City of Lancaster shall provide reasonable pedestrian and
2 vehicular access to both parcels of property on each side of the
3 river. If reasonable from both an engineering and financial
4 perspective, the City of Lancaster shall reassemble the
5 Armstrong Pedestrian Footbridge or another pedestrian bridge
6 over the Conestoga River, connecting parcel 1.A. to the
7 Conestoga Pines Park. Upon written request of the City of
8 Lancaster and approval from the Department of Conservation and
9 Natural Resources, which shall not be unreasonably withheld, the
10 time frame set forth in this subsection shall be extended for an
11 additional 5 years.

12 Section 2. Effective date.

13 This act shall take effect immediately.
