§ 322.1 Power to set fees by regulation.

(a) Authority.--

AN ACT

Amending Title 30 (Fish) of the Pennsylvania Consolidated 1 Statutes, in Pennsylvania Fish and Boat Commission, providing for power to set fees by regulation; in fiscal affairs, further providing for collection fee for uncollectible checks; in fishing licenses, further providing for 5 nonresident and tourist licenses, for one-day resident 6 fishing license, for license, permit and issuing agent fees 7 and for license and permit packaging options; in special 8 licenses and permits, further providing for net permits, for 9 boat and net licenses for boundary lakes, for permits for 10 protection and management of particular fish, for permits for 11 the use of explosives, for Lake Erie fishing permits and for 12 fishing guide and charter boat permits; in regulated fishing 13 lakes, further providing for licenses and for fees; in dams, 14 bar racks and migration devices, further providing for 15 obstructing migration of fish; in preliminary provisions, 16 further providing for fees; and, in registration and titling 17 of boats, further providing for issuing agents, for fees and 18 for notice for boats and related equipment. 19 20 The General Assembly of the Commonwealth of Pennsylvania 21 hereby enacts as follows: 22 Section 1. 10	(III) AFTER ADOPTION OF A FINAL-FORM REGULATION
11	CONTAINING A FEE CHANGE, THE COMMISSION SHALL SUBMIT THE
12	FINAL-FORM REGULATION, COPIES OF ALL PUBLIC COMMENTS AND
13	THE TRANSCRIPT OF THE PUBLIC HEARING TO THE GAME AND
14	FISHERIES COMMITTEE OF THE SENATE AND THE GAME AND
15	FISHERIES COMMITTEE OF THE HOUSE OF REPRESENTATIVES.
16	(IV) EITHER COMMITTEE UNDER SUBPARAGRAPH (III) MAY
17	REPORT A CONCURRENT RESOLUTION RECOMMENDING DISAPPROVAL
18	OF THE FEE CHANGE WITHIN 30 DAYS OF THE SUBMISSION UNDER
19	SUBPARAGRAPH (III). IF NEITHER COMMITTEE REPORTS A
20	CONCURRENT RESOLUTION RECOMMENDING DISAPPROVAL WITHIN THE
21	TIME PRESCRIBED IN THIS SUBPARAGRAPH, THE FEE CHANGE
22	SHALL BE DEEMED APPROVED.
23	(V) IF EITHER COMMITTEE REPORTS A CONCURRENT
24	RESOLUTION UNDER SUBPARAGRAPH (IV) AND THE GENERAL
25	ASSEMBLY DOES NOT ADOPT THE CONCURRENT RESOLUTION WITHIN
26	30 DAYS OF THE DATE ON WHICH THE CONCURRENT RESOLUTION IS
27	REPORTED, THE FEE CHANGE SHALL BE DEEMED APPROVED.
28	(VI) IF THE GENERAL ASSEMBLY ADOPTS A CONCURRENT
29	RESOLUTION UNDER SUBPARAGRAPH (IV) WITHIN 30 DAYS OF THE
30	DATE ON WHICH THE CONCURRENT RESOLUTION IS REPORTED. THE

1	FOLLOWING SHALL APPLY:
2	(A) THE CONCURRENT RESOLUTION SHALL BE PRESENTED
3	TO THE GOVERNOR IN ACCORDANCE WITH SECTION 9 OF
4	ARTICLE III OF THE CONSTITUTION OF PENNSYLVANIA.
5	(B) IF THE GOVERNOR DOES NOT VETO THE CONCURRENT
6	RESOLUTION OF THE GENERAL ASSEMBLY WITHIN TEN DAYS
7	AFTER THE RESOLUTION IS PRESENTED, THE FEE CHANGE
8	SHALL BE DEEMED DISAPPROVED.
9	(C) IF THE GOVERNOR VETOES THE CONCURRENT
10	RESOLUTION WITHIN TEN DAYS AFTER THE RESOLUTION IS
11	PRESENTED, THE GENERAL ASSEMBLY MAY OVERRIDE THE VETO
12	BY A TWO-THIRDS VOTE IN EACH HOUSE WITHIN 30 DAYS

14	OVERRIDE THE VETO IN THE TIME PRESCRIBED IN THIS

17	PRESCRIBED IN THIS CLAUSE, THE FEE CHANGE SHALL BE
18	DEEMED DISAPPROVED.
19	(VII) IF THE FEE CHANGE IS DEEMED APPROVED UNDER
20	SUBPARAGRAPH (IV), (V) OR (VI)(C), THE COMMISSION SHALL:
21	(A) SUBMIT THE FINAL-FORM REGULATION CONTAINING
22	THE FEE CHANGE TO THE OFFICE OF ATTORNEY GENERAL FOR
23	APPROVAL AS TO THE LEGALITY; AND
24	(B) PUBLISH AN ORDER ADOPTING THE FINAL-FORM
25	REGULATION CONTAINING THE FEE CHANGE AND DEPOSIT A
26	COPY OF THE FINAL-FORM REGULATION WITH THE
27	LEGISLATIVE REFERENCE BUREAU IN ACCORDANCE WITH
28	SECTION 207 OF THE COMMONWEALTH DOCUMENTS LAW.
