AN ACT

Gendebien Memorial Highway; designating a portion of State Route 2026, also known as Blair Mill Road, in Montgomery County as the Private First Class Paul T. Wright Memorial Highway; designating a bridge on a portion of Sheep Bridge Road over I-83, Newberry Township, York County, as the Staff 10 Sqt. Jason M. Faley Memorial Bridge; designating a bridge on 11 that portion of State Route 879 over Trout Run in Goshen 12 Township, Clearfield County, as the Private David Kyle 13 McCracken Memorial Bridge; designating a portion of State 14 Route 2034 in Montgomery County as the Cpl. Carl F. Hynek III 15 Memorial Highway; and designating a portion of State Route 2005 in Drexel Hill, Delaware County, as the Officer Dennis 16 17 McNamara Memorial Highway. DESIGNATING A PORTION OF STATE 18 <--19 ROUTE 145 IN SALISBURY TOWNSHIP, LEHIGH COUNTY, AS THE CPL. JOSHUA B. JONATHAN DEAN 21 22 FAIRCLOTH MEMORIAL BRIDGE; DESIGNATING A PORTION OF BYBERRY 23 24 ROAD BETWEEN WARMINSTER ROAD AND ORANGEMEN'S ROAD IN MONTGOMERY COUNTY AS THE MAJOR JEFFREY TOCZYLOWSKI MEMORIAL 25 HIGHWAY; DESIGNATING A PORTION OF STATE ROUTE 1010 IN BERKS 26 27 COUNTY AS THE DELIGHT BREIDEGAM, JR., MEMORIAL HIGHWAY; DESIGNATING A PORTION OF STATE ROUTE 51 IN FAYETTE COUNTY AS 28 29 THE OFFICER RICHARD CHAMPION MEMORIAL HIGHWAY; DESIGNATING A 30 BRIDGE ON THAT PORTION OF STATE ROUTE 741 OVER THE CONESTOGA RIVER, BETWEEN PEQUEA TOWNSHIP AND LANCASTER TOWNSHIP, 31 LANCASTER COUNTY, AS THE CPL. ERIC M. TORBERT, JR., MEMORIAL 32 BRIDGE; DESIGNATING THE INTERCHANGE OF STATE ROUTE 43, THE 33

- 1 MON-FAYETTE EXPRESSWAY, WITH RUBLES MILL ROAD, KNOWN AS EXIT
- 2 4, FAYETTE COUNTY, AS THE MASTER SGT. ARTHUR L. LILLEY
- 3 MEMORIAL INTERCHANGE; DESIGNATING A BRIDGE ON THAT PORTION OF
- 4 STATE ROUTE 770 OVER THE TUNUNGWANT CREEK, BRADFORD TOWNSHIP,
- 5 MCKEAN COUNTY, AS THE MASTER SGT. THOMAS MAHOLIC MEMORIAL
- 6 BRIDGE; DESIGNATING A BRIDGE TO BE CONSTRUCTED ON THAT
- 7 PORTION OF STATE ROUTE 6 OVER DINGMAN RUN, COUDERSPORT
- 8 BOROUGH, POTTER COUNTY, AS THE PFC GEORGE PESOCK MEMORIAL
- 9 BRIDGE; AND MAKING A RELATED REPEAL.
- 10 The General Assembly of the Commonwealth of Pennsylvania
- 11 hereby enacts as follows:
- 12 Section 1. Army Specialist Ray Ira Haas Memorial Highway.
- 13 (a) Findings.--The General Assembly finds and declares as
- 14 follows:
- 15 (1) On March 28, 1968, in the Quang Tri Province, South
- 16 Vietnam, Army Specialist Ray Ira Haas was performing his
- assigned duty as an infantryman on the battlefield.
- 18 (2) During these operations, Army Specialist Haas and
- 19 his infantry came under fire.
- 20 (3) Army Specialist Haas fought bravely and was mortally
- 21 wounded during the firefight, later being pronounced dead at
- 22 a hospital in Vietnam.
- 23 (b) Designation. -- That the portion of State Route 663 from
- 24 the Bucks County line, through Pennsburg Borough to the end of
- 25 Upper Hanover Township in Montgomery County, is hereby
- 26 designated the Army Specialist Ray Ira Haas Memorial Highway.
- 27 (c) Signs. -- The Department of Transportation shall erect and
- 28 maintain appropriate signs displaying the name of the highway to
- 29 traffic in both directions on the highway.
- 30 Section 2. First Lieutenant William Raymond Gendebien Memorial
- 31 Highway.
- 32 (a) Findings.--The General Assembly finds and declares as
- 33 follows:
- 34 (1) On October 26, 1965, in Quang Nam Province, South

- 1 Vietnam, VMFA 115 was performing combat operations against
- 2 hostile forces.
- 3 (2) First Lieutenant William R. Gendebien was performing
- 4 his assigned duty as Air Traffic Controller from an aircraft
- 5 with the assigned crew in support of VMFA 115 in their combat
- 6 operations.
- 7 (3) During these operations, hostile actions downed the
- 8 aircraft with its crew and it made a crash landing.
- 9 (4) First Lieutenant William R. Gendebien died in the
- 10 crash of the aircraft.
- 11 (b) Designation. -- That the portion of State Route 100 from
- 12 Hereford Township at the Lehigh County line through Washington
- 13 Township in Berks County is hereby designated the First
- 14 Lieutenant William R. Gendebien Memorial Highway.
- 15 (c) Signs. -- The Department of Transportation shall erect and
- 16 maintain appropriate signs displaying the name of the highway to
- 17 traffic in both directions on the highway.
- 18 Section 3. Private First Class Paul T. Wright Memorial Highway.
- 19 (a) Findings.--
- 20 (1) Private First Class Paul T. Wright was a resident of
- 21 Willow Grove, Pennsylvania, before enlisting in the United
- 22 States Army.
- 23 (2) PFC Wright was assigned to the 3rd Platoon, C
- 24 Company, 26th Engineer Battalion, Americal Division of the
- United States Army in Vietnam.
- 26 (3) While valiantly serving his country, PFC Wright, at
- 27 20 years of age, was killed by an explosive device on April
- 28 3, 1968, in the Quang Ngai Province of South Vietnam.
- 29 (b) Designation. -- The section of State Route 2026, also
- 30 known as Blair Mill Road, in Montgomery County from Easton Road

- 1 to Horsham Road is hereby designated the Private First Class
- 2 Paul T. Wright Memorial Highway.
- 3 (c) Signs. -- The Department of Transportation shall erect and
- 4 maintain appropriate signs displaying the name of the highway to
- 5 traffic in both directions on the highway.
- 6 Section 4. Staff Sgt. Jason M. Faley Memorial Bridge.
- 7 (a) Findings. -- The General Assembly finds and declares as
- 8 follows:
- 9 (1) Staff Sergeant Jason Matthew Faley was born on May
- 10 19, 1973 and graduated from Red Land High School in 1991.
- 11 (2) He was a Staff Sergeant in the United States Air
- 12 Force, Special Operations Tactical Air Control Party, serving
- with the 5th Special Forces stationed at Fort Campbell,
- 14 Kentucky, supporting the 101st Airborne Forces.
- 15 (3) Staff Sergeant Jason M. Faley was killed in Kuwait
- 16 on March 12, 2001.
- 17 (4) Prior to his death, he received numerous medals and
- 18 commendations including the Air Force Achievement Medal, The
- 19 Army Achievement Medal, the Armed Forces Expeditionary Medal,
- 20 the Airborne Parachutist Badge, the Military Free Fall Badge,
- 21 The Air Assault Badge and the Pathfinder Badge. He was also
- 22 Ranger certified and a graduate of Airman Leadership School.
- 23 (b) Designation. -- The bridge located on Sheep Bridge Road in
- 24 Newberry Township, York County, over I-83 is hereby designated
- 25 the Staff Sqt. Jason M. Faley Memorial Bridge.
- 26 (c) Signs. -- The Department of Transportation shall erect and
- 27 maintain appropriate signs displaying the name of the bridge to
- 28 traffic in both directions on the bridge.
- 29 Section 5. Private David Kyle McCracken Memorial Bridge.
- 30 The General Assembly finds and declares as follows:

- 1 (a) Findings.--
- 2 (1) David Kyle McCracken was born March 12, 1924, to J.
- Ward and Margaret Jane Kyler McCracken of Shawville,
- 4 Clearfield County.
- 5 (2) Mr. McCracken graduated from Clearfield High School
- 6 in 1942 and was employed by the Department of Highways until
- 7 March 1943, when he was inducted into the Army.
- 8 (3) Private McCracken received basic training at Camp
- 9 Walters, Texas, and was sent to North Africa in September
- 10 1943 as a member of the 15th Engineers Combat Battalion, 9th
- 11 Division.
- 12 (4) Private McCracken was later transferred to England,
- 13 Italy, France and Germany.
- 14 (5) On December 31, 1944, Private McCracken made the
- 15 ultimate sacrifice for his country when he was killed in
- 16 action in Belgium.
- 17 (6) Private McCracken is the recipient of a Purple
- 18 Heart.
- 19 (b) Designation. -- The bridge located on State Route 879 over
- 20 Trout Run in Goshen Township, Clearfield County, is hereby
- 21 designated the Private David Kyle McCracken Memorial Bridge.
- 22 (c) Signs. -- The Department of Transportation shall erect and
- 23 maintain appropriate signs displaying the name of the bridge to
- 24 traffic in both directions on the bridge.
- 25 Section 6. Cpl. Carl F. Hynek III Memorial Highway.
- 26 (a) Findings.--
- 27 (1) Cpl. Carl Hynek was born and raised in Upper
- Moreland Township, Montgomery County.
- 29 (2) Cpl. Carl Hynek was drafted into the United States
- 30 Army after his high school graduation and served in Vietnam

- 1 with the 101st Airborne Division.
- 2 (3) Cpl. Carl Hynek was killed on October 5, 1967, in
- Quang Nam, South Vietnam, at 22 years of age from wounds he
- 4 received in an intense firefight with enemy forces.
- 5 (b) Designation. -- The section of State Route 2034 in
- 6 Montgomery County from Terwood Road to Moreland Road is hereby
- 7 designated the Cpl. Carl F. Hynek III Memorial Highway.
- 8 (c) Signs.--The Department of Transportation shall erect and
- 9 maintain appropriate signs displaying the name of the highway to

- 10 traffic in both directions on the highway.
- 11 Section 7. Officer Dennis McNamara Memorial Highway.
- 12 (a) Findings. The General Assembly finds and declares as
- 13 follows:
- (1) Officer Dennis McNamara was born July 4, 1958, and
- 15 graduated from West Catholic High School.
- 16 (2) Officer McNamara served in the United States Air
- 17 Force from February 1981 to February 1987 where he developed
- 18 a background in military intelligence and was a linguist in-
- 19 several Middle Eastern languages.
- 20 (3) Officer McNamara joined the Upper Darby Police Force
- 21 <u>in July 1993 where he served for eight years before giving</u>
- 22 <u>his life in the line of duty.</u>
- 23 (4) On January 30, 2002, Officer McNamara was
- 24 investigating a suspicious vehicle and occupant in the
- 25 Cardington Section of Upper Darby before being fatally
- 26 wounded as he exited his vehicle.
- 27 (b) Designation. The section of State Route 2005, known as
- 28 Lansdowne Avenue, Delaware County, from State Road to School
- 29 Lane is hereby designated the Officer Dennis McNamara Memorial
- 30 Highway.

- 1 (c) Signs. -- The Department of Transportation shall erect and
- 2 maintain appropriate signs displaying the name of the road to
- 3 traffic in both directions on the road.
- 4 SECTION 7. CPL. JOSHUA B. SMITH MEMORIAL HIGHWAY.

- 11 SCHOOL'S SOCCER TEAM AS CAPTAIN FOR TWO YEARS.
- 12 (3) IN 2003, CPL. SMITH JOINED THE MARINE CORPS AND WAS
- 13 PROMOTED TO PRIVATE FIRST CLASS UPON GRADUATION FROM PARRIS
- 14 ISLAND, SOUTH CAROLINA.
- 15 (4) AFTER SERVING EIGHT YEARS IN THE MARINE CORPS, CPL.
- 16 SMITH WAS HONORABLY DISCHARGED IN 2011.
- 17 (5) CPL. SMITH WAS AWARDED THE NATIONAL DEFENSE SERVICE
- 18 MEDAL, NAVY MERITORIOUS UNIT COMMENDATION, GLOBAL WAR ON
- 19 TERRORISM SERVICE MEDAL, AFGHANISTAN CAMPAIGN MEDAL, SEA
- 20 SERVICE DEPLOYMENT RIBBON, MARINE CORPS GOOD CONDUCT MEDAL,
- 21 KOREAN DEFENSE SERVICE MEDAL, NATO ARTICLE 5 MEDAL AND THE
- 22 NAVY AND MARINE CORPS COMMENDATION.
- 23 (6) CPL. SMITH RETURNED HOME AND STRUGGLED WITH
- 24 POSTTRAUMATIC STRESS DISORDER AND TRAUMATIC BRAIN INJURY
- 25 UNTIL HE LOST HIS BATTLE ON NOVEMBER 5, 2012.
- 26 (B) DESIGNATION.--THE SECTION OF STATE ROUTE 145 IN
- 27 SALISBURY TOWNSHIP, LEHIGH COUNTY, FROM SEGMENT 40 OFFSET 137 TO
- 28 SEGMENT 40 OFFSET 3051 IS HEREBY DESIGNATED THE CPL. JOSHUA B.
- 29 SMITH MEMORIAL HIGHWAY.
- 30 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND

- 1 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE HIGHWAY TO

- 9 KANEOHE BAY, HAWAII; AND
- 10 (2) CPL. FAIRCLOTH WAS BORN IN YORK ON MAY 7, 1988, AND
- 11 GRADUATED FROM MECHANICSBURG AREA HIGH SCHOOL IN 2006; AND
- 12 (3) CPL. FAIRCLOTH JOINED THE MARINE CORPS IN 2006 AND
- 13 WAS DEPLOYED TO IRAO IN 2008 AND TO AFGHANISTAN IN 2010; AND
- 14 (4) CPL. FAIRCLOTH SERVED AS AN AERIAL OBSERVER AND
- 15 AIRCRAFT MECHANIC THROUGHOUT HIS FIVE-YEAR MILITARY CAREER;

- 17 (5) FOR HIS EXEMPLARY SERVICE, CPL. FAIRCLOTH WAS
