13 [The weight restrictions set forth in this subchapter do not 14 apply to a combination consisting of any tow truck towing a 15 disabled motor vehicle to a place of repairs or other place of 16 safety as long as the overweight combination travels directly to 17 the first available such location and the movement is performed 18 at the direction of authorized emergency personnel or a

19 qualified Commonwealth employee.]

20 <u>(a) Towing length restrictions.--A combination consisting of</u> 21 any tow truck towing a combination of a truck, a truck tractor

22 or not more than two trailers shall not exceed 150 feet when

23 traveling in combination.

24 (b) Towing weight restrictions.--The weight restrictions set
25 forth in this subchapter do not apply to a combination

26 consisting of any tow truck towing a disabled motor vehicle or a

8	75 miles of the point of disability.
9	(d) Failure to meet restrictionsAt any time, if a tow
10	truck operator cannot meet all the requirements of this section,

12	emergency personnel or a qualified employee of the Commonwealth.
13	An emergency plan to remove the disabled motor vehicle shall be
14	developed and approved by the department within 24 hours of the
