AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania 2 Consolidated Statutes, in assault, further providing for
- 3 ethnic intimidation.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 2710 of Title 18 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 2710. Ethnic <u>and identity</u> intimidation.
- 9 (a) Offense defined. -- A person commits the offense of ethnic
- 10 intimidation if, with malicious intention [toward the race,
- 11 color, religion or national origin of another individual or
- 12 group of individuals], he commits an offense under any other
- 13 provision of this article or under Chapter 33 (relating to
- 14 arson, criminal mischief and other property destruction)
- 15 exclusive of section 3307 (relating to institutional vandalism)
- 16 or under section 3503 (relating to criminal trespass) with
- 17 respect to such individual or his or her property or with

- 1 respect to one or more members of such group or to their
- 2 property.
- 3 (b) Grading.--An offense under this section shall be
- 4 classified as a misdemeanor of the third degree if the other
- 5 offense is classified as a summary offense. Otherwise, an
- 6 offense under this section shall be classified one degree higher
- 7 in the classification specified in section 106 (relating to
- 8 classes of offenses) than the classification of the other
- 9 offense.
- 10 (c) [Definition.--As used in this section "malicious
- 11 intention" means the] <u>Definitions.--As used in this section</u>, the
- 12 following words and phrases shall have the meanings given to
- 13 them in this subsection unless the context clearly indicates
- 14 otherwise:
- 15 "Emergency medical services provider." The term shall have
- 16 the same meaning as provided under 35 Pa.C.S. § 8103 (relating
- 17 to definitions).
- 18 "Firefighter." A professional or volunteer firefighter.
- 19 <u>"Law enforcement officer." The term shall have the same</u>
- 20 meaning as the term "peace officer" under section 501 (relating
- 21 to definitions).
- 22 "Malicious intention." The intention to commit any act, the
- 23 commission of which is a necessary element of any offense
- 24 referred to in subsection (a) motivated by hatred toward the
- 25 race, color, religion [or], national origin or employment as a
- 26 law enforcement officer, firefighter or emergency medical
- 27 <u>services provider</u> of another individual or group of individuals.
- 28 Section 2. This act shall take effect in 60 days.
