## AN ACT

1 2 3 4 5	Amending Titles 51 (Military Affairs) and 74 (Transportation) of the Pennsylvania Consolidated Statutes, in Department of Military Affairs, providing for Civil Air Patrol; and, in authority of Department of Transportation, further providing for authority of department.
6	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. Title 51 of the Pennsylvania Consolidated
9	Statutes is amended by adding a section to read:
10	<u>§ 712. Civil Air Patrol.</u>
11	(a) LiaisonThe department shall be a liaison for the
12	Civil Air Patrol and shall, notwithstanding any law, provide
13	administrative support in accordance with this section and
14	within the limits of authorized appropriations.
15	(b) SupervisionThe department shall:
16	(1) Receive and supervise the expenditure of State funds
17	appropriated by the General Assembly or secured by the

1	Commonwealth for the use and benefit of the Civil Air Patrol
2	within this Commonwealth.
3	(2) Supervise the maintenance and use of Commonwealth
4	facilities used by the Civil Air Patrol.
5	(3) Receive, from the Commonwealth or the Commonwealth's
6	instrumentalities, requests for approval for assistance by
7	the Civil Air Patrol in natural or man-made disasters or
8	emergency situations. A requested and approved mission must
9	be approved or denied in accordance with Federal procedures
10	and in consultation with the Adjutant General or the Adjutant
11	General's designee and the Pennsylvania Emergency Management
12	Agency.
13	(c) Construction Nothing in this section shall be
14	construed to limit, diminish or impair an authority, right or
15	agreement validly established and existing on the effective date
16	of this section.
17	(d) DefinitionsAs used in this section, the following
18	words and phrases shall have the meanings given to them in this
19	subsection unless the context clearly indicates otherwise:
20	"Assistance." The term shall include, but is not limited to,
21	the following missions:
22	(1) Search and rescue.
23	<u>(2) Disaster relief support.</u>
24	(3) Homeland security.
25	(4) Emergency transport services.
26	(5) Communications support.
