## AN ACT

Amending Title 75 (Vehicles) of the Pennsylvania Consolidated

4	which shall be in addition to the annual registration fee and by
_5	documentation as the department shall require, the department
6	shall issue to the person a special registration plate

- 2 registration plate may be used only on a passenger car or truck
- 3 with a registered gross weight of not more than 10,000 pounds.
- 4 Fifteen dollars of the fee paid by the applicant for the special
- 5 registration plate shall be transferred to the Veterans' Trust
- 6 Fund. The portion of the fee transferred to the Veterans' Trust
- 7 Fund under this subsection shall be used for programs and

- (C) HONORING OUR WOMEN VETERANS. -- UPON APPLICATION OF ANY
- 14 PERSON, ACCOMPANIED BY A FEE OF \$35, WHICH SHALL BE IN ADDITION
- 15 TO THE ANNUAL REGISTRATION FEE AND BY SUCH DOCUMENTATION AS THE
- 16 DEPARTMENT SHALL REQUIRE, THE DEPARTMENT SHALL ISSUE TO THE
- 17 PERSON A SPECIAL REGISTRATION PLATE DESIGNATING THE VEHICLE AS
- 18 BELONGING TO A PERSON WHO IS HONORING WOMEN VETERANS OF THE
- 19 ARMED FORCES OF THE UNITED STATES. THE SPECIAL REGISTRATION
- 20 PLATE MAY BE USED ONLY ON A PASSENGER CAR OR TRUCK WITH A
- 21 REGISTERED GROSS WEIGHT OF NOT MORE THAN 14,000 POUNDS. THE
- 22 VETERANS' TRUST FUND SHALL RECEIVE \$15 OF THE FEE PAID BY THE
- 23 APPLICANT FOR THE PLATE. THE PORTION OF THE FEE TRANSFERRED TO
- 24 THE VETERANS' TRUST FUND UNDER THIS SUBSECTION SHALL BE USED FOR
- 25 PROGRAMS AND RESOURCES THAT ASSIST WOMEN VETERANS.
- 26 Section 2. This act shall take effect in <del>60</del> 120 days.
