## AN ACT

Amending the act of November 22, 1978 (P.L.1166, No.274), entitled "An act establishing the Pennsylvania Commission on 1 2 Crime and Delinquency, providing for its powers and duties 3 establishing several advisory committees within the commission and providing for their powers and duties," 5 further providing for powers and duties of the commission; and establishing the Constable William Davidson Reward Fund. 6 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 10 Section 1. Section 3 of the act of November 22, 1978 11 (P.L.1166, No.274), referred to as the Pennsylvania Commission on Crime and Delinquency Law, is amended by adding a paragraph 13 to read: Section 3. Powers and duties of the commission. 14 15 The commission shall have the power and its duty shall be: \* \* \* 16 17 (19) To offer and cause to be paid rewards of up to 18 \$50,000 for information leading to the arrest and conviction of perpetrators of an offense under 18 Pa.C.S. § 2507 19 (relating to criminal homicide of law enforcement officer). 2.0

- 1 Section 2. The act is amended by adding a section to read:
- 2 Section 8.2. Constable William Davidson Reward Fund.
- 3 (a) Establishment of fund. -- The Constable William Davidson
- 4 Reward Fund is established as a special fund in the State
- 5 <u>Treasury.</u>
- 6 (b) Administration. -- The fund shall be administered by the
- 7 commission. The commission shall use money in the fund solely
- 8 for the purpose of section 3(19).
- 9 (c) Fund sources.--The sources of the fund are as follows:
- 10 (1) Moneys transferred under subsection (d).
- 11 (2) Contributions and donations to the fund.
- 12 (d) Transfers. -- Commencing with fiscal year 2017-2018 and
- 13 continuing annually thereafter, the sum of \$750,000 shall be
- 14 transferred from the State Gaming Fund to the Constable William
- 15 Davidson Reward Fund.
- 16 (e) Definition. -- As used in this section, the term "fund"
- 17 means the Constable William Davidson Reward Fund.
- 18 Section 3. This act shall take effect in 60 days.
