## AN ACT

Amending Title 68 (Real and Personal Property) of the 1 Pennsylvania Consolidated Statutes, in seller disclosures, 2 further providing for disclosure form. 3 The General Assembly of the Commonwealth of Pennsylvania 4 5 hereby enacts as follows: Section 1. Section 7304(b) of Title 68 of the Pennsylvania 6 Consolidated Statutes is amended and the section is amended by adding a subsection to read: § 7304. Disclosure form. 9 \* \* \* 10 11 (b) Contents of property disclosure statement. -- The form of 12 property disclosure statement promulgated by the State Real Estate Commission shall call for disclosures with respect to all 13 14 of the following subjects: 15 Seller's expertise in contracting, engineering, 16 architecture or other areas related to the construction and

conditions of the property and its improvements.

When the property was last occupied by the seller.

- 1 (4) Basements and crawl spaces.
- 2 (5) Termites/wood destroying insects, dry rot and pests.
- 3 (6) Structural problems.
- 4 (7) Additions, remodeling and structural changes to the
- 5 property.
- 6 (8) Water and sewage systems or service.
- 7 (9) Plumbing system.
- 8 (10) Heating and air conditioning.
- 9 (11) Electrical system.
- 10 (12) Other equipment and appliances included in the
- 11 sale.
- 12 (13) Soils, drainage, boundaries and sinkholes.
- 13 (14) Presence of hazardous substances.
- 14 (14.1) Previous use of premises as a marijuana grow
- house.
- 16 (15) Condominiums and other homeowners associations.
- 17 (16) Legal issues affecting title or that would
- interfere with use and enjoyment of the property.
- 19 (17) Condition, if known, and location of all storm
- 20 water facilities, including a statement disclosing whether
- 21 ongoing maintenance of the storm water facilities is the
- responsibility of the property owner or the responsibility of
- another person or entity.

- 25 <u>(d) Definition.--As used in this section, the following</u>
- 26 words and phrases shall have the meanings given to them in this
- 27 <u>subsection unless the context clearly indicates otherwise:</u>
- 28 "Marijuana grow house." A residential structure in which
- 29 <u>marijuana has been or was attempted to be cultivated and all</u>
- 30 proximate areas likely to be contaminated as a result of the

- 1 <u>cultivation</u>, including areas where pesticides or fertilizers
- 2 <u>were used.</u>
- 3 Section 2. This act shall take effect in 60 days.
