- 23 location where the dog or cat may be retrieved.
- 24 (c) Limitation. -- A person shall not be immune from civil
- 25 liability for damage resulting from the entry if the person's
- 26 actions constitute gross negligence, recklessness or willful or
- 27 wanton misconduct.
