6 CAMBRIA COUNTY, AS THE PFC NICK KOZOROSKY MEMORIAL BRIDGE.

7 The General Assembly of the Commonwealth of Pennsylvania
8 hereby enacts as follows:

9 Section 1. PFC Nick Kozorosky Memorial Bridge.

10 (a) Findings.--The General Assembly finds and declares as
11 follows:

12 (1) PFC Nick Kozorosky, a native of Nanty Glo Borough,
13 served his country in the United States Army, 101st Airborne
14 Division, 506th Parachute Infantry Regiment during World War
15 II.

16 (2) On May 4, 1945, PFC Kozorosky was killed in action
17 near Berchtesgaden, Germany, where Nazi leaders were planning
18 a last stand.

1 (3) PFC Nick Kozorosky was posthumously awarded the
2 Purple Heart.

3 ~~(b) Designation. The bridge located on State Route 271 over <--~~
4 ~~U.S. Route 22, Nanty Glo Borough, Cambria County, is hereby~~
5 ~~designated the PFC Nick Kozorosky Memorial Bridge.~~

6 (B) DESIGNATION.--THE BRIDGE LOCATED ON U.S. ROUTE 219 <--
7 SOUTH, OVER U.S. ROUTE 22, ALSO KNOWN AS THE ADMIRAL PEARY
8 HIGHWAY, IN CAMBRIA TOWNSHIP, CAMBRIA COUNTY, IS DESIGNATED AS
9 THE PFC NICK KOZOROSKY MEMORIAL BRIDGE.

10 (c) Signs.--The Department of Transportation shall erect and
11 maintain appropriate signs displaying the name of the bridge to
12 traffic in both directions on the bridge.

13 Section 2. Effective date.

14 This act shall take effect in 60 days.
