AN ACT

1 Amending the act of April 9, 1929 (P.L.343, No.176), entitled
2 "An act relating to the finances of the State government;
3 providing for the settlement, assessment, collection, and
4 lien of taxes, bonus, and all other accounts due the
5 Commonwealth, the collection and recovery of fees and other
6 money or property due or belonging to the Commonwealth, or
7 any agency thereof, including escheated property and the
8 proceeds of its sale, the custody and disbursement or other
9 disposition of funds and securities belonging to or in the
10 possession of the Commonwealth, and the settlement of claims
11 against the Commonwealth, the resettlement of accounts and
12 appeals to the courts, refunds of moneys erroneously paid to
13 the Commonwealth, auditing the accounts of the Commonwealth
14 and all agencies thereof, of all public officers collecting
15 moneys payable to the Commonwealth, or any agency thereof,
16 and all receipts of appropriations from the Commonwealth,
17 authorizing the Commonwealth to issue tax anticipation notes
18 to defray current expenses, implementing the provisions of
19 section 7(a) of Article VIII of the Constitution of
20 Pennsylvania authorizing and restricting the incurring of
21 certain debt and imposing penalties; affecting every
22 department, board, commission, and officer of the State
23 government, every political subdivision of the State, and
24 certain officers of such subdivisions, every person,
25 association, and corporation required to pay, assess, or
26 collect taxes, or to make returns or reports under the laws
27 imposing taxes for State purposes, or to pay license fees or
28 other moneys to the Commonwealth, or any agency thereof,
29 every State depository and every debtor or creditor of the
30 Commonwealth," in Department of the Auditor General,
31 providing for audits of affairs of the General Assembly and
32 legislative agencies; and making a related repeal.

1 The General Assembly of the Commonwealth of Pennsylvania
2 hereby enacts as follows:

3 Section 1. The act of April 9, 1929 (P.L.343, No.176), known
4 as The Fiscal Code, is amended by adding a section to read:

5 Section 402.1. Audits of Affairs of the General Assembly and
6 Legislative Agencies.--It shall be the duty of the Department of
7 the Auditor General to audit the financial affairs of the
8 General Assembly and its legislative service agencies. At least
9 one audit shall be made each year. Special audits may be made
10 whenever they may, in the judgment of the Auditor General,
11 appear necessary. Copies of all audits made by the Department of
12 the Auditor General shall be promptly submitted to the President
13 pro tempore of the Senate, the Minority Leader of the Senate,
14 the Speaker of the House of Representatives and the Minority
15 Leader of the House of Representatives.

16 Section 2. Repeals are as follows:

17 (1) The General Assembly declares that the repeal under
18 paragraph (2) is necessary to effectuate the addition of
19 section 402.1 of the act.

20 (2) Section 1 of the act of June 30, 1970 (P.L.442,
21 No.151) is repealed.

22 Section 3. This act shall take effect in 60 days.
