AN ACT

- 1 Providing for health insurance coverage requirements for stage 2 four, advanced metastatic cancer.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Fair Access
- 7 to Cancer Treatment Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Enrollee." Any policyholder, subscriber, covered person or
- 13 other individual who is entitled to receive health care services
- 14 under a health insurance plan.
- 15 "Health insurance carrier." An entity that offers or issues
- 16 a health insurance plan and is subject to any of the following:

- 1 (1) The act of May 17, 1921 (P.L.682, No.284), known as
- 2 The Insurance Company Law of 1921.
- 3 (2) The act of December 29, 1972 (P.L.1701, No.364),
- 4 known as the Health Maintenance Organization Act.
- 5 (3) 40 Pa.C.S. Ch. 61 (relating to hospital plan
- 6 corporations) or 63 (relating to professional health services
- 7 plan corporations).
- 8 "Health insurance plan." A policy, contract, certificate or
- 9 agreement offered or issued by a health insurance carrier to
- 10 provide for the costs of health care services. The term does not
- 11 include the following types of policies:
- 12 (1) Accident only.
- 13 (2) Limited benefit.
- 14 (3) Credit.
- 15 (4) Vision.
- 16 (5) Dental.
- 17 (6) Specified disease.
- 18 (7) Civilian Health and Medical Program of the Uniformed
- 19 Services (CHAMPUS) supplement.
- 20 (8) Long-term care or disability income.
- 21 (9) Workers' compensation.
- 22 (10) Automobile medical payment.
- 23 (11) FIXED INDEMNITY.
- "Stage four advanced, metastatic cancer." Cancer that has
- 25 spread from the primary or original site of the cancer to nearby

- 26 tissues, lymph nodes or other areas or parts of the body.
- 27 Section 3. Utilization management for stage four, advanced
- 28 metastatic cancer drugs.
- 29 A health insurance carrier or health insurance plan that,
- 30 directly or indirectly, covers the treatment of stage four,

- 1 advanced metastatic cancer shall not require an enrollee to
- 2 first fail to successfully respond to a different drug, or prove
- 3 a history of failure in use of a different drug, before
- 4 providing coverage for a drug to which the following apply:
- 5 (1) The drug is approved by the United States Food and
- 6 Drug Administration.
- 7 (2) The use of the drug is consistent with the best
- 8 practices for the treatment of stage four, advanced
- 9 metastatic cancer.
- 10 Section 4. Applicability.
- 11 This act shall apply to insurance plans issued, delivered or
- 12 renewed on or after the effective date of this section.
- 13 Section 5. Effective date.
- 14 This act shall take effect in 60 days.
