RESH MEMORIAL HIGHWAY; 19 DESIGNATING A BRIDGE ON THAT PORTION OF STATE ROUTE 18 20 (COLLEGE AVENUE) OVER THE LITTLE SHENANGO RIVER, GREENVILLE 21 BOROUGH, MERCER COUNTY, AS THE GREENVILLE VETERANS MEMORIAL 22 BRIDGE; DESIGNATING THAT PORTION OF STATE ROUTE 3078 AND 23 24 STATE ROUTE 3090 IN YORK COUNTY FROM THE INTERSECTION WITH 25 STATE ROUTE 116 TO THE INTERSECTION WITH STATE ROUTE 3042 AS THE PRIVATE FIRST CLASS DONALD R. GISE MEMORIAL ROAD; 26 27 DESIGNATING A BRIDGE ON THAT PORTION OF STATE ROUTE 1005, KNOWN AS CHURCH VIEW ROAD, SEGMENT 0180, OFFSET 0000, OVER 28

- 1 BEAVER CREEK, SOUTH WOODBURY TOWNSHIP, BEDFORD COUNTY, AS THE
- 2 PFC/POW WILLIAM G. KOONTZ MEMORIAL BRIDGE; AND DESIGNATING A
- 3 BRIDGE ON THAT PORTION OF STATE ROUTE 588 OVER INTERSTATE
- 4 376, CHIPPEWA TOWNSHIP, BEAVER COUNTY, AS THE TFC BLAKE T.
- 5 COBLE MEMORIAL BRIDGE.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Honorable Robert E. Belfanti, Jr., Memorial Highway.
- 9 (a) Findings. -- The General Assembly finds and declares as
- 10 follows:
- 11 (1) The Honorable Robert E. Belfanti, Jr., represented
- 12 the 107th Legislative District, covering portions of
- Columbia, Montour, Northumberland and Schuylkill Counties
- 14 from 1981 to 2010.
- 15 (2) During his 30 years in the House of Representatives,
- 16 Representative Belfanti served on numerous committees and was
- 17 chairperson of the Labor Relations Committee from 1993 to
- 18 2010.
- 19 (3) Representative Belfanti was active on numerous State
- 20 boards and commissions and championed workers, small
- businesses, veterans and improved accessibility for the
- disabled.
- 23 (4) Representative Belfanti attended Mount Carmel area
- 24 schools and was a lifelong scout, earning the rank of Eagle
- 25 Scout in 1962 and returning to scouting as an adult as a
- 26 charter member of Cub Scout Pack 3178.
- 27 (5) Representative Belfanti and his wife, Cecilia, were
- instrumental in bringing scouting back to the Mount Carmel
- area following a long dormancy, and Representative Belfanti
- 30 received numerous awards during his 25 years of service.
- 31 (6) Before becoming a State Representative,
- 32 Representative Belfanti enlisted in the United States Marine

- 1 Corps in 1967 and served a 13-month tour of duty in the
- 2 Vietnam War with helicopter units that supplied troops,
- 3 ammunition and medical supplies to Marines. His CH-46
- 4 helicopters, known as Sea Knights, were also the major means
- 5 for rescuing and providing medivacs for the wounded.
- 6 (7) Representative Belfanti rose to the rank of sergeant
- 7 before being honorably discharged in 1971. Among his
- 8 decorations were two Bronze Stars with Valor, the Combat
- 9 Action Ribbon, the Presidential Unit Citation, the Vietnam
- 10 Campaign Medal, the Vietnam Cross of Gallantry and the
- 11 Vietnam Service Medal.
- 12 (8) Representative Belfanti was active in numerous
- veteran organizations and cofounded the Black Diamond
- 14 Detachment of the Marine Corps League, as well as a life
- member of the Veterans of Foreign Wars (VFW), AMVETS and
- 16 Veterans of the Vietnam War. Representative Belfanti was
- 17 named Veteran of the Year by the National War Veterans
- 18 Council and also received the Patriot of the Year award.
- 19 (9) Representative Belfanti's legacy includes saving the
- former Shamokin State General Hospital from divestiture, the
- 21 opening of State Correctional Institution Coal Township,
- 22 resolving issues related to the Centralia mine fire, the
- 23 Shamokin Creek project, championing numerous abandoned mine
- reclamation projects and helping with many rail improvement
- and economic development projects in the district.
- 26 (10) Representative Belfanti was also instrumental in
- securing funding for the State Route 901 widening project
- from Locust Summit to Interstate 81, as well as the Strong
- 29 Connector improvement project.
- 30 (b) Designation.--The portion of State Routes 54 and 901 in

- 1 Northumberland County and Schuylkill County from the
- 2 intersection of State Route 54, State Route 901 and State Route
- 3 2023, also known as the Mount Carmel Merriam Highway, in Mount
- 4 Carmel Township, Northumberland County, to the intersection of
- 5 State Route 901, also known as Fairgrounds Road, and High Road
- 6 in Butler Township, Schuylkill County, is hereby designated as
- 7 the Honorable Robert E. Belfanti, Jr., Memorial Highway.
- 8 (c) Signs. -- The Department of Transportation shall erect and
- 9 maintain appropriate signs displaying the name of the highway to
- 10 traffic in both directions on the highway.

- 20 LOCATIONS ACROSS THE GLOBE, INCLUDING TURKEY, SAUDI ARABIA,
- 21 SOMALIA, HONDURAS, EL SALVADOR, KOSOVO, CUBA AND AFGHANISTAN.
- 22 (4) THE DISTINGUISHED MILITARY CAREER OF STAFF SERGEANT
- 23 MOWRIS ENDED ON JANUARY 29, 2004, WHEN HE WAS KILLED ALONG
- 24 WITH SEVEN OTHER SOLDIERS IN AN EXPLOSION DURING THE CLEARING
- 25 OF AN ENEMY WEAPONS AND AMMUNITION CACHE IN GHAZNI,

- 14 OF PITTSBURGH WITH A DEGREE IN ENGINEERING.
- 15 (3) CAPTAIN RESH SERVED AS AN APACHE HELICOPTER PILOT
- 16 WITH THE UNITED STATES ARMY, 4TH BATTALION, 227TH AVIATION
- 17 REGIMENT, 1ST AIR CAVALRY BRIGADE, 1ST CAVALRY DIVISION IN
- 18 SUPPORT OF OPERATION IRAOI FREEDOM.

- 4 GRADUATED FROM SPRING GROVE AREA HIGH SCHOOL IN 1960.
- 5 (3) PFC. GISE WAS DRAFTED INTO THE ARMY IN JANUARY 1968.
- 6 (4) PFC. GISE WAS AWARDED THE BRONZE STAR FOR HIS
- 7 SERVICE AND HIS BRAVERY.
- 8 (5) PFC. GISE WAS SURVIVED BY HIS WIFE, LINDA LOUIS
- 9 GISE, WHOM HE HAD MARRIED IN 1963, AND HIS SON, DONALD
- 10 RICHARD GISE, WHO WAS BORN 22 DAYS AFTER PFC. GISE WAS KILLED
- 11 IN ACTION.
- 12 (B) DESIGNATION.--THAT PORTION OF STATE ROUTE 3078 AND STATE
- 13 ROUTE 3090 IN YORK COUNTY FROM THE INTERSECTION WITH STATE ROUTE
- 14 116 TO THE INTERSECTION WITH STATE ROUTE 3042 IS HEREBY
- 15 DESIGNATED THE PRIVATE FIRST CLASS DONALD R. GISE MEMORIAL ROAD.
- 16 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND

- 20 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AND DECLARES AS
- 21 FOLLOWS:
- 22 (1) PFC WILLIAM G. KOONTZ OF NEW ENTERPRISE, WAS DRAFTED
- 23 INTO THE UNITED STATES ARMY DURING THE KOREAN WAR.
- 24 (2) PFC KOONTZ ARRIVED IN SOUTH KOREA ON MARCH 25, 1951,
- 25 AND ALONG WITH OTHER NEW ARRIVALS WAS GIVEN ONLY FIVE DAYS OF
- 26 BASIC COMBAT TRAINING BEFORE BEING SENT TO THE FRONT LINES.
- 27 (3) LESS THAN A MONTH LATER ON APRIL 22, 1951, THE
- 28 SOVIET-BACKED CHINESE RED ARMY LAUNCHED A MASSIVE ASSAULT
- 29 AGAINST THE UNITED NATIONS AND AMERICAN FORCES. PFC KOONTZ
- 30 WAS ON THE FRONT LINES THAT DAY WITH COMPANY E, 24TH

- 1 DIVISION, EIGHTH ARMY.
- 2 (4) COMPANY E'S LOCATION WAS SOON OVERTAKEN BY THE
- 3 CHINESE AND PFC KOONTZ ALONG WITH 13 OTHER MEN HID IN A CAVE
- 4 TO AVOID CAPTURE. AFTER FOUR DAYS WITHOUT FOOD OR WATER, THE
- 5 MEN WERE FORCED TO SURRENDER.

- 17 HE REUNITED WITH HIS FAMILY AND LIVED A FULL LIFE WITH HIS
- 18 WIFE, TO WHOM HE WAS MARRIED FOR OVER 50 YEARS, TWO SONS,
- 19 GRANDCHILDREN AND MANY OTHER RELATIVES.
- 20 (8) FOR HIS HEROISM AND SACRIFICE, PFC KOONTZ WAS
- 21 AWARDED THE GOOD CONDUCT MEDAL, THE ASIATIC PACIFIC THEATER
- 22 RIBBON, THE WORLD WAR II VICTORY RIBBON AND THE ARMY
- 23 OCCUPATION MEDAL (JAPAN).
- 24 (B) DESIGNATION.--THE BRIDGE LOCATED ON STATE ROUTE 1005,

- AND AVOWED COMMUNITY STEWARD, TROOPER FIRST CLASS COBLE
- 15 EXEMPLIFIED THE BEST QUALITIES OF THE HUMAN EXPERIENCE. HE
- GENEROUSLY GAVE OF HIS HEART AND TIME TO ENHANCE THE QUALITY
