- 17 § 3301. Short title of chapter.
- 18 This chapter shall be known and may be cited as the Health
- 19 Care Cost Containment Act.
- 20 § 3302. Definitions.
- 21 The following words and phrases when used in this chapter
- 22 shall have the meanings given to them in this section unless the
- 23 context clearly indicates otherwise:
- 24 "Ambulatory service facility." A facility licensed in this
- 25 Commonwealth which is not part of a hospital and which provides
- 26 medical, diagnostic or surgical treatment to patients not
- 27 <u>requiring hospitalization, including ambulatory surgical</u>
- 28 facilities, ambulatory imaging or diagnostic centers, birthing
- 29 <u>centers</u>, <u>freestanding emergency rooms and any other facilities</u>
- 30 providing ambulatory care which charge a separate facility

- 1 charge. The term does not include the offices of private
- 2 physicians or dentists, whether for individual or group
- 3 practices.
- 4 "Charge" or "rate." The amount billed by a provider for
- 5 specific goods or services provided to a patient, prior to any
- 6 adjustment for contractual allowances.
- 7 <u>"Council." The Health Care Cost Containment Council.</u>
- 8 <u>"Covered services."</u> Any health care services or procedures
- 9 connected with episodes of illness or injury that require either
- 10 <u>inpatient hospital care or major ambulatory service</u>, including
- 11 any initial and follow-up outpatient services associated with
- 12 the episode of illness or injury before, during or after
- 13 <u>inpatient hospital care or major ambulatory service. The term</u>
- 14 does not include routine outpatient services connected with
- 15 episodes of illness that do not require hospitalization or major
- 16 ambulatory service.
- 17 "Data." Data collected by the council under section 3305
- 18 <u>(relating to data submission and collection). The term includes</u>
- 19 raw data.
- 20 "Data source." The term includes a health care payor data
- 21 source and a provider.
- 22 "Health care facility." A general or special hospital,
- 23 <u>including:</u>
- 24 <u>(1) Psychiatric hospitals.</u>
- 25 (2) Kidney disease treatment centers, including
- 26 <u>freestanding hemodialysis units.</u>
- 27 (3) Ambulatory service facilities.
- 28 <u>(4) Hospices, including hospices operated by an agency</u>
- of State or local government.
- 30 "Health care insurer." A person, corporation or other entity

- 1 that offers administrative, indemnity or payment services for
- 2 <u>health care in exchange for a premium or service charge under a</u>
- 3 program of health care benefits, including, but not limited to:
- 4 (1) An insurance company, association or exchange
- 5 <u>issuing health insurance policies in this Commonwealth</u>
- 6 governed by the act of May 17, 1921 (P.L.682, No.284), known
- 7 <u>as The Insurance Company Law of 1921.</u>
- 8 (2) A hospital plan corporation as defined in 40 Pa.C.S.
- 9 <u>Ch. 61 (relating to hospital plan corporations).</u>
- 10 (3) A professional health service corporation as defined
- in 40 Pa.C.S. Ch. 63 (relating to professional health
- 12 <u>services plan corporations).</u>
- 13 (4) A health maintenance organization governed by the
- 14 <u>act of December 29, 1972 (P.L.1701, No.364), known as the</u>
- 15 <u>Health Maintenance Organization Act.</u>
- 16 (5) A third-party administrator governed by Article X of
- 17 the act of May 17, 1921 (P.L.789, No.285), known as The
- 18 <u>Insurance Department Act of 1921.</u>
- 19 The term does not include employers, labor unions or health and
- 20 welfare funds jointly or separately administered by employers or
- 21 labor unions that purchase or self-fund a program of health care
- 22 <u>benefits for their employees or members and their dependents.</u>
- 23 "Health maintenance organization." An organized system which
- 24 combines the delivery and financing of health care and which
- 25 provides basic health services to voluntarily enrolled
- 26 <u>subscribers for a fixed prepaid fee, as defined in the Health</u>
- 27 Maintenance Organization Act.
- 28 "Hospital." An institution licensed in this Commonwealth
- 29 which is:
- 30 (1) A general, mental, chronic disease or other type of

- 1 <u>hospital</u>.
- 2 (2) A kidney disease treatment center, including kidney
- 3 disease treatment centers operated by an agency of State or
- 4 local government.
- 5 <u>"Major ambulatory service."</u> Surgical or medical procedures,
- 6 <u>including diagnostic and therapeutic radiological procedures</u>,
- 7 <u>commonly performed in hospitals or ambulatory service</u>
- 8 <u>facilities</u>, which are not of a type commonly performed, or which
- 9 cannot be safely performed, in physicians' offices and which
- 10 require special facilities such as operating rooms or suites or
- 11 <u>special equipment such as fluoroscopic equipment or computed</u>
- 12 tomographic scanners, or a postprocedure recovery room or short-
- 13 term convalescent room.
- 14 <u>"Medical procedure incidence variations."</u> The variation in
- 15 the incidence in the population of specific medical, surgical
- 16 and radiological procedures in any given year, expressed as a
- 17 <u>deviation from the norm, as these terms are defined in the</u>
- 18 classical statistical definition of "variation," "incidence,"
- 19 "deviation" and "norm."
- 20 "Payment." The payments that providers actually accept for
- 21 their services, exclusive of charity care, rather than the
- 22 <u>charges they bill.</u>
- 23 "Payor." Any person or entity, including, but not limited
- 24 to, health care insurers and purchasers, that make direct
- 25 payments to providers for covered services.
- 26 "Physician." An individual licensed under the laws of this
- 27 Commonwealth to practice medicine and surgery within the scope
- 28 <u>of the act of October 5, 1978 (P.L.1109, No.261), known as the</u>
- 29 Osteopathic Medical Practice Act, or the act of December 20,
- 30 1985 (P.L.457, No.112), known as the Medical Practice Act of

- 1 1985.
- 2 "Preferred provider organization." Any arrangement between a
- 3 health care insurer and providers of health care services which
- 4 specifies rates of payment to such providers which differ from
- 5 their usual and customary charges to the general public and
- 6 which encourages enrollees to receive health services from such
- 7 providers.
- 8 "Provider." A hospital, a health care facility, an
- 9 <u>ambulatory service facility or a physician.</u>
- 10 <u>"Provider quality." The extent to which a provider renders</u>
- 11 care that, within the capabilities of modern medicine, obtains
- 12 for patients medically acceptable health outcomes and prognoses,
- 13 <u>adjusted for patient severity</u>, and treats patients
- 14 <u>compassionately and responsively.</u>
- 15 "Provider service effectiveness." The effectiveness of
- 16 <u>services rendered by a provider, determined by measurement of</u>
- 17 the medical outcome of patients grouped by severity receiving
- 18 those services.
- 19 "Purchaser." Corporations, labor organizations or other
- 20 entities that purchase benefits which provide covered services
- 21 for their employees or members, either through a health care
- 22 insurer or by means of a self-funded program of benefits, and a
- 23 certified bargaining representative that represents a group or
- 24 groups of employees for whom employers purchase a program of
- 25 benefits which provide covered services, but excluding any
- 26 entity defined in this section as a "health care insurer."
- 27 <u>"Severity." In any patient, the measureable degree of the</u>
- 28 potential for failure of one or more vital organs.
- 29 § 3303. Health Care Cost Containment Council.
- 30 (a) Establishment.--The Health Care Cost Containment Council

- 1 <u>is established as an independent council.</u>
- 2 (b) Composition. -- The council shall consist of voting
- 3 members, composed of and appointed in accordance with the
- 4 <u>following:</u>
- 5 <u>(1) The Secretary of Health.</u>
- 6 (2) The Secretary of Human Services.
- 7 <u>(3) The Insurance Commissioner.</u>
- 8 (4) Six representatives of the business community, at
- 9 <u>least one of whom represents small business, who are</u>
- 10 purchasers of health care, none of which is primarily
- involved in the provision of health care or health insurance,
- three of which shall be appointed by the President pro
- 13 tempore of the Senate and three of which shall be appointed
- 14 by the Speaker of the House of Representatives from a list of
- 15 <u>12 qualified persons recommended by the Pennsylvania Chamber</u>
- of Business and Industry. Three nominees shall be
- 17 representatives of small business.
- 18 (5) Six representatives of organized labor, three of
- 19 which shall be appointed by the President pro tempore of the
- Senate and three of which shall be appointed by the Speaker
- 21 of the House of Representatives from a list of twelve
- 22 <u>qualified persons recommended by the Pennsylvania AFL-CIO.</u>
- 23 (6) One representative of consumers who is not primarily
- 24 <u>involved in the provision of health care or health care</u>
- 25 insurance, appointed by the Governor from a list of three
- 26 <u>qualified persons recommended jointly by the Speaker of the</u>
- 27 House of Representatives and the President pro tempore of the
- 28 <u>Senate.</u>
- 29 (7) Two representatives of hospitals, appointed by the
- 30 Governor from a list of five qualified hospital

1	representatives recommended by the Hospital and Health System
2	Association of Pennsylvania one of whom shall be a
3	representative of rural hospitals. Each representative under
4	this paragraph may appoint two additional delegates to act
5	for the representative only at meetings of committees, as
6	provided for in subsection (f).
7	(8) Two representatives of physicians, appointed by the
8	Governor from a list of five qualified physician
9	representatives recommended jointly by the Pennsylvania
10	Medical Society and the Pennsylvania Osteopathic Medical
11	Society. The representative under this paragraph may appoint
12	two additional delegates to act for the representative only
13	at meetings of committees, as provided for in subsection (f).
14	(8.1) An individual appointed by the Governor who has
15	expertise in the application of continuous quality
16	improvement methods in hospitals.
17	(8.2) One representative of nurses, appointed by the
18	Governor from a list of three qualified representatives
19	recommended by the Pennsylvania State Nurses Association.
20	(9) One representative of the Blue Cross and Blue Shield
21	plans in Pennsylvania, appointed by the Governor from a list
22	of three qualified persons recommended jointly by the Blue
23	Cross and Blue Shield plans of Pennsylvania.
24	(10) One representative of commercial insurance
25	carriers, appointed by the Governor from a list of three_
26	qualified persons recommended by the Insurance Federation of
27	Pennsylvania, Inc.
28	(11) One representative of health maintenance
29	organizations, appointed by the Governor, from a list of

three qualified persons recommended by the Managed Care

1	Association of Pennsylvania.
2	(12) Representatives from the General Assembly as
3	<pre>follows:</pre>
4	(i) One Senator appointed by the President pro
5	tempore of the Senate.
6	(ii) One Senator appointed by the Minority Leader of
7	the Senate.
8	(iii) One member of the House of Representatives
9	appointed by the Speaker of the House of Representatives.
10	(iv) One member of the House of Representatives
11	appointed by the Minority Leader of the House of
12	Representatives.
13	(13) In the case of each appointment to be made from a
14	list supplied by a specified organization, it is incumbent
15	upon that organization to consult with and provide a list
16	which reflects the input of other equivalent organizations
17	representing similar interests. Each appointing authority
18	will have the discretion to request additions to the list
19	originally submitted. Additional names will be provided not
20	later than 15 days after such request. Appointments shall be
21	made by the appointing authority no later than 90 days after
22	receipt of the original list. If, for any reason, any
23	specified organization supplying a list should cease to
24	exist, then the respective appointing authority shall specify
25	an equivalent organization to fulfill the responsibilities
26	set forth in this chapter.
27	(c) Chairperson and vice chairperson The members shall
28	annually elect, by a majority vote of the members, a chairperson
29	and a vice chairperson of the council from among the members the
30	council.

- 1 (d) Quorum.--Eleven members, at least four of whom shall be
- 2 <u>council members under subsection (b) (5) (B) (4) through (12),</u>
- 3 shall constitute a quorum for the transaction of any business,
- 4 and the act by the majority of the members present at any
- 5 meeting in which there is a quorum shall be deemed to be the act
- 6 of the council. A quorum may be met by members who are attending
- 7 <u>by electronic means under subsection (e)(1).</u>
- 8 (e) Meetings. -- All meetings of the council shall be
- 9 <u>advertised and conducted under 65 Pa.C.S. Ch. 7 (relating to</u>
- 10 open meetings), unless otherwise provided in this section. The
- 11 <u>following apply:</u>
- 12 (1) The council shall meet at least once every two
- months and may provide for special meetings as it deems
- 14 <u>necessary. Meeting dates shall be set by a majority vote of</u>
- the members of the council or by the call of the chairperson
- 16 <u>upon seven days' notice to council members. Attendance at the</u>
- 17 meeting may be accomplished by electronic means so long as
- 18 <u>each council member attending via electronic means can</u>
- communicate in real time with the other members of the
- 20 <u>council and the public.</u>
- 21 (2) All meetings of the council shall be publicly
- 22 <u>advertised</u>, as provided for in this subsection, and shall be
- 23 open to the public, except that the council, through its
- 24 <u>bylaws, may provide for executive sessions of the council on</u>
- 25 <u>subjects permitted to be discussed in such sessions under 65</u>
- Pa.C.S. Ch. 7. No act of the council shall be taken in an
- 27 <u>executive session.</u>
- 28 (3) The council shall publish a schedule of its meetings
- 29 in the Pennsylvania Bulletin, on its publicly accessible
- Internet website and as provided under 65 Pa.C.S. Ch. 7. The

- 1 <u>notice shall be published at least once in each calendar</u>
- 2 <u>quarter and shall list the schedule of meetings of the</u>
- 3 <u>council to be held in the subsequent calendar quarter. The</u>
- 4 <u>notice shall specify the date, time and place of the meeting</u>
- 5 and shall state that the council's meetings are open to the
- 6 general public, except that no notice shall be required for
- 7 <u>executive sessions of the council.</u>
- 8 (4) All action taken by the council shall be taken in
- 9 open public session, and action of the council shall not be
- 10 <u>taken except upon the affirmative vote of a majority of the</u>
- 11 <u>members of the council present during meetings at which a</u>
- 12 <u>quorum is present.</u>
- (f) Bylaws. -- The council shall adopt bylaws, not
- 14 <u>inconsistent with this chapter</u>, and may appoint such committees
- 15 or elect such officers subordinate to those provided for in
- 16 <u>subsection (c) as it deems advisable.</u>
- 17 (g) Technical advisory group. --
- 18 <u>(1) The council shall appoint a technical advisory group</u>
- which shall, on an ad hoc basis, respond to issues presented
- 20 to it by the council or committees of the council and shall
- 21 make recommendations to the council. The technical advisory
- 22 group shall include:
- (i) Physicians.
- (ii) Researchers.
- 25 <u>(iii) Biostatisticians.</u>
- 26 (iv) One representative of the Hospital and
- 27 <u>Healthsystem Association of Pennsylvania.</u>
- (v) One representative of the Pennsylvania Medical
- 29 <u>Society.</u>
- 30 (2) The Hospital and Healthsystem Association of

1	Pennsylvania and the Pennsylvania Medical Society
2	representatives shall not be subject to executive committee
3	approval. In appointing other physicians, researchers and
4	biostatisticians to the technical advisory group, the council
5	shall consult with and take nominations from the
6	representatives of:
7	(i) the Hospital Association of Pennsylvania;
8	(ii) the Pennsylvania Medical Society;
9	(iii) the Pennsylvania Osteopathic Medical Society;
10	<u>or</u>
11	(iv) other like organizations.
12	(3) At its discretion and in accordance with this
13	section, nominations shall be approved by the executive
14	committee of the council. If the subject matter of any
15	project exceeds the expertise of the technical advisory
16	group, physicians in appropriate specialties who possess
17	current knowledge of the issue under study may be consulted.
18	The technical advisory group shall also review the
19	availability and reliability of severity of illness
20	measurements as they relate to small hospitals and
21	psychiatric, rehabilitation and children's hospitals and
22	shall make recommendations to the council based upon this
23	review. Meetings of the technical advisory group shall be
24	open to the general public.
25	(h) Payment data advisory group
26	(1) In order to assure the technical appropriateness and
27	accuracy of payment data, the council shall establish a
28	payment data advisory group to produce recommendations
29	surrounding the collection of payment data, the analysis and
30	manipulation of payment data and the public reporting of

_	payment data. The payment data advisory group sharr include
2	technical experts and individuals knowledgeable in payment
3	systems and claims data. The advisory group shall consist of
4	the following members appointed by the council:
5	(i) One member representing each plan under 40
6	Pa.C.S. Chs. 61 (relating to hospital plan corporations)
7	and 63 (relating to professional health services plan
8	corporations).
9	(ii) Two members representing commercial insurance
10	carriers.
11	(iii) Three members representing health care
12	<u>facilities.</u>
13	(iv) Three members representing physicians.
14	(2) The payment data advisory group shall meet at least
15	four times a year and may provide for special meetings as may
16	be necessary.
17	(3) The payment data advisory group shall review and
18	concur with the technical appropriateness of the use and
19	presentation of data and report its findings to the council
20	prior to any vote to publicly release reports. If the council
21	elects to release a report without addressing the technical
22	concerns of the advisory group, it shall prominently disclose
23	this in the public report and include the comments of the
24	advisory group in the public report.
25	(4) The payment data advisory group shall exercise all
26	powers necessary and appropriate to carry out its duties,
27	including advising the council on the following:
28	(i) Collection of payment data by the council.
29	(ii) Manipulation, adjustments and methods used with
30	payment data.

1	(iii) Public reporting of payment data by the
2	council.
3	(i) Compensation and expenses The members of the council
4	and any member of an advisory group appointed by the council
5	shall not receive a salary or per diem allowance for serving as
6	members or advisors of the council, but shall be reimbursed for
7	actual and necessary expenses incurred in the performance of
8	their duties. The expenses may include reimbursement of travel
9	and living expenses while engaged in council business.
10	(j) Terms of council members
11	(1) The terms of the Secretary of Health, the Secretary
12	of Human Services, the Insurance Commissioner and the
13	legislative representatives shall be concurrent with their
14	holding of public office. The council members under
15	subsection $\frac{\text{(b)}(5)}{\text{(B)}(4)}$ (B) (4) through (12) shall each serve for a <-
16	term of four years and shall continue to serve thereafter
17	until their successors are appointed.
18	(2) Vacancies on the council shall be filled in the
19	manner designated under subsection (b), within 60 days of the
20	vacancy, except that, when vacancies occur among the
21	representatives of business or organized labor, two
22	nominations shall be submitted by the organization specified
23	in subsection (b) for each vacancy on the council. If the
24	officer required in subsection (b) to make appointments to
25	the council fails to act within 60 days of the vacancy, the
26	council chairperson may appoint one of the persons
27	recommended for the vacancy until the appointing authority
28	makes the appointment.
29	(3) Except for the Secretary of Health, the Secretary of
30	Human Services, the Insurance Commissioner and the

- 1 <u>legislative representatives, a member may be removed for just</u>
- 2 cause by the appointing authority after recommendation by a
- 3 vote of at least 14 members of the council.
- 4 (4) No appointed member under subsection (b) (5) (B) (4) <--
- 5 through (12) shall be eligible to serve more than two full
- 6 <u>consecutive terms of four years beginning on the effective</u>
- 7 <u>date of this paragraph.</u>
- 8 (k) Subsequent appointments. -- Submission of lists of
- 9 recommended persons and appointments of council members for
- 10 <u>succeeding terms shall be made in the same manner as prescribed</u>
- 11 <u>in subsection (b), except that:</u>
- 12 (1) Organizations required under subsection (b) to
- submit lists of recommended persons shall do so at least 60
- 14 days prior to expiration of the council members' terms.
- 15 (2) The officer required under subsection (b) to make
- appointments to the council shall make the appointments at
- 17 least 30 days prior to expiration of the council members'
- terms. If the appointments are not made within the specified
- 19 time, the council chairperson may make interim appointments
- 20 from the lists of recommended individuals. An interim
- 21 appointment shall be valid only until the appropriate officer
- 22 under subsection (b) makes the required appointment. Whether
- 23 the appointment is by the required officer or by the
- 24 chairperson of the council, the appointment shall become
- 25 <u>effective immediately upon expiration of the incumbent</u>
- 26 member's term.
- 27 § 3304. Powers and duties of council.
- 28 (a) General powers. -- The council shall exercise all powers
- 29 necessary and appropriate to carry out its duties, including the
- 30 following:

1	(1) To employ an executive director, investigators and
2	other staff necessary to comply with the provisions of this
3	chapter and regulations promulgated thereunder, to employ or
4	retain legal counsel and to engage professional consultants,
5	as it deems necessary to the performance of its duties. Any
6	consultants, other than sole source consultants, engaged by
7	the council shall be selected in accordance with the
8	provisions for contracting with vendors set forth in section
9	3314 (relating to contracts with vendors).
10	(2) To fix the compensation of all employees and to
11	prescribe their duties. Notwithstanding the independence of
12	the council under section 3303(a) (relating to Health Care
13	Cost Containment Council), employees under this paragraph
14	shall be deemed employees of the Commonwealth for the
15	purposes of participation in the Pennsylvania Employee
16	Benefit Trust Fund.
17	(3) To make and execute contracts and other instruments,
18	including those for purchase of services and purchase or
19	leasing of equipment and supplies, necessary or convenient to
20	the exercise of the powers of the council. Any such contract
21	shall be in accordance with the provision for contracting
22	with vendors set forth in section 3314.
23	(4) To conduct examinations and investigations, to

- (4) To conduct examinations and investigations, to conduct audits, under the provisions of subsection (c), and to hear testimony and take proof, under oath or affirmation, at public or private hearings, on any matter necessary to its duties.
- 28 (5) To provide hospitals with individualized data on
 29 patient safety indicators under section 3305(c)(8) (relating
 30 to data submission and collection). The data shall be risk

- 1 adjusted and made available to hospitals electronically and
- 2 free of charge on a quarterly basis within 45 days of receipt
- 3 of the corrected quarterly data from the hospitals. The data
- 4 <u>is intended to provide the patient safety committee of each</u>
- 5 <u>hospital with information necessary to assist in conducting</u>
- 6 patient safety analysis.
- 7 (6) To do all things necessary to carry out its duties
- 8 under the provisions of this chapter.
- 9 (b) Rules and regulations.--
- 10 <u>(1) The council may promulgate rules and regulations as</u>
- 11 <u>necessary and appropriate to implement this act.</u>
- 12 (2) Regulations promulgated by the council shall be
- promulgated in accordance with the act of June 25, 1982
- 14 (P.L.633, No.181), known as the Regulatory Review Act.
- 15 (3) Rules and regulations in effect prior to the
- 16 <u>effective date of this section shall remain in effect.</u>
- 17 (c) Audit powers. -- The council shall have the right to
- 18 independently audit all information required to be submitted by

11	(d) General duties and functions The council is hereby
12	authorized to and shall perform the following duties and
13	functions:
14	(1) Develop a computerized system for the collection,
15	analysis and dissemination of data. The council may contract
16	with a vendor who will provide data processing services. The
17	council shall assure that the system will be capable of
18	processing all data required to be collected under this
19	chapter. Any vendor selected by the council shall be selected
20	in accordance with the provisions of section 3314, and the
21	vendor shall relinquish any and all proprietary rights or
22	claims to the database created as a result of implementation
23	of the data processing system.
24	(2) Establish a Pennsylvania Uniform Claims and Billing
25	Form for all data sources and all providers, which shall be

3	(4) Collect and disseminate data, as specified in
4	sections 3305 and 3306 (relating to data dissemination and
5	publication), and other information from data sources to
6	which the council is entitled, prepared according to formats,
7	time frames and confidentiality provisions as specified in
8	sections 3305 and 3308 (relating to Right-to-Know Law and
9	access to council data), and by the council. The council
10	shall begin collection of the data identified in paragraph
11	(3) within 12 months of the effective date of this section.
12	(5) Adopt and implement a methodology to collect and
13	disseminate data reflecting provider quality, provider
14	service effectiveness, utilization and the cost of health
15	care services under sections 3305 and 3306.
16	(6) Subject to the restrictions on access to raw data
17	set forth in section 3308, issue special reports and make
18	available raw data to a purchaser requesting it. Sale by a
19	recipient or exchange or publication by a recipient, other
20	than a purchaser, of council raw data to other parties
21	without the express written consent of, and under terms
22	approved by, the council shall be unauthorized use of data
23	under section 3308(d).
24	(7) On an annual basis, publish in the Pennsylvania
25	Bulletin a list of all the raw data reports it has prepared
26	under section 3308(g) and a description of the data obtained
27	through each computer-to-computer access it has provided
28	under section 3308(g) and of the names of the parties to whom
29	the council provided the reports or the computer-to-computer
30	access during the previous month.

3	(9) Assure that the use of council data does not raise
4	access barriers to care.
5	(10) Provide information on the allowed and paid costs
6	of medical services in terminology that may be reasonably

9	conjunction with information on quality of care delivery, if
10	quality information is reasonably available to the council,
11	so that the average individual consumer of health care
12	services may use the information to inform purchasing
13	decisions.
14	(11) Make annual reports to the General Assembly on the
15	rate of increase in the cost of health care in this
16	Commonwealth, including, but not limited to, the following:
17	(i) The rate of increase in health insurance
18	premiums in this Commonwealth.
19	(ii) Regional trends in cost of health care and
20	health insurance premiums.
21	(iii) The effectiveness of the council in carrying
22	out the legislative intent of this chapter.
23	(iv) The quality and effectiveness of health care
24	and access to health care for all citizens of this
25	Commonwealth.
26	(12) In the discretion of the council, make
27	recommendations on the need for further health care cost
28	containment legislation.
29	(13) Conduct studies and publish reports analyzing the
30	effects that outpatient, alternative health care delivery

- 1 systems have on health care costs. The systems shall include,
- 2 <u>but are not limited to, health maintenance organizations</u>
- 3 (HMOs); preferred provider organizations (PPOs); primary
- 4 <u>health care facilities; home health care; attendant care;</u>
- 5 <u>ambulatory service facilities; freestanding emergency</u>
- 6 centers; birthing centers; and hospice care. The reports
- 7 <u>shall be submitted to the General Assembly and shall be made</u>

- 13 § 3305. Data submission and collection.
- 14 <u>(a) Submission of data.--</u>
- 15 <u>(1) The council is authorized to collect and data</u>

- 18 <u>submission formats, coding systems, the health care payor</u>
- 19 claims data submission manual and other technical
- 20 specifications necessary to render the incoming data

- 20 (9) principal procedure by council-specified standard
- 21 code and date;
- 22 (10) up to three secondary procedures by council-
- 23 specified standard codes and dates;
- 24 (11) uniform health care facility identifier, continuous
- 25 across episodes, patients and providers;
- 26 (12) uniform identifier of admitting physician, by
- 27 unique physician identification number established by the
- 28 council, continuous across episodes, patients and providers;
- 29 (13) uniform identifier of consulting physicians, by
- 30 unique physician identification number established by the

1	council, continuous across episodes, patients and providers;
2	(14) total charges of health care facility, segregated
3	into major categories, including, but not limited to, room
4	and board, radiology, laboratory, operating room, drugs,
5	medical supplies and other goods and services according to
6	guidelines specified by the council;
7	(15) actual payments to health care facility,
8	segregated, if available, according to the categories
9	specified in paragraph (14);
10	(16) charges of each physician or professional rendering
11	service relating to an incident of hospitalization or
12	treatment in an ambulatory service facility;
13	(17) actual payments to each physician or professional
14	rendering service under paragraph (16);
15	(18) uniform identifier of primary payor;
16	(19) zip code number of facility where health care
17	service is rendered;
18	(20) uniform identifier for payor group contract number;
19	(21) patient discharge status; and
20	(22) provider service effectiveness and provider quality
21	under section 3304(d).
22	(d) Provider quality and provider service effectiveness data
23	elements In carrying out its duty to collect data on provider
24	quality and provider service effectiveness under subsection (c)
25	(22) and section 3304(d)(5), the council shall define a
26	methodology to measure provider service effectiveness, which may

- 26 <u>methodology to measure provider service effectiveness, which may</u>
- 27 <u>include additional data elements to be specified by the council</u>
- 28 <u>sufficient to carry out its responsibilities under section</u>
- 29 3304(d)(5). The council shall not require health care insurers
- 30 to report on data elements that are not reported to nationally

4	(f) Other data required to be submittedEach provider and
5	health care payor data source is hereby required to submit, and

9	is not available to the council from public records:
10	(1) Audited annual financial reports of all hospitals
11	and ambulatory service facilities providing covered services

14	successor forms, including the settled Medicare cost report.
15	(3) Additional data, including, but not limited to, data
16	which can be used in reports about:
17	(i) the incidence of medical and surgical procedures

19	(ii) physicians who provide covered services and
20	accept medical assistance patients;
21	(iii) physicians who provide covered services and
22	accept Medicare assignment as full payment;
23	(iv) mortality rates for specified diagnoses and
24	treatments, grouped by severity, for individual

26	(v) rates of infection for specified diagnoses and
27	treatments, grouped by severity, for individual

9	(4) Any other data the council requires to carry out its
10	responsibilities under section 3304(d).
11	(g) Review and correction of data The council shall
12	provide a reasonable period for data sources to review and
13	correct the data submitted under this section which the council
14	intends to prepare and issue in reports to the General Assembly,
15	to the general public or in special studies and reports under
16	section 3309 (relating to special studies and reports). When
17	corrections are provided, the council shall correct the
18	appropriate data in its data files and subsequent reports.
19	(h) Allowance for clarification or dissents The council
20	shall maintain a file of written statements submitted by data
21	sources who wish to provide an explanation of data that they
22	feel might be misleading or misinterpreted. The council shall
23	provide access to the file to any person and shall, where
24	practical, in its reports and data files indicate the
25	availability of such statements. When the council agrees with
26	such statements, it shall correct the appropriate data and
27	comments in its data files and subsequent reports.
28	(i) Allowance for correction The council shall verify the
29	patient safety indicator data submitted by hospitals under
30	subsection (c)(8) within 60 days of receipt. The council may

- 19 collection), as well as other data, records and matters of
- 20 record available to it, the council shall prepare and issue

- and within appropriate regions and subregions, prepare and

(i) Differences in mortality rates; differences in length of stay; differences in complication rates; differences in readmission rates; differences in infection rates; and other comparative outcome measures the council may develop that will allow purchasers, providers and consumers to make purchasing and quality improvement decisions based upon quality patient care and to restrain costs.

(ii) The incidence rate of selected medical or surgical procedures, the quality and service effectiveness and the payments received for those providers, identified by the name and type or specialty, for which these elements vary significantly from the norms for all providers.

(2) In preparing its reports under paragraph (1), the council shall ensure that factors which have the effect of either reducing provider revenue or increasing provider costs and other factors beyond a provider's control which reduce provider competitiveness in the marketplace are explained in the reports. The council shall also ensure that any clarifications and dissents submitted by individual providers under section 3305(h) are noted in any reports that include release of data on that individual provider.

(b) Raw data reports and computer access to council data.--

The council shall provide special reports derived from raw data
and a means for computer-to-computer access to its raw data to a
purchaser under section 3308(g). The council shall provide the

30 reports and computer-to-computer access, at its discretion, to

- 1 other parties under section 3308(i). The council shall provide
- 2 these special reports and computer-to-computer access in as
- 3 timely a fashion as the council's responsibilities to publish
- 4 the public reports required in this section will allow. Any
- 5 provision of special reports or computer-to-computer access by
- 6 the council shall be made only subject to the restrictions on
- 7 access to raw data set forth in section 3308(c) and only after

- 10 § 3307. Mandated health benefits.
- In relation to current law or proposed legislation, the
- 12 council shall, upon the request of the appropriate committee
- 13 chairman in the Senate and in the House of Representatives or
- 14 upon the request of the Secretary of Health or the Secretary of
- 15 Human Services, provide information on the proposed mandated
- 16 <u>health benefit pursuant to the following:</u>
- 17 (1) The General Assembly hereby declares that proposals
- 18 <u>for mandated health benefits or mandated health insurance</u>
- 19 coverage should be accompanied by adequate, independently
- 20 <u>certified documentation defining the social and financial</u>
- 21 impact and medical efficacy of the proposal. To that end, the
- council, upon receipt of such requests, is hereby authorized
- 23 <u>to conduct a preliminary review of the material submitted by</u>
- 24 both proponents and opponents concerning the proposed
- 25 mandated benefit. If, after this preliminary review, the
- council is satisfied that both proponents and opponents have
- 27 <u>submitted sufficient documentation necessary for a review</u>
- 28 <u>under paragraphs (3) and (4), the council is directed to</u>
- 29 <u>contract with individuals, pursuant to the selection</u>
- 30 procedures for vendors set forth in section 3314 (relating to

1	contracts with vendors), who will constitute a Mandated
2	Benefits Review Panel to review mandated benefits proposals
3	and provide independently certified documentation, as
4	provided for in this section.
5	(2) The panel shall consist of the following senior
6	researchers, each of whom shall be a recognized expert:
7	(i) one in health research;
8	(ii) one in biostatistics;
9	(iii) one in economic research;
10	(iv) one, a physician, in the appropriate specialty
11	with current knowledge of the subject being proposed as a
12	mandated benefit; and
13	(v) one with experience in insurance or actuarial
14	research.
15	(3) The Mandated Benefits Review Panel shall have the
16	following duties and responsibilities:
17	(i) To review documentation submitted by a person
18	proposing or opposing mandated benefits within 90 days of
19	submission of the documentation to the panel.
20	(ii) To report to the council, pursuant to the
21	council's review under subparagraph (i), the following:
22	(A) Whether or not the documentation is complete
23	as defined in paragraph (4).
24	(B) Whether or not the research cited in the
25	documentation meets professional standards.
26	(C) Whether or not all relevant research
27	respecting the proposed mandated benefit has been
28	cited in the documentation.
29	(D) Whether or not the conclusions and
30	interpretations in the documentation are consistent

1	with the data submitted.
2	(4) A person proposing or opposing legislation mandating
3	benefits coverage should, to provide the Mandated Benefits
4	Review Panel with sufficient information to carry out the
5	Mandated Benefits Review Panel's duties and responsibilities
6	under paragraph (3), submit documentation to the council,
7	pursuant to the procedure established under paragraph (5),
8	which demonstrates the following:
9	(i) The extent to which the proposed benefit and the
10	services the proposed benefit would provide are needed
11	by, available to and utilized by the population of this
12	Commonwealth.
13	(ii) The extent to which insurance coverage for the
14	proposed benefit already exists or, if no coverage
15	exists, the extent to which the lack of coverage results
16	in inadequate health care or financial hardship for the
17	population of this Commonwealth.
18	(iii) The demand for the proposed benefit from the
19	public and the source and extent of opposition to
20	mandating the benefit.
21	(iv) All relevant findings bearing on the social
22	impact of the lack of the proposed benefit.
23	(v) If the proposed benefit mandates coverage of a
24	particular therapy, the results of at least one
25	professionally accepted, controlled trial comparing the
26	medical consequences of the proposed therapy, alternative
27	therapies and no therapy.
28	(vi) If the proposed benefit mandates coverage of an
29	additional class of practitioners, the results of at
30	least one professionally accepted, controlled trial

1	comparing the medical results achieved by the additional
2	class of practitioners and those practitioners already
3	covered by benefits.
4	(vii) The results of any other relevant research.
5	(viii) Evidence of the financial impact of the
6	proposed legislation, including at least the following:
7	(A) The extent to which the proposed benefit
8	would increase or decrease cost for treatment or
9	service.
10	(B) The extent to which similar mandated
11	benefits in other states have affected charges, costs
12	and payments for services.
13	(C) The extent to which the proposed benefit
14	would increase the appropriate use of the treatment
15	or service.
16	(D) The impact of the proposed benefit on
17	administrative expenses of health care insurers.
18	(E) The impact of the proposed benefits on
19	benefits costs of purchasers.
20	(F) The impact of the proposed benefits on the
21	total cost of health care within this Commonwealth.
22	(5) The procedure for review of documentation shall be
23	as follows:
24	(i) A person wishing to submit information on
25	proposed legislation mandating insurance benefits for
26	review by the panel must submit the documentation
27	specified under paragraph (4) to the council.
28	(ii) The council shall, within 30 days of receipt of
29	<pre>the documentation:</pre>
30	(A) Publish in the Pennsylvania Bulletin notice

1 of receipt of the documentation, a description of the proposed legislation, provision for a period of 60 2 days for public comment and the time and place at 3 4 which a person may examine the documentation. (B) Submit copies of the documentation to the 5 Secretary of Health, the Secretary of Human Services 6 and the Insurance Commissioner, who shall review and 7 submit comments to the council on the proposed 8 legislation within 30 days. 9 10 (C) Submit copies of the documentation to the 11 panel, which shall review the documentation and issue 12 their findings, subject to paragraph (3), within 90 13 days. - 17 (1) Any raw data of the council which could reasonably
- 18 <u>be expected to reveal the identity of an individual patient.</u>
- 19 (2) Any raw data of the council which could reasonably
- 20 <u>be expected to reveal the identity of any purchaser, other</u>
- 21 than a purchaser requesting data on the purchaser's own group
- or an entity entitled to the purchaser's data under
- 23 subsection (q).
- 24 (3) Any raw data disclosing discounts or allowances
- 25 <u>between identified payors and providers which is prejudicial</u>
- to an individual payor or provider.
- 27 <u>(d) Unauthorized use of data.--A person who knowingly</u>
- 28 releases council data violating raw data safeguards under this
- 29 <u>section to an unauthorized person commits a misdemeanor of the</u>
- 30 first degree and shall, upon conviction, be sentenced to pay a

- 1 fine of \$10,000 or to imprisonment for not more than five years,
- 2 or both. An unauthorized person who knowingly receives or
- 3 possesses the data commits a misdemeanor of the first degree.
- 4 (e) Unauthorized access to data. -- If person inadvertently or
- 5 by council error gains access to data that violates the
- 6 <u>safequards under this section</u>, the data must immediately be
- 7 returned, without duplication, to the council with proper
- 8 notification.
- 9 (f) Public access to records. -- Each public report prepared
- 10 by the council shall be a public record and shall be available
- 11 to the public for a reasonable fee. Copies shall be provided,
- 12 upon request of the chair, to the Health and Human Services
- 13 Committee of the Senate and the Health Committee and Human
- 14 <u>Services Committee of the House of Representatives.</u>
- 15 (g) Access to council raw data by purchasers. -- Pursuant to
- 16 <u>sections 3304(d)(6) (relating to powers and duties of council)</u>
- 17 and 3306(b) (relating to data dissemination and publication) and
- 18 subject to the limitations on access under subsection (c), the
- 19 council shall provide access to the council's raw data to
- 20 purchasers, excluding purchasers that provide covered services
- 21 other than through the purchase of fully funded insurance from a
- 22 health care insurer but that are not elective health care payor
- 23 data sources, in accordance with the following procedure:
- 24 (1) Special reports derived from raw data of the council
- 25 <u>shall be provided by the council to the purchaser requesting</u>
- 26 such reports.
- 27 (2) A means to enable computer-to-computer access by the
- 28 purchaser to raw data of the council shall be developed,
- adopted and implemented by the council. The council shall
- 30 provide the access to the council's raw data to a purchaser

- 1 <u>upon request.</u>
- 2 (3) If an employer obtains from the council, under
- 3 paragraph (1) or (2), data pertaining to the employer's
- 4 <u>employees and the employees' dependents for whom the employer</u>
- 5 purchases or otherwise provides covered services and who are
- 6 represented by a certified collective bargaining
- 7 representative, the collective bargaining representative
- 8 <u>shall be entitled to the data, after payment of fees under</u>
- 9 paragraph (4). If a certified collective bargaining
- 10 representative obtains from the council, under paragraph (1)
- or (2), data pertaining to the employer's members and the
- 12 <u>member's dependents who are employed by and for whom covered</u>
- 13 <u>services are purchased or otherwise provided by an employer,</u>
- 14 <u>the employer shall be entitled to the data, after payment of</u>
- fees under paragraph (4).
- 16 (4) In providing for access to its raw data, the council
- 17 shall charge the purchasers which originally obtained the
- 18 <u>access a fee sufficient to cover the council's costs to</u>
- 19 prepare and provide special reports requested under paragraph
- 20 <u>(1) or to provide computer-to-computer access to its raw data</u>
- 21 requested under paragraph (2). If a second or subsequent
- 22 party requests the information under paragraph (3), the
- 23 council shall charge the party a reasonable fee.
- 24 (h) Access to council raw data by State agencies. -- The
- 25 council shall develop and execute memoranda of understanding
- 26 with any State agency upon request of that agency, including the
- 27 <u>Insurance Department</u>, the Department of Health and the
- 28 Department of Human Services, to allow the agency access to the
- 29 <u>data.</u>
- 30 (i) Access to council raw data by other parties. -- Subject to

- 1 the limitations on access to council raw data under subsection
- 2 (c), the council may provide special reports derived from the
- 3 <u>council's raw data or computer-to-computer access to parties</u>
- 4 other than purchasers provided access under subsection (g). The
- 5 council may publish regulations that set forth the criteria and
- 6 the procedure the council shall use in making determinations on
- 7 the access, pursuant to the powers vested in the council under
- 8 section 3304. In providing the access, the council shall charge
- 9 the party requesting the access a reasonable fee.
- 10 § 3309. Special studies and reports.
- 11 (a) Special studies. -- A Commonwealth agency, the Senate or
- 12 the House of Representatives may direct the council to publish
- 13 or contract for publication of special studies, including, but
- 14 not limited to, a special study on diseases and the cost of
- 15 <u>health care related to particular diseases in this Commonwealth.</u>
- 16 A special study published under this subsection shall become a
- 17 public document.
- 18 <u>(b) Special reports.--</u>
- 19 (1) A Commonwealth agency, the Senate or the House of
- 20 Representative may study and issue a report on the special
- 21 medical needs, demographic characteristics, access or lack
- 22 thereof to health care services and need for financing of
- 23 <u>health care services of:</u>
- 24 <u>(i) Senior citizens, particularly low-income senior</u>
- 25 <u>citizens, senior citizens who are members of minority</u>
- qroups and senior citizens residing in low-income urban
- 27 <u>or rural areas.</u>
- 28 (ii) Low-income urban or rural areas.
- 29 (iii) Minority communities.
- 30 (iv) Women.

2	(vi) Unemployed workers.
3	(vii) Veterans.

- information on the current availability of services to the targeted parts of the population under paragraph (1), whether access to the services has increased or decreased over the past 10 years and specific recommendations for the improvement of the primary care and health delivery systems of targeted parts of the population under paragraph (1), including disease prevention and comprehensive health care services. The agency may study and report on the effects of using prepaid, capitated or health maintenance organization health delivery systems as ways to promote the delivery of primary health care services to the underserved segments of the population enumerated above.
- 17 (3) The agency may study and report on the short-term 18 and long-term fiscal and programmatic impact on the health 19 care consumer of changes in ownership of hospitals from nonprofit to profit, whether through purchase, merger or the 20 21 like. The agency may study and report on factors which have 22 the effect of either reducing provider revenue or increasing 23 provider cost and other factors beyond a provider's control 24 which reduce provider competitiveness in the marketplace.
- 25 § 3310. Enforcement and penalty.
- 26 (a) Compliance enforcement. -- The council shall have standing
- 27 to bring an action in law or in equity through private counsel
- 28 in any court of common pleas to enforce compliance with any
- 29 provision of this chapter, except section 3309 (relating to
- 30 special studies and reports), or any requirement or appropriate

- 1 request of the council made under this chapter. The Attorney
- 2 General is authorized and shall bring an enforcement action in
- 3 aid of the council in a court of common pleas at the request of
- 4 the council and in the name of the Commonwealth.
- 5 <u>(b) Penalty.--</u>
- 6 (1) Any person who fails to supply data under section

- 15 § 3311. Research and demonstration projects.
- The council shall actively encourage research and
- 17 demonstrations to design and test improved methods of assessing

- 20 <u>mandated demonstration exceed the current reserve field on the</u>
- 21 Pennsylvania Uniform Claims and Billing Form or the data

- 6 § 3312. Grievances and grievance procedures.
- 7 (a) Procedures and requirements. -- Pursuant to its powers to
- 8 publish regulations under section 3304 (relating to powers and
- 9 <u>duties of council</u>) and with the requirements of this section,
- 10 the council may establish procedures and requirements for the
- 11 filing, hearing and adjudication of grievances against the
- 12 <u>council of a data source. The procedures and requirements shall</u>
- 13 <u>be published in the Pennsylvania Bulletin pursuant to law.</u>
- 14 (b) Claims and hearings. -- Grievance claims of a data source
- 15 shall be submitted to the council or to a third party designated
- 16 by the council. The council or the designated third party shall

- 19 A person or entity required or permitted to submit data or

- A contract with a vendor other than a sole source vendor for
- 27 <u>purchase of services or for purchase or lease of supplies and</u>
- 28 <u>equipment related to the council's powers and duties shall be</u>
- 29 <u>let only after a public bidding process and only in accordance</u>
- 30 with the following provisions:

1	(1) The council shall prepare specifications fully
2	describing the services to be rendered or equipment or
3	supplies to be provided by a vendor and shall make the
4	specifications available for inspection by a person at the
5	council's offices during normal working hours and at other
6	places and other times as the council deems advisable.
7	(2) The council shall publish notice of invitations to
8	bid in the Pennsylvania Bulletin and on the council's
9	publicly accessible Internet website. The notice shall
10	include at least the following:
11	(i) The deadline for submission of bids by
12	prospective vendors, which shall be no sooner than 30
13	days following the latest publication of the notice as
14	prescribed under this paragraph.
15	(ii) The locations, dates and times during which
16	prospective vendors may examine the specifications
17	required under paragraph (1).
18	(iii) The date, time and place of the meeting or
19	meetings of the council at which bids will be opened and
20	accepted.
21	(iv) A statement to the effect that any person is
22	eligible to bid.
23	(3) Bids shall be accepted as follows:
24	(i) A council member who is affiliated in any way
25	with a bidder may not vote on the awarding of a contract
26	for which the bidder has submitted a bid. A council
27	member who has an affiliation with a bidder shall state
28	the nature of the affiliation prior to a vote of the
29	council.
30	(ii) Bids shall be opened and reviewed by the

1	appropriate council committee, which shall make
2	recommendations to the council on approval. Bids shall be
3	accepted and the acceptance shall be announced only at a
4	public meeting of the council as defined in section
5	3303(e) (relating to Health Care Cost Containment
6	Council). A bid may not be accepted at an executive
7	session of the council.
8	(iii) The council may require that a certified
9	check, in an amount determined by the council, accompany
10	every bid. If required, a bid may not be accepted unless
11	accompanied by a certified check.
12	(4) In order to prevent a party from deliberately
13	underbidding contracts in order to gain or prevent access to
14	council data, the council may award a contract at the
15	council's discretion, regardless of the amount of the bid, as
16	<pre>follows:</pre>
17	(i) A bid accepted must reasonably reflect the
18	actual cost of services provided.
19	(ii) A vendor selected by the council under this
20	paragraph must be found by the council to be of the
21	character and integrity as to assure, to the maximum
22	extent possible, adherence to this chapter in the
23	provision of contracted services.
24	(iii) The council may require the selected vendor to
25	furnish, within 20 days after the contract has been
26	awarded, a bond with suitable and reasonable requirements
27	guaranteeing the services to be performed with sufficient
28	surety in an amount determined by the council. If the
29	bond is not furnished within the time specified, the
30	previous award shall be void.

- 1 (5) The council shall make efforts to assure that the
- 2 <u>council's vendors have established affirmative action plans</u>
- 3 to assure equal opportunity policies for hiring and promoting
- 4 <u>employees.</u>
- 5 <u>§ 3315. Reporting.</u>
- 6 The council shall provide an annual report of its financial
- 7 <u>expenditures to the Appropriations Committee and Public Health</u>
- 8 and Welfare HEALTH AND HUMAN SERVICES Committee of the Senate
- 9 and the Appropriations Committee, the Health Committee and the
- 10 <u>Human Services Committee of the House of Representatives.</u>
- 11 § 3316. Severability.
- 12 The provisions of this chapter are severable. If a provision
- 13 of this chapter or the provision's application to a person or
- 14 <u>circumstance is held invalid, the invalidity shall not affect</u>
- 15 other provisions or applications of this chapter which can be
- 16 given effect without the invalid provision or application.
- 17 Section 2. The following apply:
- 18 (1) Actions taken by the Health Care Cost Containment
- 19 Council from the period from June 30, 2014, to the effective
- 20 date of this section are validated.
- 21 (2) New positions on the Health Care Cost Containment
- 22 Council created under 35 Pa.C.S. Ch. 33 shall be filled in
- the manner designated under 35 Pa.C.S. § 3303(b) no later
- than 60 days after the effective date of this section.
- Organizations required under 35 Pa.C.S. § 3303(b) to submit
- 26 lists of recommended persons to fill new positions on the

- 29 (3) There shall be no lapse in the employment
- 30 relationship for employees of the Health Care Cost

- 1 Containment Council, including salary, seniority, benefits

- 3 Section 3. This act shall take effect immediately.
