## AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public
- welfare laws of the Commonwealth," in general powers and
- duties, providing for work requirements for the Supplemental
- 5 Nutrition Assistance Program.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. The act of June 13, 1967 (P.L.31, No.21), known
- 9 as the Human Services Code, is amended by adding a section to
- 10 read:
- 11 Section 216. Work Requirements for the Supplemental
- 12 <u>Nutrition Assistance Program. -- (a) The department may not apply</u>
- 13 for, accept or renew a waiver of requirements established under
- 14 <u>section 5 of the Food and Nutrition Act of 2008 (Public Law 88-</u>
- 15 525, 7 U.S.C. § 2015(o)) without prior approval of the General
- 16 Assembly.
- 17 (b) To the extent permitted by Federal law, as a condition
- 18 of participation and continuing eligibility for food assistance,

- 1 <u>an adult recipient shall comply with and submit proof of</u>
- 2 <u>compliance with at least one of the following:</u>
- 3 (1) The recipient has been employed for an average of at
- 4 <u>least twenty hours per week.</u>
- 5 (2) The recipient engaged in at least twenty-four hours of
- 6 <u>community service per month.</u>
- 7 (3) The recipient participates in a work program for at
- 8 <u>least twenty hours per week.</u>
- 9 (4) The recipient is enrolled as a full-time student in an
- 10 institution of higher education.
- 11 (c) Subsection (b) shall not apply to:
- 12 (1) An adult recipient who is a single parent with custody
- 13 of a child under the age of twelve.
- 14 (2) An adult recipient who is determined to not be an able-
- 15 bodied person capable of compliance with subsection (b), as
- 16 determined by the secretary.
- 17 Section 2. This act shall take effect in 60 days.
