- Amending Titles 18 (Crimes and Offenses) and 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in obstructing 2 governmental operations, further providing for the offense of 3 resisting arrest or other law enforcement; and, in 4 miscellaneous provisions, further providing for the offense of fleeing or attempting to elude police officer. 6 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Section 5104 of Title 18 of the Pennsylvania 9 Consolidated Statutes is amended to read: 10 § 5104. Resisting arrest or [other] fleeing law enforcement. 11 12 [A] (a) General rule. -- Except as provided in subsection (b), a person commits a misdemeanor of the second degree if, with the 13 intent of preventing a public servant from effecting a lawful 14 arrest or discharging any other duty, the person creates a 15 16 substantial risk of bodily injury to the public servant or 17 anyone else, <u>flees or attempts to elude the public servant</u> or employs means justifying or requiring substantial force to 18
 - (b) Serious bodily injury or death. -- A person commits a
