AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in sexual offenses, providing for the
- offense of sexual extortion.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 18 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 3132. Sexual extortion.
- 9 (a) Offense defined. -- A person commits the crime of sexual
- 10 extortion when the person intentionally or knowingly coerces or
- 11 <u>causes another person to engage in sexual conduct or simulated</u>
- 12 sexual conduct or to produce, disseminate or distribute an
- 13 image, video or other recording of another person in a state of
- 14 nudity or engaged in sexual conduct or simulated sexual conduct
- 15 <u>by:</u>
- 16 (1) harming or threatening to harm the person, property,
- 17 reputation or other thing of value of the other person;

Τ	(2) distributing, disseminating or threatening to
2	distribute or disseminate an image, video or other recording
3	of the other person in a state of nudity or engaged in sexual
4	<pre>conduct or simulated sexual conduct;</pre>
5	(3) exposing or threatening to expose any fact of
6	information that if revealed would tend to subject the other
7	person to criminal proceedings, hatred, contempt or ridicule;
8	<u>or</u>
9	(4) holding out, withholding or threatening to withhold
10	a service, employment, position or other thing of use or
11	<u>value.</u>
12	(b) Grading
13	(1) Except as otherwise provided, a violation of this
14	section shall constitute a misdemeanor of the first degree.
15	(2) A violation of this section shall constitute a
16	felony of the third degree when any of the following apply at
L 7	the time of the offense:
18	(i) the victim is less than 18 years of age;
19	(ii) the victim has an intellectual disability;
20	(iii) the person holds a position of trust or
21	supervisory or disciplinary power over the victim by
22	virtue of the person's legal, professional or
23	occupational status;
24	(iv) the violation is part of a course of conduct of
25	sexual extortion by the person; or
26	(v) the person was previously convicted of a
27	violation of this section or of a similar offense in
28	another jurisdiction.
29	(c) Sentencing The Pennsylvania Commission on Sentencing,
30	in accordance with 42 Pa.C.S. § 2154 (relating to adoption of

- 1 <u>quidelines for sentencing</u>), shall provide for a sentence
- 2 enhancement within its guidelines for an offense under this
- 3 section when at the time of the offense the victim is less than
- 4 18 years of age, has an intellectual disability or the person
- 5 <u>holds a position of trust or supervisory or disciplinary power</u>
- 6 over the victim by virtue of the person's legal, professional or
- 7 occupational status.
- 8 <u>(d) Juvenile diversion.--</u>
- 9 (1) Whenever a juvenile is charged with a violation of
- this section, the judicial authority having jurisdiction of
- the proceeding shall give first consideration to referring
- the juvenile to a diversionary program under Pa.R.J.C.P. No.
- 13 312 (relating to Informal Adjustment) or No. 370 (relating to
- 14 <u>Consent Decree</u>). As part of the diversionary program, the
- judicial authority may order the juvenile to participate in
- 16 <u>an educational program that covers the legal and nonlegal</u>
- 17 consequences of sexual extortion.
- 18 (2) If the person successfully completes the
- 19 <u>diversionary program, the juvenile's records of the charge of</u>
- violating this section shall be expunded under section 9123
- 21 (relating to juvenile records).
- 22 (e) Definitions. -- As used in this section, the following
- 23 words and phrases shall have the meanings given to them in this
- 24 subsection unless the context clearly indicates otherwise:
- 25 "Course of conduct." A pattern of actions composed of more
- 26 than one act over a period of time, however short, evidencing a
- 27 continuity of conduct. Acts indicating a course of conduct that
- 28 occur in more than one jurisdiction may be used by any other
- 29 jurisdiction in which an act occurred as evidence of a
- 30 continuing pattern of conduct or a course of conduct.

- 1 "Disseminate." To cause or make an electronic or actual
- 2 communication from one place or electronic communication device
- 3 to two or more other persons, places or electronic communication
- 4 <u>devices.</u>
- 5 <u>"Distribute." To sell, lend, rent, lease, give, advertise,</u>
- 6 publish or exhibit in a physical or electronic medium.
- 7 <u>"Intellectual disability."</u> Regardless of the age of the
- 8 <u>individual</u>, <u>significantly subaverage general intellectual</u>
- 9 <u>functioning that is accompanied by significant limitations in</u>
- 10 <u>adaptive functioning in at least two of the following skill</u>
- 11 <u>areas: communication; self-care; home living; social and</u>
- 12 <u>interpersonal skills; use of community resources' self-</u>
- 13 <u>direction; functional academic skills; work; health; and safety.</u>
- 14 "Nudity." As defined in section 5903 (relating to obscene
- 15 <u>and other sexual materials and performances).</u>
- 16 "Sexual conduct." Any of the following:
- 17 (1) intentional touching by the victim or person, either
- directly or through clothing, of the victim's or person's
- 19 intimate parts. Sexual contact of the actor with himself must
- 20 be in view of the victim whom the actor knows to be present;
- 21 (2) sexual intercourse, including genital-genital, oral-
- 22 genital, anal-genital or oral-anal, whether between persons
- of the same or opposite sex; or
- 24 (3) sexual bestiality.
- 25 "Simulated sexually explicit conduct." Conduct engaged in by
- 26 performers that is depicted in a manner that would cause a
- 27 <u>reasonable viewer to believe that the performers engaged in</u>
- 28 <u>actual sexually explicit conduct, even if they did not in fact</u>
- 29 do so.
- 30 Section 2. This act shall take effect in 60 days.
