A JOINT RESOLUTION

1 2 3	Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, further providing for exemptions and special provisions.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby resolves as follows:
6	Section 1. The following amendment to the Constitution of
7	Pennsylvania is proposed in accordance with Article XI:
8	That section 2 of Article VIII be amended by adding a
9	subsection to read:
10	§ 2. Exemptions and special provisions.

12	(d) The surviving spouse of any member of the armed forces
13	of the United States who was killed in action as determined by
14	the United States Department of Defense, or who died as a result
15	of injuries received while in active service, shall be exempt
16	from the payment of all real property taxes on the surviving
17	spouse's primary place of residence, without any restriction on

the spouse's relocating to another primary place of residence 1 and without any requirement that the spouse reside in this 2 Commonwealth at the time of death of the member of the armed 3 forces. The exemption shall cease if the surviving spouse 4 remarries and shall not be claimed thereafter. 5 6 Section 2. (a) Upon the first passage by the General 7 Assembly of this proposed constitutional amendment, the 8 Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article 9 10 XI of the Constitution of Pennsylvania and shall transmit the required advertisements to two newspapers in every county in 11 12 which such newspapers are published in sufficient time after 13 passage of this proposed constitutional amendment.

Upon the second passage by the General Assembly of this 14 (b) 15 proposed constitutional amendment, the Secretary of the 16 Commonwealth shall proceed immediately to comply with the 17 advertising requirements of section 1 of Article XI of the 18 Constitution of Pennsylvania and shall transmit the required 19 advertisements to two newspapers in every county in which such 20 newspapers are published in sufficient time after passage of 21 this proposed constitutional amendment. The Secretary of the 22 Commonwealth shall submit this proposed constitutional amendment 23 to the qualified electors of this Commonwealth at the first 24 primary, general or municipal election which meets the 25 requirements of and is in conformance with section 1 of Article 26 XI of the Constitution of Pennsylvania and which occurs at least three months after the proposed constitutional amendment is 27 28 passed by the General Assembly.
