## A RESOLUTION

- Designating the month of February 2017 as "Teen Dating and Violence Awareness and Prevention Month" in Pennsylvania.
- 3 WHEREAS, Teen dating violence is widespread, affecting
- 4 individuals, families and schools; and
- 5 WHEREAS, Teen dating violence includes physical, emotional
- 6 and sexual assault and harassment via texting, e-mail or instant
- 7 messaging; and
- 8 WHEREAS, Violent behavior on average begins between 12 and 18
- 9 years of age; and
- 10 WHEREAS, Nearly 1.5 million high school students nationwide
- 11 experience physical abuse from a dating partner each year; and
- 12 WHEREAS, Girls and young women between 16 and 24 years of age
- 13 experience the highest rate of violence, nearly triple the
- 14 national average; and
- 15 WHEREAS, Not only does this affect adolescents and high
- 16 school students, violence also affects approximately 43% of

- 1 college women who are dating; and
- 2 WHEREAS, Violent relationships can have serious ramifications
- 3 by placing the victims at higher risk for substance abuse,
- 4 eating disorders, risky sexual behavior, further domestic
- 5 violence and suicide; and
- 6 WHEREAS, Despite the fact that 82% of parents believe they
- 7 could recognize the signs of dating abuse, 58% could not
- 8 correctly identify all the warning signs; and
- 9 WHEREAS, The Love is Not Abuse iPhone app is an educational
- 10 resource for parents and provides information on teen dating
- 11 violence and abuse; and
- 12 WHEREAS, The Circle of 6 app is an iPhone app for college-
- 13 aged students and their friends to stay close, stay safe and
- 14 prevent violence before it happens; and
- 15 WHEREAS, The One Love Foundation's apps help the individual
- 16 determine if a relationship is unsafe and help to create the
- 17 best action plan; and
- 18 WHEREAS, Numerous organizations provide direct services to
- 19 those who experience dating violence, including the National
- 20 Dating Abuse 24-hour Helpline and Break the Cycle, national
- 21 nonprofit organizations providing preventive education and
- 22 outreach; and
- 23 WHEREAS, Everyone can help reduce this violence by raising
- 24 awareness and speaking up about abuse when they see it;
- 25 therefore be it
- 26 RESOLVED, That the House of Representatives designate the
- 27 month of February 2017 as "Teen Dating and Violence Awareness
- 28 and Prevention Month" in Pennsylvania to spread awareness
- 29 regarding teen dating abuse.
