INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, APRIL 19, 2017

A RESOLUTION

- 1 Designating April 23 through 30, 2017, as "Days of Remembrance
- of the Victims of the Holocaust" and recognizing April 24, 2017, as "Holocaust Remembrance Day" in Pennsylvania.
- 4 WHEREAS, The Holocaust, one of the darkest chapters in human
- 5 history, was the state-sponsored, systematic persecution and
- 6 annihilation of the European Jewry by Nazi Germany and its
- 7 collaborators between 1933 and 1945; and
- 8 WHEREAS, During the Holocaust, 6 million Jews were murdered,
- 9 many by bullets from the Einsatzgruppen (mobile killing units)
- 10 or in the gas chambers of the concentration camps; and
- 11 WHEREAS, The word "Holocaust" is Greek in origin and means
- 12 "sacrifice by fire"; and
- 13 WHEREAS, The Nazi's suspension of basic civil rights occurred
- 14 within days of Hitler's accession to power in January 1933; and

- 1 WHEREAS, Starting in April 1933, laws using a template called
- 2 the "Aryan Paragraph" were passed to deprive Jews of their
- 3 government jobs and their place in civil society; and
- 4 WHEREAS, In 1935, the Nuremberg Laws removed voting and
- 5 political rights and banned intermarriage, among numerous other
- 6 assaults on civil rights; and
- WHEREAS, From 1933 until the outbreak of war in 1939, the
- 8 first six years of Adolph Hitler's dictatorship in Germany, Jews
- 9 felt the effects of more than 400 decrees and regulations that
- 10 restricted all aspects of their public and private lives; and
- 11 WHEREAS, In 1933, the Jewish population in Europe was
- 12 estimated to be more than 9 million; and
- 13 WHEREAS, By 1945, the Nazis and their collaborators killed
- 14 nearly two out of every three European Jews as part of their
- 15 "Final Solution"; and
- 16 WHEREAS, Millions of persons, including Roma (Gypsies),
- 17 persons with disabilities, gay men and women, Jehovah's
- 18 Witnesses, Soviet prisoners of war, political dissidents and
- 19 nearly 2 million Poles, were also targeted for destruction or
- 20 decimation for racial, ethnic or national reasons; and
- 21 WHEREAS, This Commonwealth was founded on the principles of
- 22 religious freedom and tolerance; and
- 23 WHEREAS, The people of this Commonwealth should remember the
- 24 atrocities committed by the Nazis so that these horrors are
- 25 never repeated; and
- 26 WHEREAS, The people of this Commonwealth should continually
- 27 rededicate themselves to the principle of equal justice for all;
- 28 and
- 29 WHEREAS, The people of this Commonwealth should remain
- 30 vigilant against all tyranny and recognize that bigotry provides

- 1 a breeding ground for tyranny to flourish; and
- 2 WHEREAS, In the 1930s and the 1940s, Pennsylvanians rescued
- 3 children from Europe, led efforts to publicize the horrors of
- 4 the Holocaust during the war, liberated concentration camps and
- 5 prosecuted those who committed these evil acts in the Nuremberg
- 6 Trials; and
- 7 WHEREAS, Nearly 1,000 Pennsylvanians who are Holocaust
- 8 survivors have contributed their oral histories of the Holocaust
- 9 to the USC Shoah Foundation, created by Steven Spielberg, and
- 10 have told their stories in schools and in communities across the
- 11 Commonwealth; and
- 12 WHEREAS, Pennsylvanians have established Holocaust museums,
- 13 educational programs, monuments and commemorations throughout
- 14 this Commonwealth, engaging Jews, Christians, Muslims and all
- 15 people of good will; and
- 16 WHEREAS, With the help of the children and grandchildren of
- 17 Holocaust survivors and liberators, Pennsylvanians can continue
- 18 to rededicate themselves to the principle of equal justice for
- 19 all; and
- 20 WHEREAS, The General Assembly has passed laws providing for
- 21 curriculum guidelines that would complement the stories of
- 22 Pennsylvania's Holocaust survivors and the efforts of their
- 23 children and grandchildren to teach our students about the
- 24 Holocaust; and
- 25 WHEREAS, April 24, 2017, which corresponds to the 27th day of
- 26 Nisan on the Hebrew calendar, has been designated
- 27 internationally as a "Day of Remembrance of Victims of the Nazi
- 28 Holocaust" and is also known as Yom Hashoah; and
- 29 WHEREAS, This date further coincides with the anniversary of
- 30 the Warsaw Ghetto Uprising in German-occupied Poland which

- 1 occurred from April 19 through May 16, 1943; and
- 2 WHEREAS, It is appropriate for the people of this
- 3 Commonwealth to join in the international commemoration of this
- 4 solemn event; and
- 5 WHEREAS, By marking this occasion and honoring the memory of
- 6 the millions of victims of the Holocaust, the House of
- 7 Representatives hopes to overcome prejudice and inhumanity
- 8 through education, vigilance and resistance; therefore be it
- 9 RESOLVED, That the House of Representatives designate April
- 10 23 through 30, 2017, as "Days of Remembrance of the Victims of
- 11 the Holocaust" and recognize April 24, 2017, as "Holocaust
- 12 Remembrance Day" in Pennsylvania.
