INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, SEPTEMBER 12, 2017

A RESOLUTION

- Designating the month of September 2017 as "Military Suicide Prevention and Awareness Month" in Pennsylvania.
- 3 WHEREAS, Current studies confirm a high suicide rate among
- 4 recent veterans; and
- 5 WHEREAS, It is estimated that nationwide 22 veterans take
- 6 their own lives each day; and
- 7 WHEREAS, Veterans who have served on active duty in the
- 8 military since the start of the Global War on Terror and
- 9 operations in Afghanistan and Iraq have committed suicide at a
- 10 much higher rate than those who have never served in the
- 11 military; and
- 12 WHEREAS, A new analysis published in the February 2015 issue
- 13 of the Annals of Epidemiology tracked all 1,282,074 veterans who
- 14 served in active-duty units between 2001 and 2007 and left the

- 1 military during that same period; and
- 2 WHEREAS, The analysis matched military records with the
- 3 National Death Index, which collects data on every death, and
- 4 tracked the veterans after service until the end of 2009,
- 5 finding an alarming total of 1,868 suicides from that group; and
- 6 WHEREAS, The reason for the elevated suicide rate among these
- 7 veterans remains unclear but can most likely be attributed to
- 8 factors such as the long wars in Afghanistan and Iraq and added
- 9 tours of duty; and
- 10 WHEREAS, These wars have attracted more volunteers prone to
- 11 risk-taking who face a difficult transition to civilian life due
- 12 to a prolonged, weakened economy and the unavailability of
- 13 employment upon returning home; and
- 14 WHEREAS, On January 12, 2015, the Congress of the United
- 15 States passed the Clay Hunt Suicide Prevention for American
- 16 Veterans Act named after Marine Corps veteran Clay Hunt; and
- 17 WHEREAS, Corporal Hunt served honorably in both Afghanistan
- 18 and Iraq and was wounded in battle; and
- 19 WHEREAS, Upon his return home, Corporal Hunt grappled with
- 20 post-traumatic stress disorder and sadly, in March 2011 at 28
- 21 years of age, Corporal Hunt took his own life; and
- 22 WHEREAS, Officials at the United States Department of
- 23 Veterans Affairs have responded to the veteran suicide crisis by
- 24 boosting their mental health personnel and suicide hotline staff
- 25 in recent years, yet there is still more to do; therefore be it
- 26 RESOLVED, That the House of Representatives designate the
- 27 month of September 2017 as "Military Suicide Prevention and
- 28 Awareness Month" in Pennsylvania; and be it further
- 29 RESOLVED, That the House of Representatives fully support the
- 30 bipartisan actions of the 115th Congress and the United States

- 1 Department of Veterans Affairs as they continue to work together
- 2 to improve the needed support for our veterans.
