- Designating the month of April 2018 as "Prevention of Cruelty to Animals Month" in Pennsylvania.

- 4 changed in 1954 when the Humane Society of the United States
- 5 (Humane Society) was founded by animal rights activists; and
- 6 WHEREAS, The Humane Society campaigns for the humane
- 7 treatment of animals and fights to ensure public awareness of
- 8 the plight of mistreated animals; and
- 9 WHEREAS, The Humane Society has championed landmark
- 10 anticruelty laws and works to ensure their enforcement; and
- 11 WHEREAS, The Humane Society also tirelessly supports local
- 12 communities in their fight against animal cruelty and the rescue
- 13 of animals in crisis; and
- 14 WHEREAS, The Humane Society and its affiliates provide direct

- 1 care to more than 100,000 animals each year; and
- 2 WHEREAS, "Prevention of Cruelty to Animals Month" aims to
- 3 raise awareness of the Humane Society's mission as well as the
- 4 endless fight to prevent cruelty to animals; and
- 5 WHEREAS, As part of "Prevention of Cruelty to Animals Month,"
- 6 animal lovers are encouraged to donate to their local Humane
- 7 Society affiliates; and
- 8 WHEREAS, Humane Society supporters can offer their time and
- 9 volunteer to assist in the rescue efforts of affiliate
- 10 facilities; therefore be it
- 11 RESOLVED, That the House of Representatives designate the
- 12 month of April 2018 as "Prevention of Cruelty to Animals Month"
- 13 in Pennsylvania; and be it further
