## A JOINT RESOLUTION

1 2 3 4	Proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, prohibiting the Executive Department and school districts from making payroll collections of dues, fees and political contributions.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby resolves as follows:
7	Section 1. The following integrated amendments to the
8	Constitution of Pennsylvania are proposed in accordance with
9	Article XI:
10	(1) That Article IV be amended by adding a section to read:
11	§ 20. Payroll collection of dues, fees and political
12	contributions.
13	No agency in the Executive Department may use its payroll
14	system to collect membership dues, nonmembership fees or a <-
15	political contribution from an employee. DEDUCT FROM THE WAGES <-
16	OF A PUBLIC EMPLOYEE MONEY OR FUNDS TO BE USED FOR POLITICAL
17	CONTRIBUTIONS. A provision in a collective bargaining agreement
18	which authorizes collection in violation of this section is

- 2 (2) That section 9 of Article IX be amended to read:
- 3 § 9. [Appropriation for public] <u>Public</u> purposes.
- 4 <u>(a)</u> The General Assembly shall not authorize any
- 5 municipality or incorporated district to become a stockholder in
- 6 any company, association or corporation, or to obtain or
- 7 appropriate money for, or to loan its credit to, any
- 8 corporation, association, institution or individual. The General
- 9 Assembly may provide standards by which municipalities or school
- 10 districts may give financial assistance or lease property to
- 11 public service, industrial or commercial enterprises if it shall
- 12 find that such assistance or leasing is necessary to the health,
- 13 safety or welfare of the Commonwealth or any municipality or
- 14 school district. Existing authority of any municipality or
- 15 incorporated district to obtain or appropriate money for, or to
- 16 loan its credit to, any corporation, association, institution or
- 17 individual, is preserved.
- 18 (b) A school district may not use its payroll system to
- 19 <u>collect membership dues</u>, nonmembership fees or a political
- 20 contribution from an employee. DEDUCT FROM THE WAGES OF A PUBLIC <--
- 21 EMPLOYEE MONEY OR FUNDS TO BE USED FOR POLITICAL CONTRIBUTIONS.
- 22 A provision in a collective bargaining agreement which
- 23 authorizes collection in violation of this subsection is void.
- 24 Section 2. (a) Upon the first passage by the General
- 25 Assembly of these proposed constitutional amendments, the
- 26 Secretary of the Commonwealth shall proceed immediately to
- 27 comply with the advertising requirements of section 1 of Article
- 28 XI of the Constitution of Pennsylvania and shall transmit the
- 29 required advertisements to two newspapers in every county in
- 30 which such newspapers are published in sufficient time after

- 1 passage of these proposed constitutional amendments.
- 2 (b) Upon the second passage by the General Assembly of these
- 3 proposed constitutional amendments, the Secretary of the
- 4 Commonwealth shall proceed immediately to comply with the
- 5 advertising requirements of section 1 of Article XI of the
- 6 Constitution of Pennsylvania and shall transmit the required
- 7 advertisements to two newspapers in every county in which such
- 8 newspapers are published in sufficient time after passage of
- 9 these proposed constitutional amendments. The Secretary of the
- 10 Commonwealth shall submit the proposed constitutional amendments
- 11 under section 1 of this resolution to the qualified electors of
- 12 this Commonwealth as a single ballot question at the first
- 13 primary, general or municipal election which meets the
- 14 requirements of and is in conformance with section 1 of Article
- 15 XI of the Constitution of Pennsylvania and which occurs at least
- 16 three months after the proposed constitutional amendments are
- 17 passed by the General Assembly.
