AN ACT

Amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in limitation of time, 2 further providing for limitations on civil actions based on 3 certain assaults. 4 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Sections 5524 and 5531 of Title 42 of the 8 Pennsylvania Consolidated Statutes are amended to read: 9 § 5524. Two year limitation. 10 The following actions and proceedings must be commenced 11 within two years: 12 [An] Except as provided in section 5531(4) (relating to no limitation), an action for assault, battery, false 13 14 imprisonment, false arrest, malicious prosecution or 15 malicious abuse of process. 16 [An] Except as provided in section 5531(4), an 17 action to recover damages for injuries to the person or for 18 the death of an individual caused by the wrongful act or

neglect or unlawful violence or negligence of another.

- 1 (3) An action for taking, detaining or injuring personal property, including actions for specific recovery thereof.
 - (4) An action for waste or trespass of real property.
- 4 (5) An action upon a statute for a civil penalty or forfeiture.
 - (6) An action against any officer of any government unit for the nonpayment of money or the nondelivery of property collected upon on execution or otherwise in his possession.
 - other action or proceeding to recover damages for injury to person or property which is founded on negligent, intentional, or otherwise tortious conduct or any other action or proceeding sounding in trespass, including deceit or fraud, except an action or proceeding subject to another limitation specified in this subchapter.
- 16 An action to recover damages for injury to a person 17 or for the death of a person caused by exposure to asbestos 18 shall be commenced within two years from the date on which 19 the person is informed by a licensed physician that the 20 person has been injured by such exposure or upon the date on which the person knew or in the exercise of reasonable 21 22 diligence should have known that the person had an injury 23 which was caused by such exposure, whichever date occurs 24 first.
- 25 § 5531. No limitation.
- The following actions and proceedings may be commenced at any
- 27 time notwithstanding any other provision of this subchapter
- 28 except section 5521 (relating to limitations on foreign claims):
- 29 (1) An action against an attorney at law by or on behalf 30 of a client to enforce any implied or resulting trust as to

 - (3) An action by the Commonwealth, a county or an institution district against the real or personal property of persons who were legally liable to pay for the maintenance and support of persons who were public charges, including mental patients, to recover the cost of their maintenance and support.

- 30 Section 2. This act shall take effect in 60 days.
