10	Section 1. Paragraphs (2) and (3) of the definition of
11	"redevelopment assistance capital project" in section 302 of the
12	act of February 9, 1999 (P.L.1, No.1), known as the Capital
13	Facilities Debt Enabling Act, are amended to read:
14	Section 302. Definitions.
15	The following words and phrases when used in this chapter
16	shall have the meanings given to them in this section unless the
17	context clearly indicates otherwise:

19	"Redevelopment assistance capital project." The design and
20	construction of a project which meets all of the following:

2	(2) Is a project which will generate substantial
3	increases in or maintain current levels of employment, tax
4	revenues or other measures of economic activity. This
5	paragraph includes:
6	(i) a community asset project; and
7	(ii) a housing project that will support and
8	generate economic activity or provide housing to the
9	veteran population of this Commonwealth.
10	(3) Is a project that has a regional or
11	multijurisdictional impact or, in the case of housing, is
12	part of a community revitalization plan <u>or a plan to provide</u>
13	housing to the veteran population of this Commonwealth.

15	Section 2. Section 317(c) of the act is amended to read:
16	Section 317. Appropriation for and limitation on redevelopment
17	assistance capital projects.

19	(c) Housing unitsAn amount not to exceed \$50,000,000 of
20	the amount under subsection (b) may be used for the construction
21	of housing units[.] <u>if a minimum of \$25,000,000 is used for the</u>
22	construction of units to house veterans who are residents of
23	this Commonwealth and homeless or in need of housing.
24	Section 3. This act shall take effect in 60 days.
