AN ACT

Amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and 1 Judicial Procedure) of the Pennsylvania Consolidated 2 Statutes, in authorized disposition of offenders, further 3 providing for restitution for injuries to person or property; 5 and, in sentencing, further providing for victim impact statements. 6 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 Section 1. Section 1106(a), (b), (c)(1), (g) and (h) of 10 Title 18 of the Pennsylvania Consolidated Statutes are amended 11 to read: 12 § 1106. Restitution for injuries to person or property. (a) General rule. -- Upon conviction for any crime wherein: 13 14 (1) property of a victim has been stolen, converted or otherwise unlawfully obtained, or its value substantially 15 16 decreased as a direct result of the crime[, or wherein]; or 17 (2) the victim, if an individual, suffered personal 18 injury directly resulting from the crime,

the offender shall be sentenced to make restitution in addition

- 1 to the punishment prescribed therefor.
- 2 (b) Condition of probation or parole. -- Whenever restitution
- 3 has been ordered pursuant to subsection (a) and the offender has
- 4 been placed on probation or parole, [his] the offender's
- 5 compliance with such order may be made a condition of such
- 6 probation or parole.

- (c) Mandatory restitution.--
 - (1) The court shall order full restitution:
- 9 Regardless of the current financial resources of 10 the defendant, so as to provide the victim with the fullest compensation for the loss. The court shall not 11 12 reduce a restitution award by any amount that the victim 13 has received from the Crime Victim's Compensation Board 14 or other [governmental] government agency but shall order 15 the defendant to pay any restitution ordered for loss 16 previously compensated by the board to the Crime Victim's 17 Compensation Fund or other designated account when the 18 claim involves a government agency in addition to or in 19 place of the board. The court shall not reduce a 20 restitution award by any amount that the victim has 21 received from an insurance company but shall order the 22 defendant to pay any restitution ordered for loss 23 previously compensated by an insurance company to the 24 insurance company.
 - (ii) If restitution to more than one [person] victim is set at the same time, the court shall set priorities of payment. However, when establishing priorities, the court shall order payment in the following order:
 - (A) [The victim] Any individual.
 - (A.1) Any affected government agency.

15	(g) Preservation of private remedies No judgment or order
16	of restitution shall debar the [owner of the property or the
17	victim who sustained personal injury] victim, by appropriate
18	action, to recover from the offender as otherwise provided by
19	law, provided that any civil award shall be reduced by the
20	amount paid under the criminal judgment.
21	(h) DefinitionsAs used in this section, the following
22	words and phrases shall have the meanings given to them in this

24	"Affected government agency." The Commonwealth, a political
25	subdivision or local authority that has sustained injury to

- "Offender." Any person who has been found quilty of any
- 13 crime.
- 14 "Personal injury." Actual bodily harm, including pregnancy,
- 15 directly resulting from the crime.
- 16 "Property." Any real or personal property, including
- 17 currency and negotiable instruments, of the victim.
- 18 "Restitution." The return of the property of the victim or
- 19 payments in cash or the equivalent thereof pursuant to an order
- 20 of the court.
- 21 "Victim." As defined in section [479.1 of the act of April
- 22 9, 1929 (P.L.177, No.175), known as The Administrative Code of
- 23 1929] 103 of the act of November 24, 1998 (P.L.882, No.111),
- 24 known as the Crime Victims Act. The term includes an affected
- 25 government agency, the Crime Victim's Compensation Fund, if
- 26 compensation has been paid by the Crime Victim's Compensation
- 27 Fund to the victim [and], any insurance company that has
- 28 compensated the victim for loss under an insurance contract and
- 29 any nonprofit corporation, nonprofit unincorporated association, <--
