## AN ACT

Amending Titles 18 (Crimes and Offenses) and 62 (Procurement) of <-the Pennsylvania Consolidated Statutes, in trade and commerce, further providing for fraudulent traffic in food 3 orders; and, in source selection and contract formation, further providing for debarment or suspension. A person commits the offense of 21 fraudulent traffic in food orders if he, whether acting for himself or for another, directly or indirectly, furnishes or
