AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in preliminary provisions, further
- 6 providing for Keystone Exams.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 121 of the act of March 10, 1949 (P.L.30,
- 10 No.14), known as the Public School Code of 1949, amended June
- 11 21, 2017 (P.L.200, No.6), is amended to read:
- 12 Section 121. Keystone Exams and Graduation Requirements. --
- 13 (a) The Department of Education shall develop and implement
- 14 Keystone Exams in algebra I, literature and biology. The State
- 15 Board of Education shall promulgate or revise regulations,
- 16 subject to the act of June 25, 1982 (P.L.633, No.181), known as
- 17 the "Regulatory Review Act," necessary to implement this
- 18 section.
- 19 [(b) The following shall apply:

- 1 (1) Notwithstanding section 2604-B(b)(2)(v), 22 Pa. Code §
- 2 4.24 (relating to high school graduation requirements), 4.51
- 3 (relating to State assessment system) or 4.51c (relating to
- 4 project-based assessment) or any statute or regulation to the
- 5 contrary, the use of the Keystone Exams as a graduation
- 6 requirement or as a benchmark for the need for participation in
- 7 a project-based assessment shall be delayed until the 2019-2020
- 8 school year. ((1) amended Nov. 6, 2017, P.L.1142, No.55)
- 9 (2) The Department of Education shall investigate and
- 10 develop alternatives in addition to the use of the Keystone
- 11 Exams as a requirement for graduation and shall, within six (6)
- 12 months of the effective date of this paragraph, issue a report
- 13 of the Department of Education's findings and recommendations,
- 14 including proposed legislation, to the chairman and minority
- 15 chairman of the Education Committee of the Senate and the
- 16 chairman and minority chairman of the Education Committee of the
- 17 House of Representatives. The report shall, at a minimum,
- 18 contain a detailed plan and timeline within which the Department
- 19 of Education shall accomplish all of the following:
- (i) Implement alternative methods for students to
- 21 demonstrate proficiency for graduation in addition to the
- 22 Keystone Exams, the project-based assessments and other
- 23 alternative assessments provided for in 22 Pa. Code § 4.24.
- 24 (ii) Improve and expedite the evaluation of project-based
- 25 assessments.
- (iii) Ensure that no student is prohibited from
- 27 participation in vocational-technical education or elective
- 28 courses or programs as a result of supplemental instruction
- required in 22 Pa. Code §§ 4.24(k) and 4.51b(f) (relating to
- 30 Keystone Exams).]

- 1 (b.1) Each local school district shall have requirements for
- 2 high school graduation which include locally established course
- 3 <u>completion and grade-based requirements for academic content</u>
- 4 <u>areas and a demonstration of proficiency in State academic</u>
- 5 standards, which shall be in addition to the graduation
- 6 requirement alternatives contained in this section. All students
- 7 shall be provided the alternatives to demonstrate readiness for
- 8 graduation which are contained in this section.
- 9 (c) Notwithstanding section 2604-B(b)(2)(v), 22 Pa. Code §
- 10 4.24 (relating to high school graduation requirements) or 4.51
- 11 (relating to State assessment system) or any statute or
- 12 regulation to the contrary, in any school year in which a
- 13 demonstration of proficiency on a Keystone Exam is required for
- 14 high school graduation, a CTE Concentrator shall be deemed
- 15 proficient provided that the CTE Concentrator shall meet all of
- 16 the following requirements:
- 17 (1) completes locally established grade-based requirements
- 18 for academic content areas associated with each Keystone Exam on
- 19 which the CTE Concentrator did not achieve proficiency. For the
- 20 purposes of this paragraph, completion of grade-based
- 21 requirements in any science and technology and environment and
- 22 ecology course shall satisfy the requirements for the academic
- 23 content area associated with the Keystone Exam in biology; and
- 24 (2) completes one of the following:
- 25 (i) attains an industry-based competency certification
- 26 related to the CTE Concentrator's program of study; [or]
- 27 (ii) demonstrates a high likelihood of success on an
- 28 approved industry-based competency assessment or readiness for
- 29 continued meaningful engagement in the CTE Concentrator's
- 30 program of study as demonstrated by performance on benchmark

- 1 assessments, course grades and other factors consistent with the
- 2 CTE Concentrator's goals and career plan[.];
- 3 (iii) attains an industry-recognized credential, as approved
- 4 by the Pennsylvania Department of Education and identified in
- 5 the industry credential resource book compiled by the
- 6 department's Bureau of Career and Technical Education; or
- 7 <u>(iv) receipt of a certification that the student will begin</u>
- 8 work in a registered apprenticeship program following high
- 9 <u>school graduation</u>.
- 10 (c.1) Beginning in school year 2018-2019, notwithstanding
- 11 any statute or regulation to the contrary, students shall be
- 12 provided the following alternatives to demonstrate readiness for
- 13 graduation:
- (1) Compliance with subsection (c).
- 15 (2) As to any academic content area as to which a student
- 16 did not achieve proficiency on the Keystone Exam, or any
- 17 successor exam, a student shall be deemed proficient for
- 18 graduation purposes as to the content area if the student
- 19 <u>completes one or more of the following:</u>
- 20 (i) The earning of a passing grade in a dual-enrollment
- 21 course in a comparable content area.
- 22 (ii) The earning of a passing score on an advanced placement
- 23 assessment in a comparable content area.
- 24 (iii) The earning of a passing score on an international
- 25 baccalaureate assessment or course in a comparable content area.
- 26 (3) If a student attains one or more of the following, the
- 27 student shall be deemed proficient for graduation purposes,
- 28 regardless of scores on the Keystone Exam or successor exam:
- 29 (i) A combined score above the fiftieth percentile on either
- 30 the SAT or ACT.

- 1 (ii) Achievement of a minimum score on the Armed Services
- 2 <u>Vocational Aptitude Battery test required for enlistment.</u>
- 3 (iii) Proof of acceptance of admission or scholarship to an
- 4 <u>accredited institution of higher education. The Pennsylvania</u>
- 5 Department of Education shall maintain a list of approved
- 6 <u>institutions</u>.
- 7 (4) Attainment of an established composite score on the
- 8 Algebra I, Biology and Literature Keystone Exams. The Secretary
- 9 <u>of Education shall propose the satisfactory composite score a</u>
- 10 student must attain no later than September 30, 2019, and shall
- 11 <u>submit the proposed composite score to the State Board of</u>
- 12 Education for approval. The State Board of Education shall
- 13 approve a composite score no later than December 31, 2019. At a
- 14 minimum, the composite score shall require a student to achieve
- 15 <u>a proficient score on at least one of the three content areas of</u>
- 16 the Keystone Exam and no less than a basic score on the
- 17 remaining portions and shall be no less than one standard
- 18 deviation below the mean.
- 19 (c.2) Notwithstanding section 2604-B(b)(2)(v), 22 Pa. Code §
- 20 4.24 (relating to high school graduation requirements) or 4.51
- 21 <u>(relating to State assessment system) or any statute or</u>
- 22 regulation to the contrary, beginning with the 2018-2019 school
- 23 year, neither project-based assessments, as provided for in 22
- 24 Pa. Code § 4.51c (relating to project-based assessment), nor
- 25 supplemental instruction shall be required of any student for
- 26 high school graduation. Supplemental instruction may be provided
- 27 within the guidance of the Department of Education.
- 28 (c.3) A child with a disability who satisfactorily completes
- 29 <u>a special education program developed by an individualized</u>
- 30 education program team under the Individuals with Disabilities

- 1 Education Act (Public Law 91-230, 20 U.S.C. § 1400 et seq.) and
- 2 <u>22 Pa. Code Ch. 14 (relating to special education services and</u>
- 3 programs) shall be granted and issued a regular high school
- 4 <u>diploma by the school entity, if applicable. This subsection</u>
- 5 shall apply if the special education program of a child with a
- 6 <u>disability does not otherwise meet the requirements of this</u>
- 7 section.
- 8 (c.4) The Secretary of Education, with approval of the State
- 9 Board of Education, may approve locally administered assessments
- 10 for graduation purposes in addition to the alternatives provided
- 11 <u>under this section. Locally administered assessments shall be</u>
- 12 <u>independently and objectively validated once every six years.</u>
- 13 Local assessments may be designed to include a variety of
- 14 assessment strategies for graduation purposes, including the use
- 15 of the GED, the HiSET® exam, attainment of a career-readiness
- 16 certificate through the ACT WorkKeys assessment, an internship,
- 17 externship or cooperative education program or one or more
- 18 portions of the Keystone Exam. Validated local assessments shall
- 19 contain performance-level expectations and descriptors that
- 20 describe a level of performance comparable to those required to
- 21 achieve proficiency on the Keystone Exams.
- 22 (d) As used in this section, the following words and phrases
- 23 shall have the meanings given to them in this subsection unless
- 24 the context clearly indicates otherwise:
- 25 <u>"Accredited institution of higher education." A public,</u>
- 26 private or independent college or university which has received
- 27 <u>accreditation from an entity recognized by the United States</u>
- 28 Department of Education, the Pennsylvania Department of
- 29 Education or the Council for Higher Education Accreditation.
- 30 "ACT." The nationally recognized college admissions test to

- 1 <u>determine academic readiness for college.</u>
- 2 "Approved industry-based competency assessment." A NOCTI
- 3 exam, NIMS assessment or other industry-based competency
- 4 assessment identified by the Secretary of Education and approved
- 5 by the State Board of Education.
- 6 <u>"Armed Services Vocational Aptitude Battery." The multiple-</u>
- 7 aptitude test, including the Armed Forces Qualification Test,
- 8 <u>used by the United States military to determine vocational</u>
- 9 <u>aptitude and qualification for enlistment.</u>
- 10 "Cooperative education program." A program of instruction
- 11 whereby students alternate or coordinate their high school
- 12 studies with a job in a field related to their academic or
- 13 career objectives.
- "CTE Concentrator." A student who, by the end of a reporting
- 15 year, will be reported as successfully completing at least fifty
- 16 percent (50%) of the minimum technical instructional hours
- 17 required under 22 Pa. Code Ch. 339 (relating to vocational
- 18 education).
- 19 "GED." The General Educational Development Test from the
- 20 American Council on Education.
- 21 "HiSET® exam." The high school equivalency exam offered by
- 22 the Educational Testing Service.
- 23 "NIMS assessment." An assessment based on the National
- 24 Institute for Metalworking Skills standards.
- 25 "NOCTI exam." A National Occupational Competency Testing
- 26 Institute exam.
- 27 <u>"Scholastic Aptitude Test" or "SAT." The nationally</u>
- 28 recognized college and career readiness assessment developed by
- 29 <u>the college board.</u>
- 30 "Successor exam." An assessment which replaces the Keystone

- 1 Exam and is developed to comply with section 1111 of the
- 2 <u>Elementary and Secondary Education Act of 1965 (Public Law 89-</u>
- 3 10, 20 U.S.C. § 6301 et seq.), as amended by the Every Student
- 4 Succeeds Act (Public Law 114-95, 129 Stat. 1802), or its
- 5 successor Federal statute.
- 6 Section 2. This act shall take effect immediately.
