## AN ACT

Amending Title 25 (Elections) of the Pennsylvania Consolidated Statutes, in preliminary provisions relating to voter 2 registration, further providing for definitions; in 3 registration system, further providing for SURE system; in voter registration, further providing for qualifications to 5 register, for government agencies, for time and for 6 preparation and distribution of applications; and, in changes 7 in records, further providing for death of registrant. 8 9 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 1102 of Title 25 of the Pennsylvania 11 12 Consolidated Statutes is amended by adding a definition to read: 1.3 § 1102. Definitions. 14 Subject to additional definitions contained in subsequent 15 provisions of this part which are applicable to specific 16 provisions of this part, the following words and phrases when 17 used in this part shall have the meanings given to them in this 18 section unless the context clearly indicates otherwise: \* \* \* 19 20 "Preregistrant." A person who is at least 16 years of age,

but not yet 18 years of age, who is otherwise eligible to

- 1 register to vote in accordance with this part.
- 2 "Preregistration." A process in which a preregistrant
- 3 submits the information necessary for voter registration and
- 4 <u>inclusion into the SURE system in accordance with this part</u>
- 5 prior to the time at which the preregistrant is eligible to
- 6 <u>actively register to vote under section 1301 (relating to</u>
- 7 qualifications to register).

- 9 Section 2. Section 1222(c) of Title 25 is amended by adding

- 13 (c) Requirements. -- The SURE system shall be developed as a
- 14 single, uniform integrated computer system. All commissions
- 15 shall be connected electronically to the SURE system and shall
- 16 maintain their registration records in the system. The SURE
- 17 system shall, at a minimum, do all of the following:

- 20 <u>tracking of preregistration status.</u>

- 22 preregistrant no later than the preregistrant's 18th

- 25 Section 3. Section 1301(a) of Title 25 is amended and the
- 26 section is amended by adding a subsection to read:
- 27 § 1301. Qualifications to register.
- 28 (a) Eligibility.--[An] Except as provided in subsection
- 29 (a.1), an individual [who] shall be eliqible to register to vote
- 30 if the individual:

- 1 <u>(1)</u> will be at least 18 years of age on the day of the
- 2 next election[, who];
- 3 (2) has been a citizen of the United States for at least
- 4 one month prior to the next election and [who] has resided in
- 5 this Commonwealth and the election district where the
- 6 individual offers to vote for at least 30 days prior to the
- 7 next ensuing election; and
- 8 (3) has not been confined in a penal institution for a
- 9 conviction of a felony within the last five years shall be
- 10 eligible to register as provided in this chapter.
- 11 (a.1) Preregistration. -- Notwithstanding subsection (a) (1), a
- 12 preregistrant may preregister to vote, provided that the
- 13 preregistrant may not vote in any election before reaching 18
- 14 years of age. The department shall provide guidance within 90
- 15 days of the effective date of this subsection to assist
- 16 <u>commissions in implementing preregistration.</u>

- to vote, you must be at least 18 years of age on the day of
- the next election, you must have been a citizen of the United
- 30 States for at least one month prior to the next election and

- 1 have resided in Pennsylvania and the election district where
- 2 you plan to vote for at least 30 days prior to the next
- 3 election, and you must not have been confined in a penal
- 4 institution for a conviction of a felony within the last five
- 5 years[."]. You may preregister to vote if you are at least 16
- 6 years of age, provided you may not vote in an election until
- 7 you reach 18 years of age."

- 15 (3) In the case of preregistration, each commission
- 16 shall:
- 17 (i) enter preregistration information into the SURE
- 18 system upon receipt of the information; and
- (ii) ensure that each preregistrant is actively
- registered to vote no later than the preregistrant's 18th
- 21 birthday.
- 22 Section 6. Sections 1327(a)(4)(iii) and (b)(1)(ii) and
- 23 1505(a) of Title 25 are amended to read:
- 24 § 1327. Preparation and distribution of applications.
- 25 (a) Form.--

- 27 (4) A voter registration application shall be printed on
- stock of good quality and shall be of suitable uniform size.
- Nothing in this part shall prohibit the design and use of an
- 30 electronic voter registration application which includes the

1 applicant's digitized or electronic signature. The

2 registration application shall contain the following

3 information; however, the information may be provided on a

4 separate form for voter registration made under section 1323

7 (iii) Notice that the applicant must be a citizen of 8 the United States for at least one month prior to the 9 next election and a resident of this Commonwealth and the election district for at least 30 days and must be at 10 11 least 18 years of age by the day of the next ensuing 12 election, unless the individual is at least 16 years of 13 age and preregisters to vote, and has not been confined 14 in a penal institution for a conviction of a felony 15 within the last five years. The notice required in this 16 subparagraph shall be in print identical to the 17 declaration under subsection (b).

- 19 (b) Registration declaration. --
- 20 (1) The official voter registration application shall 21 contain a registration declaration. On the declaration, the 22 applicant shall state all of the following:

(ii) On the day of the next ensuing election, the
applicant shall be at least 18 years of age[.], unless
the applicant is preregistering to vote in the next
election in which the individual reaches 18 years of age.

- 29 § 1505. Death of registrant.
- 30 (a) Department of Health.--A commission shall cancel the

- 1 registration of a registered elector or the preregistration of a
- 2 preregistrant reported dead by the Department of Health. The
- 3 Department of Health shall, within 60 days of receiving notice
- 4 of the death of an individual [18] 16 years of age or older,
- 5 send the name and address of residence of that individual to a
- 6 commission in a manner and on a form prescribed by the
- 7 department. The commission shall promptly update information
- 8 contained in its registration records.

- 10 Section 7. This act shall take effect in 60 days.
