## AN ACT

Authorizing and directing the Department of General Services, 1 with the approval of the Governor and the Department of 2 Military and Veterans Affairs, to grant and convey to the 3 Pennhurst Memorial Preservation Alliance, or its assigns, a 4 certain tract of land with certain improvements on it situate 5 in East Vincent Township, Chester County. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: Section 1. Conveyance in East Vincent Township, Chester County. 9 10 (a) Authorization.--The Department of General Services, with 11 the approval of the Governor and the Department of Military and Veterans Affairs, is authorized on behalf of the Commonwealth of 12 13 Pennsylvania to grant and convey to the Pennhurst Memorial 14 Preservation Alliance, or its assigns, a certain tract of land with certain improvements on it situate in East Vincent 15 16 Township, Chester County, for \$1. 17 (b) Description. -- The property to be conveyed under this section is more particularly described as follows: 18 ALL THAT CERTAIN tract of land situated on the northeast 19 20 corner of the intersection of Veterans Drive and Pennhurst

Road (extended), in the Township of East Vincent, County of
 Chester and Commonwealth of Pennsylvania, being approximately
 3.83 acres bounded and more particularly described as
 follows:

5 BEGINNING at a point in Pennhurst Road (extended), a corner 6 of lands of now or formerly Pennhurst Acquisition LP and the 7 Commonwealth of Pennsylvania;

8 THENCE leaving said road in a southeasterly direction and 9 along lands of now or formerly Pennhurst Acquisition LP, 10 South 74 degrees 38 minutes 01 seconds East, 294.73 feet, to 11 a point along lands of now or formerly Pennhurst Acquisition 12 LP;

13 THENCE moving southerly, away from lands now or formerly 14 Pennhurst Acquisition LP and along lands of the Commonwealth 15 of Pennsylvania, South 4 degrees 37 minutes 35 seconds East, 16 145.59 feet to a point along the western side of an existing 17 stone driveway;

18 THENCE following the western side of the stone driveway and 19 along lands now or formerly of The Commonwealth of 20 Pennsylvania, South 6 degrees 19 minutes 22 seconds East, 21 88.62 feet to a point along the northern edge of Veterans 22 Drive;

23 THENCE along Veterans drive moving westerly, South 79 degrees 24 56 minutes 54 seconds West, 435.16 feet to a point; thence 25 continuing along Veterans Drive, South 80 degrees 39 minutes 26 01 second West, 109.60 feet to a point; thence continuing 27 along Veterans Drive, South 78 degrees 18 minutes 00 seconds West, 86.45 feet to a point along the southern side of a 28 29 stone wall and near the intersection Veterans Drive and Pennhurst Road; 30

1 THENCE continuing along the aforementioned stone wall, South 2 85 degrees 16 minutes 41 seconds West, 7.75 feet to a point; 3 thence continuing northwesterly, along the aforementioned 4 stone wall, by a line curving to the right having a radius of 5 26.59 feet, an arc length of 42.46 feet and a chord bearing 6 of North 43 degrees 41 minutes 04 seconds West, a chord 7 distance of 38.09 feet to a point;

8 THENCE continuing along the west side of the aforementioned 9 stone wall and also along the eastern edge of Pennhurst Road 10 (extended) the following ten (10) courses and distances: (1) 11 North 06 degrees 58 minutes 31 seconds East, 10.42 feet to a 12 point; (2) North 16 degrees 14 minutes 58 seconds East, 13.71 13 feet to a point; (3) North 23 degrees 39 minutes 08 seconds 14 East, 27.00 feet to a point; (4) North 34 degrees 40 minutes 40 seconds East, 83.50 feet to a point; (5) North 36 degrees 15 20 minutes 06 seconds East, 26.32 feet to a point; (6) North 16 17 43 degrees 10 minutes 50 seconds East, 44.60 feet to a point; 18 (7) in northeasterly direction by a line curving to the right 19 having a radius of 1,212.11 feet, an arc length of 72.01 20 feet, a chord bearing of North 46 degrees 47 minutes 01 21 seconds East, a chord distance of 71.99 feet to a point; (8) 22 North 47 degrees 48 minutes 03 seconds East, 57.96 feet to a 23 point; (9) North 43 degrees 08 minutes 03 seconds East, 29.88 24 feet to a point; (9) North 47 degrees 07 minutes 44 seconds 25 East, 18.89 feet to a point; (10) North 50 degrees 31 minutes 26 12 seconds East, 47.92 feet to a point; 27 THENCE gradually moving northeasterly into aforementioned 28 Pennhurst Road (extended) North 45 degrees 40 minutes 09 29 seconds East, 102.60 feet to the POINT and PLACE of 30 BEGINNING, CONTAINING 3.83 acres more or less.

1 (c) Conditions.--The conveyance shall be made under and subject to all lawful and enforceable easements, servitudes and 2 rights of others, including, but not confined to, streets, 3 roadways and rights of any telephone, telegraph, water, 4 electric, gas or pipeline companies, as well as under and 5 subject to any lawful and enforceable estates or tenancies 6 7 vested in third persons appearing of record, for any portion of 8 the land or improvements erected thereon.

9 (d) Execution.--The conveyance shall be executed by the
10 Secretary of General Services in the name of the Commonwealth of
11 Pennsylvania.

12 (e) Costs and fees.--Costs and fees incidental to this13 conveyance shall be borne by the grantee.

14 (f) Expiration.--If this conveyance is not fully executed 15 within two years of the effective date of this section, the 16 authority contained in this section shall expire.

17 Section 2. Effective date.

18 This act shall take effect immediately.
