Transfers prohibited. There is no authority for the State Treasurer, the Secretary 11 12 of the Budget, the Secretary of Revenue or the Pennsylvania 13 Gaming Control Board to transfer any money within or between the 14 appropriations in Part III. 15 Section 502. Effective date. This act shall take effect July 1, 2017, or immediately, 16 17 whichever is later.
