- 20 SECTION 9. REPORT TO THE GOVERNOR AND THE GENERAL ASSEMBLY. <--
- 21 (A) DUTY TO SUBMIT. -- NOT LATER THAN [ONE YEAR] TWO YEARS
- 22 AFTER THE EFFECTIVE DATE OF THIS SECTION, THE COMMISSION SHALL
- 23 SUBMIT TO THE GOVERNOR AND THE GENERAL ASSEMBLY A COMPREHENSIVE
- 24 REPORT THAT INCLUDES THE SPECIFIC RECOMMENDATIONS OF THE
- 25 COMMISSION FOR THE COMMEMORATION OF THE 250TH ANNIVERSARY OF THE
- 26 FOUNDING OF THE UNITED STATES AND RELATED EVENTS.
