AN ACT

- Providing for consumer prescription drug pricing disclosure and pharmacy freedom to communicate.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Consumer
- 7 Prescription Drug Pricing and Freedom Disclosure Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Contract." A contract administered by a pharmacy benefits <--
- 13 manager PHARMACY BENEFIT MANAGER or pharmacy services <--
- 14 administration organization.

- 1 "Covered entity." A contract holder or policy holder
- 2 providing pharmacy benefits to a covered individual under a
- 3 health insurance policy pursuant to a contract administered by a
- 4 pharmacy benefits manager PHARMACY BENEFIT MANAGER.

5 "Covered individual." A member, participant, enrollee or

- 6 beneficiary of a covered entity who is provided health coverage
- 7 by the covered entity. The term includes a dependent or other
- 8 person provided health coverage through the policy or contract
- 9 of a covered individual.
- 10 "Health insurance policy." A policy, subscriber contract,
- 11 certificate or plan that provides prescription drug coverage.
- 12 The term includes both comprehensive and limited benefit health
- 13 policies.
- "Pharmacist." As defined in section 2(10) of the act of
- 15 September 27, 1961 (P.L.1700, No.699), known as the Pharmacy
- 16 Act.
- 17 "Pharmacy." As defined in section 2(12) of the Pharmacy Act.
- 18 "Pharmacy benefits management." "PHARMACY BENEFIT
- 19 MANAGEMENT." Any of the following:
- 20 (1) Procurement of prescription drugs at a negotiated
- 21 contracted rate for distribution within this Commonwealth to
- 22 covered individuals.
- 23 (2) Administration or management of prescription drug
- 24 benefits provided by a covered entity for the benefit of
- 25 covered individuals.
- 26 (3) Administration of pharmacy benefits, including:
- 27 (i) Operating a mail-service pharmacy.
- 28 (ii) Claims processing.
- 29 (iii) Retail pharmacy network management.
- 30 (iv) Paying claims to pharmacies for prescription

- drugs dispensed to covered individuals by a retail,
- 2 specialty or mail-order pharmacy.
- 3 (v) Developing and managing a clinical formulary,
- 4 utilization management and quality assurance programs.
- 5 (vi) Rebate contracting and administration.
- 6 (vii) Managing a patient compliance, therapeutic
- 7 intervention and generic substitution program.
- 8 (viii) Operating a disease management program.
- 9 (ix) Setting pharmacy reimbursement pricing and
- 10 methodologies, including maximum allowable cost, and
- 11 determining single or multiple source drugs.
- 12 "Pharmacy benefits manager." "PHARMACY BENEFIT MANAGER." A <--
- 13 person, business or other entity that performs pharmacy benefits <--
- 14 management PHARMACY BENEFIT MANAGEMENT FOR COVERED ENTITIES. THE <--
- 15 TERM DOES NOT INCLUDE AN ENTITY THAT HOLDS A VALID LICENSE BY
- 16 THE INSURANCE DEPARTMENT WITH ACCIDENT AND HEALTH AUTHORITY TO
- 17 ISSUE A HEALTH INSURANCE POLICY AND GOVERNED UNDER ANY OF THE
- 18 FOLLOWING:
- 19 (1) THE ACT OF MAY 17, 1921 (P.L.682, NO.284), KNOWN AS
- THE INSURANCE COMPANY LAW OF 1921, INCLUDING SECTION 630 AND
- 21 ARTICLE XXIV OF THAT ACT.
- 22 (2) THE ACT OF DECEMBER 29, 1972 (P.L.1701, NO.364),
- 23 KNOWN AS THE HEALTH MAINTENANCE ORGANIZATION ACT.
- 24 (3) 40 PA.C.S. CH. 61 (RELATING TO HOSPITAL PLAN
- 25 CORPORATIONS) OR 63 (RELATING TO PROFESSIONAL HEALTH SERVICES
- 26 PLAN CORPORATIONS).
- 27 "Pharmacy services administration organization." A person,
- 28 business or other entity that performs any of the following:
- 29 (1) Negotiates and contracts with managed care
- 30 organizations or pharmacy benefit managers on behalf of their

- 1 pharmacy members.
- 2 (2) Negotiates reimbursement rates, payment and audit 3 terms on behalf of their pharmacy members.
- 4 (3) Payment collection or reconciliation on behalf of <--

- 5 their pharmacy members. PROVIDES PAYMENT COLLECTION OR
- 6 RECONCILIATION SERVICES ON BEHALF OF THEIR PHARMACY MEMBERS.
- 7 Section 3. Disclosure of prescription drug costs.
- 8 (a) Information to covered individual. -- A pharmacy or
- 9 pharmacist shall have the right to provide a covered individual
- 10 with information concerning the cost of a prescription drug,
- 11 including the individual's cost share.
- 12 (b) No prohibition or penalization. -- A pharmacy, pharmacist
- 13 or contracting agent of a pharmacy or pharmacist may not be
- 14 prohibited from or penalized by a pharmacy benefits manager-
- 15 PHARMACY BENEFIT MANAGER or pharmacy services administration <-
- 16 organization for discussing the information under subsection
- 17 (a), disclosing the availability of therapeutically equivalent
- 18 alternative medications or selling to the covered individual a
- 19 more affordable alternative if an affordable alternative is
- 20 available.
- 21 Section 4. Disclosure of contract information.
- 22 (a) Disclosure authorized. A pharmacy benefits manager or
- 23 pharmacy services administration organization shall not-
- 24 prohibit, restrict or limit written or oral disclosure of
- 25 contract information by a pharmacist or pharmacy to any State,
- 26 county or municipal official or before any State, county or
- 27 municipal committee, body or proceeding.
- 28 (b) Penalty prohibited. A pharmacy benefits manager or
- 29 pharmacy services administration organization shall not penalize-
- 30 or restrict a pharmacist or pharmacy for any disclosure under

- 1 subsection (a).
- 2 Section 5 4. Effective date.
