18	This chapter relates to a certification of compliance with

Federal and State insurance laws regarding mental health and

- 2 § 4302. Definitions.
- 3 The following words and phrases when used in this chapter
- 4 shall have the meanings given to them in this section unless the
- 5 <u>context clearly indicates otherwise:</u>
- 6 "Insurer." As follows:
- 7 (1) An entity that issues or administers health
- 8 <u>insurance policies or health plans and is subject to the</u>
- 9 <u>jurisdiction of the department.</u>
- 10 (2) The term includes an entity organized or existing
- 11 <u>under, or subject to, any of the following:</u>
- 12 <u>(i) The act of May 17, 1921 (P.L.682, No.284), known</u>
- as The Insurance Company Law of 1921.
- 14 <u>(ii) The act of December 29, 1972 (P.L.1701,</u>
- No.364), known as the Health Maintenance Organization
- 16 <u>Act.</u>
- 17 (iii) The act of May 18, 1976 (P.L.123, No.54),
- 18 <u>known as the Individual Accident and Sickness Insurance</u>
- 19 <u>Minimum Standards Act.</u>
- 20 <u>(iv) Chapter 61 (relating to hospital plan</u>
- 21 corporations) or 63 (relating to professional health
- 22 <u>services plan corporations).</u>

- 26 § 4303. Certification.
- No later than January 1 of each year, an insurer that issues
- 28 <u>or administers a health insurance policy or health plan in this</u>
- 29 Commonwealth, including a policy or plan in which mental health
- 30 <u>or substance use disorder benefits are managed by an entity</u>

- 1 other than the insurer, shall file with the department a written
- 2 certification signed by an officer of the insurer under oath
- 3 attesting that:
- 4 (1) The insurer has completed a comprehensive review of
- 5 <u>all health insurance policies and health plans issued or</u>
- 6 administered by the insurer, including policies and plans in
- 7 <u>which mental health or substance use disorder benefits are</u>
- 8 <u>managed by an entity other than the insurer, for compliance</u>
- 9 <u>with the requirements of MHPAEA and its implementing</u>
- 10 <u>regulations and compliance with section 604-B of the act of</u>
- 11 <u>May 17, 1921 (P.L.682, No.284), known as The Insurance</u>
- 12 <u>Company Law of 1921, and its implementing regulations.</u>
- 13 (2) All policies and plans under paragraph (1) comply
- with the laws and regulations referred to in paragraph (1).
- 15 § 4304. Regulations.
- 16 The department shall promulgate regulations necessary to
- 17 implement this chapter.
- 18 Section 2. All acts and parts of acts are repealed insofar
- 19 as they are inconsistent with 40 Pa.C.S. Ch. 43.
- 20 Section 3. This act shall take effect immediately.
