AN ACT

- Amending Titles 8 (Boroughs and Incorporated Towns) and 11 (Cities) of the Pennsylvania Consolidated Statutes, in 2 corporate powers, further providing for real property; and, 3 in corporate powers, further providing for city property and 4 affairs. 5 The General Assembly of the Commonwealth of Pennsylvania 6 7 hereby enacts as follows: Section 1. Section 1201.1(a) and (c) of Title 8 of the 8 Pennsylvania Consolidated Statutes are amended to read:
- 10 § 1201.1. Real property.
- 11 (a) Sale.--No real estate owned by the borough may be sold
- 12 except upon approval of council by resolution. Additionally, no
- 13 real estate owned by the borough may be sold for a consideration
- 14 in excess of [\$1,500] \$6,000, except to the highest bidder after
- 15 due notice by advertisement for bids or advertisement of a
- 16 public auction.

- 18 (c) Exception. -- Real estate owned by a borough may be sold
- 19 at a consideration of [\$1,500] \$6,000 or less without

- 1 advertisement or competitive bidding only after council
- 2 estimates the value of the property upon receipt of an appraisal
- 3 by a qualified real estate appraiser. Prior to selling real
- 4 <u>estate valued at \$6,000 or less without advertisement or</u>
- 5 competitive bidding, borough council shall make a public
- 6 <u>announcement of the council's intention to sell the real estate</u>
- 7 <u>at a regular or special meeting of council at least 30 days</u>
- 8 prior to the sale.

- 14 (b) Sales of real estate.--
- 15 (1) No real estate owned by the city may be sold except
- 16 upon approval of council by resolution, and no real estate
- 17 owned by the city may be sold for a consideration in excess
- of [\$1,500] \$6,000, except to the highest bidder after due
- notice by advertisement for bids or advertisement of a public
- auction in one newspaper of general circulation in the city.

- 22 (8) Real estate owned by a city may be sold at a
- consideration of [\$1,500] \$6,000 or less without
- 24 advertisement or competitive bidding only after council
- 25 estimates the value of the real estate upon receipt of an
- 26 appraisal by a qualified real estate appraiser. Prior to
- 27 <u>selling real estate valued at \$6,000 or less without</u>
- 28 <u>advertisement or competitive bidding, council shall make a</u>
- 29 <u>public announcement of the council's intention to sell the</u>
- real estate at a regular or special meeting of council at

- 1 <u>least 30 days prior to the sale.</u>
