- 2 (a) General rule. -- Notwithstanding 18 Pa.C.S. § 508
- 3 (relating to use of force in law enforcement) and except as
- 4 provided under subsection (b), in making an arrest a
- 5 Pennsylvania State Police officer or municipal police officer:
- 6 <u>(1) May not:</u>
- 7 <u>(i) apply the use of a chokehold;</u>
- 8 <u>(ii) apply any pressure to the diaphragm, airways or</u>
- 9 <u>any compression that inhibits breath or the flow of blood</u>
- to the brain of the person; or
- 11 (iii) hold the person in prone restraint or facedown
- 12 <u>while restrained for a period of time exceeding three</u>
- minutes or as practical as to avoid positional asphyxia.
- 14 (2) May not keep the person in prone restraint or a
- facedown position once the person is restrained.
- 16 (b) Application. -- The prohibitions under subsection (a)
- 17 shall not apply when the use of deadly force is permitted under
- 18 <u>law.</u>
- 19 (c) Definitions. -- As used in this section, the following
- 20 words and phrases shall have the meanings given to them in this
- 21 subsection unless the context clearly indicates otherwise:
- 22 "Prone restraint." All items or measures used to restrain a
- 23 person in a facedown position.
- 24 Section 2. This act shall take effect in 60 days.
