## A RESOLUTION

1 2	Designating the week of June 16 through 22, 2019, as "Trench Safety Stand Down Week" in Pennsylvania.
3	WHEREAS, Trenching and excavation work are hazardous
4	construction operations performed by many Pennsylvanians every
5	day; and
6	WHEREAS, Construction employers and employees who work in
7	trenching and excavation need continuous access to education and
8	training in identifying hazards associated with these
9	activities; and
10	WHEREAS, Trench collapse deaths are easily preventable with
11	proper shielding, shoring, sloping and training; and
12	WHEREAS, Despite increased training and hazard
13	identification, recent national statistics show an alarming
14	increase in trench injuries and deaths, and in 2016, the United
15	States Occupational Safety and Health Administration (OSHA)
16	reported that trench injuries and deaths were nearly double the

1 average of the previous five years; and

2 WHEREAS, NUCA Pennsylvania, a chapter of a National 3 Construction Trade Association representing underground utility 4 and excavating contractors, has focused on education and 5 training through trenching and excavating hazard awareness 6 programs that are approved by OSHA and sponsored by the North 7 American Excavation Shoring Association; and

8 WHEREAS, During "Trench Safety Stand Down Week" and 9 throughout the year, organizations and individuals in this 10 Commonwealth are encouraged to focus on education and training 11 in trenching and excavating hazard awareness in order to improve 12 the health, safety and welfare of construction workers and all 13 residents of this Commonwealth; therefore be it

14 RESOLVED, That the House of Representatives designate the 15 week of June 16 through 22, 2019, as "Trench Safety Stand Down 16 Week" in Pennsylvania; and be it further

17 RESOLVED, That the House of Representatives transmit a copy 18 of this resolution to NUCA Pennsylvania so that members of the 19 organization may be apprised of the House of Representatives' 20 commitment to raising awareness of trenching and excavation 21 hazards.
