AN ACT

- 1 Providing for enforceability of certain indemnity provisions in
- certain snow removal and ice control services contracts
- 3 relating to commercial property.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Commercial
- 8 Property Snow Removal and Ice Control Services Contract
- 9 Liability Limitation Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Commercial property." A property or portion of a property
- 15 that is used, occupied or is intended, arranged or designed to
- 16 be used or occupied for the purpose of operating a business, an
- 17 office, a manufacturing facility or a public accommodation. The
- 18 term includes any of the following:

- 1 (1) All or part of a building, structure or facility on
- 2 the property or portion of the property.
- 3 (2) A residential development operating under a
- 4 homeowners' association for the maintenance of the property
- 5 or portion of the property.
- 6 (3) An apartment complex consisting of five or more
- 7 residential dwelling units.
- 8 "Person." Includes a corporation, partnership, limited
- 9 liability company, business trust, other association, estate,
- 10 trust, foundation or individual. The term does not include the
- 11 Commonwealth, a political subdivision or an instrumentality of
- 12 the Commonwealth or a political subdivision.
- "Service provider." A person providing services for a
- 14 commercial property under a snow removal and ice control
- 15 services contract.
- 16 "Service receiver." A person receiving services for a
- 17 commercial property under a snow removal and ice control
- 18 services contract.
- "Snow removal and ice control services contract." A contract
- 20 or agreement for the performance of any of the following:
- 21 (1) Plowing, shoveling, relocating or other removal of
- 22 snow or other mixed precipitation from a surface.
- 23 (2) De-icing services.
- 24 (3) A service incidental to an activity under paragraph
- 25 (1) or (2), including operating or otherwise moving snow
- 26 removal or de-icing equipment or materials.
- 27 Section 3. Certain indemnity agreements void.
- A provision, clause, covenant or agreement that is part of or
- 29 in connection with a snow removal and ice control services
- 30 contract is against public policy and void if the provision,

- 1 clause, covenant or agreement requires, or has the effect of
- 2 requiring, a service provider to:
- 3 (1) indemnify a service receiver for damages resulting
- 4 from the acts or omissions of the service receiver or the
- 5 service receiver's agents or employees; or
- 6 (2) defend a service receiver against tort liability for
- 7 damages resulting from the acts or omissions of the service
- 8 receiver or the service receiver's agents or employees.
- 9 Section 4. Applicability.
- 10 The provisions of this act:
- 11 (1) Shall apply to snow removal and ice control services
- 12 contracts entered into on or after the effective date of this
- 13 section.
- 14 (2) Shall not apply to an insurance policy, a surety
- bond or workers' compensation.
- 16 Section 5. Construction.
- 17 Nothing in this act shall be construed to affect an immunity
- 18 or affirmative defense arising under other law.
- 19 Section 6. Effective date.
- This act shall take effect immediately.
