AN ACT

- Amending the act of July 9, 1987 (P.L.220, No.39), entitled "An act licensing and regulating the practice of social work; providing penalties; and making an appropriation," further providing for licensing and regulating the practice of music 4 therapy; and making editorial changes. 5 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 7 8 Section 1. The title and sections 1 and 2 of the act of July 9, 1987 (P.L.220, No.39), known as the Social Workers, Marriage 10 and Family Therapists and Professional Counselors Act, are 11 amended to read: 12 AN ACT 13 Licensing and regulating the practice of social work, marriage and family therapy, professional counseling and professional 14 15 music therapy; providing penalties; and making an 16 appropriation.
- 17 Section 1. Short title.

- 1 This act shall be known and may be cited as the Social
- 2 Workers, Marriage and Family Therapists [and], Professional
- 3 Counselors and Professional Music Therapists Act.
- 4 Section 2. Legislative intent.
- 5 The practice of social work, marriage and family therapy
- 6 [and], professional counseling and professional music therapy
- 7 within this Commonwealth is hereby declared to affect the public
- 8 safety and welfare and to be subject to regulation and control
- 9 in the public interest to protect the public from
- 10 unprofessional, improper, unauthorized and unqualified practice
- 11 of licensed social work, licensed marriage and family therapy
- 12 [and] _ licensed professional counseling and as licensed
- 13 professional music therapy. This act regulates only those who
- 14 hold themselves out as licensed social workers, licensed
- 15 clinical social workers, licensed marriage and family therapists
- 16 [or as], licensed professional counselors or as licensed
- 17 professional music therapists. Acquisition of a license under
- 18 this act shall not be made a condition of the employment of a
- 19 person by the Commonwealth or any of its political subdivisions
- 20 or by nonprofit agencies.
- 21 Section 2. The definition of "board" in section 3 of the act
- 22 is amended and the section is amended by adding definitions to
- 23 read:
- 24 Section 3. Definitions.
- 25 The following words and phrases when used in this act shall
- 26 have the meanings given to them in this section unless the
- 27 context clearly indicates otherwise:
- 28 * * *
- 29 "Board." The State Board of Social Workers, Marriage and
- 30 Family Therapists [and], Professional Counselors and

- 1 Professional Music Therapists under the Bureau of Professional
- 2 and Occupational Affairs within the Department of State.
- 3 * * *
- 4 "Independent practice of music therapy." The application of
- 5 professional music therapy knowledge and skills by an
- 6 individual:
- 7 (1) who styles oneself as a professional music
- 8 therapist;
- 9 (2) who regulates and is responsible for the
- individual's own practice and treatment procedures; and
- 11 (3) whose practice is not affiliated with any other
- 12 practice, health care facility, government agency or
- 13 <u>government-regulated social service agency.</u>
- 14 * * *
- 15 <u>"Licensed professional music therapist." A person who</u>
- 16 engages in the practice of music therapy and who holds a current
- 17 license under this act.
- 18 * * *
- 19 "Practice of music therapy." As follows:
- 20 (1) The clinical and evidence-based use of music
- 21 <u>interventions to accomplish individualized goals for</u>
- 22 individuals of all ages and ability levels within a
- 23 <u>therapeutic relationship by a licensed professional music</u>
- therapist. Professional music therapists develop an
- 25 individualized music therapy treatment plan for a client or
- 26 group of clients that identifies the goals, objectives and
- 27 potential strategies of the music therapy services
- appropriate for the client or group of clients using music
- 29 therapy interventions, including, but not limited to, music
- improvisation, receptive music listening, song-writing, lyric

1	discussion, music and imagery, music performance, learning
2	through music and movement to music.
3	(2) The term includes:
4	(i) Accepting referrals for music therapy services
5	from medical, developmental, mental health or education
6	professionals, family members, clients, caregivers or
7	others involved and authorized with provision of client
8	services.
9	(ii) Conducting a music therapy assessment of a
10	client to determine if treatment is indicated. If
11	treatment is indicated, the licensed professional music
12	therapist collects systematic, comprehensive and accurate
13	information necessary to determine the appropriate type
14	of music therapy services to provide for the client.
15	(iii) Developing an individualized music therapy
16	treatment plan for a client that is based upon the
17	results of the music therapy assessment.
18	(iv) Carrying out an individualized music therapy
19	treatment plan that is consistent with other medical,
20	developmental, rehabilitative, habilitating, mental
21	health, preventive, wellness care or educational services
22	being provided to a client.
23	(v) Evaluating a client's response to music therapy
24	and the individualized music therapy treatment plan,
25	documenting change and progress and suggesting
26	modifications, as appropriate.
27	(vi) Developing a plan for determining when the
28	provision of music therapy services is no longer needed
29	in collaboration with the client, a physician or other
30	provider of health care or education of the client, the

Τ	<u>iamily or caregiver of the client and any other</u>
2	appropriate person upon whom the client relies for
3	support.
4	(vii) Minimizing barriers to ensure a client may
5	receive music therapy services in the least restrictive
6	<pre>environment.</pre>
7	(viii) Collaborating with and educating the client
8	and the family or caregiver of the client or any other
9	appropriate person about the needs of the client that are
10	being addressed in music therapy and the manner in which
11	the music therapy addresses those needs.
12	(ix) Utilizing appropriate knowledge and skill to
13	improve the practice of music therapy, including the use
14	of research, reasoning and problem-solving skills to
15	determine appropriate actions in the context of each
16	specific clinical setting.
17	(3) The term does not include:
18	(i) The screening, diagnosis or assessment of any
19	physical, mental or communication disorder.
20	(ii) A person whose training and national
21	certification attests to the person's preparation and
22	ability to practice the certified profession or
23	occupation, if the person does not represent that the
24	person is a music therapist.
25	(iii) The practice of music therapy as an integral
26	part of a program of study for a student enrolled in an
27	accredited music therapy program, if the student does not
28	represent that the student is a music therapist.
29	(iv) A person who engages in the practice of music
30	therapy under the supervision of a licensed professional

- 1 <u>music therapist, if the person does not represent that</u>
- 2 the person is a music therapist.
- 3 * * *
- 4 <u>"Professional music therapist." A person who has acquired</u>
- 5 the necessary education and qualifications to apply to be a
- 6 <u>licensed professional music therapist under this act and engage</u>
- 7 <u>in the practice of music therapy in this Commonwealth.</u>
- 8 * * *
- 9 Section 3. Sections 4, 5 heading, (a), (c) and (1) and 6(2)
- 10 and (3) of the act are amended to read:
- 11 Section 4. License required.
- 12 It shall be unlawful for any person to [hold himself or
- 13 herself forth as] represent that the person is a licensed
- 14 bachelor social worker, licensed social worker, licensed
- 15 clinical social worker, licensed marriage and family therapist
- 16 [or], licensed professional counselor or licensed professional
- 17 <u>music therapist</u> unless [he or she] <u>the person</u> shall first have
- 18 obtained a license pursuant to this act.
- 19 Section 5. State Board of Social Workers, Marriage and Family
- Therapists [and], Professional Counselors and
- 21 Professional Music Therapists.
- 22 (a) Creation. -- There is hereby created the State Board of
- 23 Social Workers, Marriage and Family Therapists [and],_
- 24 Professional Counselors and Professional Music Therapists, a
- 25 departmental administrative board in the Department of State.
- 26 The board shall consist of [13] 15 members who are citizens of
- 27 the United States and who have been residents of this
- 28 Commonwealth for a two-year period, two of whom shall be public
- 29 members; five of whom shall be licensed social workers, at least
- 30 one of whom shall be a licensed clinical social worker and at

- 1 least one of whom shall be a licensed social worker; two of whom
- 2 shall be licensed marriage and family therapists; two of whom
- 3 shall be licensed professional counselors; two of whom shall be
- 4 <u>licensed professional music therapists with a master's degree or</u>
- 5 higher in music therapy or a related field; one of whom shall be
- 6 either a licensed marriage and family therapist or a licensed
- 7 professional counselor whose membership shall rotate between
- 8 those professions at the expiration of the member's second term;
- 9 and one of whom shall be the Commissioner of Professional and
- 10 Occupational Affairs.
- 11 * * *
- 12 (c) Initial appointments. -- Within 90 days of the effective
- 13 date of this act, the Governor shall nominate one professional
- 14 member to serve as a clinical social worker member of the board;
- 15 three professional members to serve as professional counselor
- 16 members of the board, one of whom shall serve a two-year term,
- 17 one of whom shall serve a three-year term and one of whom shall
- 18 serve a four-year term; two professional members to serve as the
- 19 marriage and family therapist members of the board, one of whom
- 20 shall serve a two-year term and one of whom shall serve a four-
- 21 year term[.]; and two professional members to serve as the
- 22 <u>licensed professional music therapist members of the board, one</u>
- 23 of whom shall serve a two-year term and one of whom shall serve
- 24 <u>a four-year term.</u> The professional members of the board
- 25 initially appointed pursuant to this subsection need not be
- 26 licensed by the licensure examination adopted by the board but,
- 27 at the time of appointment, must have satisfied the education
- 28 and experience requirements of this act for licensure as a
- 29 clinical social worker, a marriage and family therapist [or], a
- 30 professional counselor or a licensed professional music

- 3 (1) Operating procedures. -- The board shall meet within 30
- 4 days after the appointment of its new members and set up
- 5 operating procedures and develop application forms for licensing
- 6 clinical social workers, marriage and family therapists [and],___
- 7 professional counselors and professional music therapists. It
- 8 shall be the responsibility of the board to circulate these
- 9 forms and educate the public to the requirements of licensing in
- 10 order to hold oneself out as a licensed bachelor social worker,
- 11 licensed social worker, licensed clinical social worker,
- 12 licensed marriage and family therapist [or], licensed
- 13 professional counselor <u>or professional music therapist</u> within
- 14 [the] this Commonwealth.
- 15 Section 6. Powers and functions of board.
- 16 The board shall have the following powers:
- 17 * * *
- 18 (2) To adopt and, from time to time, revise such rules
- and regulations as may be necessary to carry into effect the
- 20 provisions of this act. Such regulations may include, but
- 21 shall not be limited to, standards of professional practice
- 22 and conduct for licensed bachelor social workers, licensed
- 23 social workers, licensed clinical social workers, licensed
- 24 marriage and family therapists [and], licensed professional
- 25 counselors and licensed professional music therapists in
- 26 Pennsylvania.
- 27 (3) To examine for, deny, approve, issue, revoke,
- suspend or renew licenses of bachelor social workers, social
- 29 workers, clinical social workers, marriage and family
- therapists [and], professional counselors and professional

- 1 <u>music therapists</u> pursuant to this act and to conduct hearings
- 2 in connection therewith.

- 4 Section 4. Section 7 of the act is amended by adding a
- 5 subsection to read:
- 6 Section 7. Qualifications for license.
- 7 * * *
- 8 (h) Professional music therapist license. -- An applicant
- 9 shall be qualified for a license to hold oneself out as a
- 10 licensed professional music therapist, provided the applicant
- 11 <u>submits proof satisfactory to the board that:</u>
- 12 <u>(1) The applicant is of good moral character.</u>
- 13 (2) The applicant has completed the education and
- 14 clinical training requirements established by the American
- 15 <u>Music Therapy Association or any successor organization.</u>
- 16 (3) The applicant provides proof of passing the
- 17 examination for board certification offered by the
- 18 <u>Certification Board for Music Therapists or any successor</u>
- 19 organization or provides proof of being transitioned into
- 20 <u>board certification</u>, and provides proof that the applicant is
- 21 currently a board certified music therapist.
- 22 (4) The applicant remains actively certified by the
- 23 Certification Board for Music Therapists.
- 24 (5) The applicant has submitted an application
- accompanied by the application fee.
- 26 (6) The applicant has not been convicted of a felony
- 27 <u>under The Controlled Substance, Drug, Device and Cosmetic</u>
- 28 Act, or of an offense under the laws of another jurisdiction,
- 29 which, if committed in this Commonwealth, would be a felony
- 30 under The Controlled Substance, Drug, Device and Cosmetic

- 1 Act, unless:
- 2 <u>(i) at least 10 years have elapsed from the date of</u>
- 3 conviction;
- 4 <u>(ii) the applicant satisfactorily demonstrates to</u>
- 5 <u>the board that the applicant has made significant</u>
- 6 progress in personal rehabilitation since the conviction,
- 7 <u>such that licensure of the applicant should not be</u>
- 8 <u>expected to create a substantial risk of harm to the</u>
- 9 <u>health and safety of the applicant's clients or the</u>
- 10 public or a substantial risk of further criminal
- 11 <u>violation; and</u>
- 12 <u>(iii)</u> the applicant otherwise satisfies the
- 13 <u>qualifications contained in or authorized by this act.</u>
- 14 As used in this paragraph, the term "convicted" shall include
- a judgment, an admission of guilt or a plea of nolo
- 16 contendere.
- 17 Section 5. Sections 8(b) and 10(a) of the act are amended to
- 18 read:
- 19 Section 8. Procedures for licensing.
- 20 * * *
- 21 (b) Issuance of license. -- The board shall issue to each
- 22 person who meets the licensure requirements of this act a
- 23 certificate setting forth that such person is licensed to [hold
- 24 himself or herself out as] represent that the person is a
- 25 licensed bachelor social worker, a licensed social worker, a
- 26 licensed clinical social worker, a licensed marriage and family
- 27 therapist [or], a licensed professional counselor or a licensed
- 28 professional music therapist.
- 29 Section 10. Reciprocity.
- 30 (a) General rule. -- The board shall have the power to grant a

- 1 reciprocal license to an applicant who is licensed or certified
- 2 as a bachelor social worker, social worker, clinical social
- 3 worker, marriage and family therapist [or], professional
- 4 counselor or a professional music therapist in another state and
- 5 has demonstrated qualifications which equal or exceed those
- 6 required pursuant to this act in the determination of the board,
- 7 provided that no license shall be granted under this section to
- 8 an applicant unless the state in which the applicant is licensed
- 9 affords reciprocal treatment to persons who are residents of
- 10 this Commonwealth and who are licensed pursuant to this act.

- 12 Section 6. Section 10.1 of the act is amended by adding a
- 13 subsection to read:
- 14 Section 10.1. Endorsement of out-of-State licenses.
- 15 * * *
- 16 (d) Professional music therapist license. -- The board may
- 17 <u>issue a professional music therapist license without examination</u>
- 18 to an applicant holding a professional music therapist license
- 19 in another state who submits proof satisfactory to the board of
- 20 <u>all of the following:</u>
- 21 <u>(1) The applicant is of good moral character.</u>
- 22 (2) The applicant meets the educational requirements,
- 23 <u>including clinical training as specified in section 7(h).</u>
- 24 (3) The applicant holds a music therapy license that is
- in good standing from another state.
- 26 (4) The applicant has, at a minimum, been actively
- 27 <u>engaged in the practice of music therapy for five of the last</u>
- seven years immediately preceding the filing of the
- 29 application for licensure by endorsement with the board.
- 30 (5) The applicant has submitted an application

24 Section 12. Reinstatement of license.

Unless ordered to do so by Commonwealth Court or an appeal

26 therefrom, the board shall not reinstate the license of a person

27 to practice as a bachelor social worker, social worker, clinical

28 social worker, marriage and family therapist [or], professional

29 counselor or professional music therapist pursuant to this act,

30 which has been revoked. Any person whose license has been

- 1 revoked may apply for reinstatement, after a period of at least
- 2 five years, but must meet all of the licensing qualifications of
- 3 this act, including the examination requirement, if [he or she]
- 4 the person desires to practice as a bachelor social worker,
- 5 social worker, clinical social worker, marriage and family
- 6 therapist [or], professional counselor or professional music
- 7 therapist pursuant to this act at any time after such
- 8 revocation.

- 13 (1) Before providing music therapy services to a client
- for an identified clinical or developmental need, the
- 15 <u>licensed professional music therapist shall review with the</u>
- 16 <u>health care provider involved in the client's care the</u>
- 17 client's diagnosis, treatment needs and treatment plan.
- 18 (2) Before providing music therapy services to an
- 19 <u>individual for an identified educational need, the licensed</u>
- 20 <u>professional music therapist shall review with the</u>
- 21 individualized family service plan team or individualized
- 22 <u>education program team the individual's diagnosis, treatment</u>
- 23 <u>needs and treatment plan.</u>
- 24 (b) During treatment.--
- 25 (1) When providing music therapy services to a client,
- the licensed professional music therapist shall collaborate,
- 27 <u>as applicable, with the client's treatment team, including</u>
- 28 physician, psychologist, licensed social worker or other
- 29 mental health professional.
- 30 (2) When providing music therapy services to a client

- 1 with a communication disorder, the licensed professional
- 2 music therapist shall collaborate and discuss the music
- 3 <u>therapy treatment plan with the client's audiologist or</u>
- 4 <u>speech-language pathologist. When providing educational or</u>
- 5 <u>health care services, a licensed professional music therapist</u>
- 6 may not replace the services provided by an audiologist or a
- 7 <u>speech-language pathologist. Unless authorized to practice</u>
- 8 speech-language pathology, music therapists may not evaluate,
- 9 <u>examine</u>, instruct or counsel on speech, language,
- 10 communication and swallowing disorders and conditions.
- 11 (c) Use of title. -- Only individuals who have received
- 12 <u>licenses as licensed professional music therapists under this</u>
- 13 <u>act may style themselves as licensed professional music</u>
- 14 therapists and use the letters "L.P.M.T." in connection with
- 15 their names. It shall be unlawful for an individual to style
- 16 <u>oneself as a licensed professional music therapist, a music</u>
- 17 therapist or use any words or symbols indicating or tending to
- 18 indicate that the individual is a licensed professional music
- 19 therapist or a music therapist without holding a license in good
- 20 standing under this act.
- 21 (d) Construction. -- Nothing in this section shall be
- 22 construed to prohibit a person who is licensed or certified to
- 23 practice a profession by a Commonwealth agency or board from
- 24 practicing within the scope of that license or certificate or as
- 25 <u>otherwise authorized by law so long as the person does not</u>
- 26 represent themselves as a music therapist.
- 27 (e) Communication disorders. -- A licensed professional music
- 28 therapist may not represent to the public that the licensed
- 29 <u>professional music therapist is authorized to treat a</u>
- 30 communication disorder. This does not prohibit a licensed

- 1 professional music therapist from representing to the public
- 2 that the licensed professional music therapist works with
- 3 <u>clients who have a communication disorder and addresses</u>
- 4 communication skills.
- 5 Section 9. Sections 17(b), 18(b) and 20(a) of the act are
- 6 amended to read:
- 7 Section 17. Penalties.
- 8 * * *
- 9 (b) Civil penalty.--In addition to any other civil remedy or
- 10 criminal penalty provided for in this act, the board, by a vote
- 11 of the majority of the maximum number of the authorized
- 12 membership of the board as provided by law, or by a vote of the
- 13 majority of the duly qualified and confirmed membership or a
- 14 minimum of three members, whichever is greater, may levy a civil
- 15 penalty of up to \$10,000 on any current licensee who violates
- 16 any provision of this act, on any person who engages in the
- 17 independent practice of clinical social work, the independent
- 18 practice of marriage and family therapy [or] the independent
- 19 practice of professional counseling or the independent practice
- 20 of music therapy without being licensed pursuant to this act or
- 21 on any person who [holds himself or herself out as] represents
- 22 that the person is a licensed bachelor social worker, licensed
- 23 social worker, licensed clinical social worker, licensed
- 24 marriage and family therapist, licensed professional counselor
- 25 [or], marriage and family therapist or licensed professional
- 26 <u>music therapist</u> without being so licensed pursuant to this act.
- 27 The board shall levy this penalty only after affording the
- 28 accused party the opportunity for a hearing, as provided in
- 29 Title 2 of the Pennsylvania Consolidated Statutes (relating to
- 30 administrative law and procedure).

- 2 Section 18. License renewal; records and fees.
- 3 * * *
- 4 (b) Records. -- A record of all persons licensed to practice
- 5 as bachelor social workers, social workers, clinical social
- 6 workers, marriage and family therapists [and], professional
- 7 counselors <u>and professional music therapists</u> in Pennsylvania
- 8 shall be kept in the office of the board and shall be open to
- 9 public inspection and copying upon payment of a nominal fee for
- 10 copying the record.
- 11 * * *
- 12 Section 20. Unlawful practice.
- 13 (a) Unlawful practice prohibited.--It shall be unlawful for
- 14 any person to engage in the independent practice of clinical
- 15 social work, the independent practice of marriage and family
- 16 therapy [or] the independent practice of professional
- 17 counseling or the independent practice of music therapy or [hold
- 18 himself or herself out as] represent that the person is a
- 19 licensed bachelor social worker, licensed social worker,
- 20 licensed clinical social worker, <u>licensed</u> marriage and family
- 21 therapist [and], licensed professional counselor and licensed
- 22 professional music therapist without possessing a valid,
- 23 unexpired, unrevoked and unsuspended license issued under this
- 24 act.

- 26 Section 10. This act shall take effect in 60 days.
