## AN ACT

- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. Corporal Brandon Hardy Memorial Highway.
- 15 (a) Findings. -- The General Assembly finds that:
- 16 (1) Brandon Michael Hardy, born March 8, 1981, was a
- 17 resident of Cochranville, Chester County, and was the oldest
- 18 of four children.
- 19 (2) Corporal Hardy graduated from Octorara High School
- in 1999 and enrolled at CAT-Brandywine Vocational Technical
- 21 School in the culinary arts program and was awarded the
- Outstanding Culinary Arts Co-Op Student Award.
- 23 (3) After seeing news coverage of Operation Desert Storm
- in 1991, Corporal Hardy was inspired to join the military and
- later decided to join the United States Air Force in 1999.
- 26 (4) Corporal Hardy was stationed in Germany for two
- 27 years and served three years at Fairchild Air Force Base in
- 28 Spokane, Washington.
- 29 (5) While serving at these duty stations, Corporal Hardy
- 30 was deployed three times to the Middle East, serving in Saudi
- 31 Arabia, Oman and the United Arab Emirates.
- 32 (6) In an extraordinary move, Corporal Hardy decided to
- forgo his rank and pay to basically start over and enlist as
- 34 a member of the United States Marine Corps.
- 35 (7) After advanced infantry training, Corporal Hardy

- 1 moved on to Camp Pendleton where he graduated at the top of
- 2 the class at the Assault Amphibian Training School, serving
- 3 as crew chief of an assault amphibian vehicle assigned to the
- 4 3rd Assault Amphibian Battalion, 1st Marine Division, I
- 5 Marine Expeditionary Force.
- 6 (8) Corporal Hardy was deployed to Iraq on March 27,
- 7 2006.
- 8 (9) On April 28, 2006, in the early morning hours, at
- 9 the Haditha Dam area in Anbar Province, Iraq, Corporal Hardy
- 10 was returning to base camp after an aid and assist mission
- 11 when the vehicle in which he was a passenger struck an IED.
- 12 (10) Three of the five passengers of the Humvee were
- mortally wounded, including Corporal Hardy, who was killed in
- 14 action.
- 15 (11) As a member of the United States Marine Corps,
- 16 Corporal Hardy received the following awards:
- 17 (i) Purple Heart.
- 18 (ii) Combat Action Ribbon.
- 19 (iii) Good Conduct Medal.
- 20 (iv) National Defense Service Medal.
- 21 (v) Iraq Campaign Medal.
- 22 (vi) Global War on Terrorism Service Medal.
- 23 (vii) Sea Service Deployment Ribbon.
- 24 (viii) Hawaiian Medal of Honor by the State of
- Hawaii.
- 26 (b) Designation. -- The portion of Pennsylvania Route 41 (Gap
- 27 Newport Pike) from the intersection with Bernard Avenue to the
- 28 intersection with Highland Road in West Fallowfield Township,
- 29 Chester County, is designated as the Corporal Brandon Hardy
- 30 Memorial Highway.

- 1 (c) Signs. -- The Department of Transportation shall erect and
- 2 maintain appropriate signs displaying the name of the highway to
- 3 traffic in both directions on the highway.
- 4 Section 2. SFC Randall Shughart Memorial Bridge.
- 5 (a) Findings.--The General Assembly finds and declares as
- 6 follows:
- 7 (1) Sergeant First Class Randall David "Randy" Shughart
- 8 was born August 13, 1958, in Lincoln, Nebraska, into an Air
- 9 Force family.
- 10 (2) The Shugharts moved to Newville, Pennsylvania, after
- 11 SFC Shughart's father left the United States Air Force,
- 12 living on and tending to a dairy farm.
- 13 (3) SFC Shughart joined the United States Army while
- 14 attending Big Spring High School in Newville and entered upon
- 15 graduation.
- 16 (4) SFC Shughart completed a pre-ranger course and was
- granted a slot to attend Army Ranger School, from which he
- 18 graduated and earned the coveted Ranger Tab.
- 19 (5) SFC Shughart left the service for a time and then
- 20 reenlisted into the Army Rangers. He was later assigned to
- 21 "Delta Force" and transferred to Fort Bragg, North Carolina.
- 22 (6) SFC Shughart was deployed to Mogadishu, Somalia,
- with other Delta Force members in the summer of 1993 as part
- of Task Force Ranger.
- 25 (7) On October 3, 1993, SFC Shughart was a member of the
- 26 sniper team during Operation Gothic Serpent, a joint-force
- 27 assault mission to apprehend key advisers to Somali warlord
- 28 Mohamed Farrah Aidid.
- 29 (8) During the assault, Super Six One and Four, two of
- 30 the Army's Black Hawk helicopters providing insertion and air

- 1 support to the assault team, were shot down and crashed in
- 2 the city.
- 3 (9) SFC Shughart and his Delta Sniper Team Leader,
- 4 Master Sergeant Gary Gordon, were inserted approximately 100
- 5 meters from the second crash site, armed with only their
- 6 sniper rifles and sidearms, and made their way to the
- 7 location of the downed Blackhawk.
- 8 (10) When Master Sergeant Gordon and SFC Shughart
- 9 reached Super Six Four, they extracted the pilot, Chief
- 10 Warrant Officer Mike Durant, and other crew members from the
- 11 aircraft and established defensive positions around the
- 12 crash.
- 13 (11) It is believed that Master Sergeant Gordon was
- 14 first to be shot by a mob, which had surrounded the crash
- 15 site.
- 16 (12) SFC Shughart retrieved Master Sergeant Gordon's
- 17 CAR-15 assault rifle and gave it to Chief Warrant Officer
- Durant to use. Shortly after, SFC Shughart was killed, the
- 19 site was overrun and Chief Warrant Officer Durant was beaten
- 20 by the mob before being taken hostage.
- 21 (13) SFC Shughart posthumously received the Medal of
- Honor for his heroic actions and sacrifice.
- 23 (b) Designation. -- The bridge, identified as Bridge Key
- 24 13775, carrying Pennsylvania Route 641 over Big Spring Creek on
- 25 the border of Newville Borough and West Pennsboro Township,
- 26 Cumberland County, is designated as the SFC Randall Shughart
- 27 Memorial Bridge.
- 28 (c) Signs.--The Department of Transportation shall erect and
- 29 maintain appropriate signs displaying the name of the bridge to
- 30 traffic in both directions on the bridge.

- 1 Section 3. Sgt. Edward L. Shannon Memorial Highway.
- 2 (a) Findings. -- The General Assembly finds and declares as
- 3 follows:
- 4 (1) Edward L. Shannon was born March 6, 1895, in
- 5 Mazeppa, Union County.
- 6 (2) He served in World War I with the 103rd Trench
- 7 Mortar Battery in the United States Army.
- 8 (3) On September 26, 1918, Sgt. Shannon bravely gave his
- 9 life for his country after encountering hostile action in the
- 10 Argonne Forest of France.
- 11 (4) Before serving in World War I, Sqt. Shannon fought
- in the Mexican Border War in 1917. For his actions there, he
- 13 was awarded the Mexican Service Medal.
- 14 (5) He is considered a hometown hero to many in the
- 15 community of Mazeppa.
- 16 (b) Designation. -- The portion of Johnson Mill Road (State
- 17 Route 1001) from the bridge over Buffalo Creek (Bridge Key
- 18 33467) to the intersection of Colonel John Kelly Road (State
- 19 Route 1002) in Buffalo Township, Union County, is designated as
- 20 the Sqt. Edward L. Shannon Memorial Highway.
- 21 (c) Signs.--The Department of Transportation shall erect and
- 22 maintain appropriate signs displaying the name of the highway to
- 23 traffic in both directions on the highway.
- 24 Section 4. Firefighter Jerome Guise Memorial Bridge.
- 25 (a) Findings. -- The General Assembly finds and declares as
- 26 follows:
- 27 (1) Jerome S. Guise was born February 15, 1986, in
- 28 Carlisle, Cumberland County.
- 29 (2) Mr. Guise was the father of three children: Kayla,
- 30 Wyatt and Zayden.

- 1 (3) Mr. Guise was a firefighter with the Citizen's Fire
- 2 Company No. 1 in Mount Holly Springs, Cumberland County. He
- 3 served as a live-in, full-time firefighter with the Citizen's

- 12 Pennsylvania Volunteer Infantry 211th on September 12, 1864.

- final assaults on Confederate positions in Petersburg,
- Virginia. On April 2, 1865, he engaged in hostile hand-to-
- hand combat, during which he captured the flags at the Battle
- of Five Forks near Petersburg. The battle was a key turning
- 18 point, as it caused the fall of Richmond and led to the
- 19 surrender of the Northern Virginia Army.
- 20 (9) For their bravery, both men were awarded the
- 21 Congressional Medal of Honor. Both men are considered
- 22 hometown heroes to many in the Westmoreland County community.
