SECOND CONSIDERATION EDUCATION BILL

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in transfers of credits between institutions of higher education, further providing for definitions, for duties of public institutions of higher education and for transfer and articulation oversight committee. (Representatives ROEBUCK, BISHOP, V. BROWN and others) – **Education, May 11, 2015**

This bill amends the Public School Code to provide for uniform standards for awarding college credit for prior learning at public institutions of higher education.

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in tax for education, further providing for exclusions from sales and use tax. (Representatives F. KELLER, BARRAR, CUTLER and others) – **Finance, June 16, 2015**

This amends the Tax Reform Code of 1971 by providing a Sales and Use Tax exclusion on the retail purchase of gun locks and gun safes.

456 An Act amending the act of June 27, 2006 (1st Sp.Sess., P.L.1873, No.1), known as the Taxpayer Relief Act, in senior citizens property tax and rent rebate assistance, further providing for definitions. (Representatives SAMUELSON, HENNESSEY, BARBIN and others) – **Finance, June 16, 2015** **3**

This bill increases the exemption for total death benefits from \$5,000 to \$10,000 when calculating income eligibility for the property tax/rent rebate program.

This bill amends the Public Welfare Code to prohibit benefits eligibility for individuals convicted of drug distribution.

This bill Establishes the Correctional Officers Investigation Procurement Act.

(Representatives GROVE, OBERLANDER, SCHEMEL and others) – **Professional Licensure, June 18, 2015** **1**

This bill amends the Social Workers Marriage and Family Therapists and Professional Counselors Act to provide title protection for Marriage and Family Therapists.
