This bill provides omnibus amendments to the Race Horse Industry Reform Act, which provides regulatory oversight on the horse and harness racing industries.

This bill amends The Administrative Code of 1929 to provide for the Environmental Quality Board.




An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in tax for education, further providing for exclusions from sales and use tax. (Representatives F. KELLER, BARRAR, CUTLER and others) – Finance, December 18, 2015 7

This amends the Tax Reform Code of 1971 by providing a Sales and Use Tax exclusion on the retail purchase of gun locks and gun safes.

HOUSE421456An Act amending the act of June 27, 2006 (1st Sp.Sess.,<br/>P.L.1873, No.1), known as the Taxpayer Relief Act, in senior<br/>citizens property tax and rent rebate assistance, further providing<br/>for definitions. (Representatives SAMUELSON, HENNESSEY,<br/>BARBIN and others) - Finance, December 18, 2015

*This bill increases the exemption for total death benefits from \$5,000 to \$10,000 when calculating income eligibility for the property tax/rent rebate program.* 



This bill amends the Tax Reform Code to tax all lottery winnings.

This bill amends the Game Code to remove the restriction on the use of semi automatic rifles for hunting.



This bill amends Article V of the PA constitution to provide for the appointment of justices to the Supreme Court and judges to the Superior and Commonwealth Courts; and establishing the Appellate Court Nomination Commission.

This bill Establishes the Correctional Officers Investigation Procurement Act.

This bill amends the Second Class Township Code to further provide for the completion and publication dates of the annual audit and financial statement and to authorize publication of a brief summary of the financial statement in lieu of a concise financial statement.

An Act amending the act of July 2, 1993 (P.L.345, No.48), entitled "An act empowering the General Counsel or his designee 948 to issue subpoenas for certain licensing board activities; providing for hearing examiners in the Bureau of Professional and Occupational Affairs; providing additional powers to the **Commissioner of Professional and Occupational Affairs; and further** providing for civil penalties and license suspension," further providing for civil penalties. This bill provides for empowering the General Counsel or his designee to issue subpoenas for certain licensing board activities.



This bill amends the Vehicle Code to allow for a registration fee refund and to eliminate the semi-annual inspection requirements on motor carrier vehicles over 17,000 pounds.
