#### SECOND CONSIDERATION COMMERCE BILL

HOUSE 1213 1486

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in consolidated county assessment, further providing for short title and scope of chapter and for appeals by taxing districts and providing for standards of redress in appeals. (Representatives KAMPF, GODSHALL, McGINNIS and others) - Commerce, June 27, 2017

OVER

This bill provides for short title and scope of chapter and for appeals by taxing districts.

#### SECOND CONSIDERATION CONSUMER AFFAIRS BILL

HOUSE **179** 

An Act amending Title 66 (Public Utilities) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in contract carrier by motor vehicle and broker, further providing for declaration of policy and definitions; and, in violations and penalties, further providing for unauthorized operation by carriers and brokers. (Representatives DAY, KNOWLES, D. COSTA and others) – Consumer Affairs, June 27, 2017

OVER

This bill amends Title 66 to increase penalties for unlicensed household goods movers operating in the Commonwealth.

#### SECOND CONSIDERATION FINANCE BILL

**332** 

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives GROVE, BLOOM, NELSON and others) – Finance, June 22, 2017 5

OVER

This bill provides for classes of income.

#### SECOND CONSIDERATION HUMAN SERVICES BILL

**SENATE** 

**446** 1024 An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for certified drug and alcohol recovery houses and establishing the Certified Drug and Alcohol Recovery House Account. (Senators McGARRIGLE, YAW, SCARNATI and others) – Human Services, June 29, 2017

VOTE



This bill amends the Administrative Code to require the Department of Drug and Alcohol Programs to license or certify drug and alcohol recovery houses which receive public funding.

#### SECOND CONSIDERATION INSURANCE BILLS

HOUSE

1789

An Act amending the act of March 20, 2002 (P.L.154, No.13), known as the Medical Care Availability and Reduction of Error (Mcare) Act, in medical professional liability, providing for punitive damages study. (Representatives MENTZER, ZIMMERMAN, HICKERNELL and others) – Insurance, June 5, 2017

OVER

This bill provides for punitive damages study.

HOUSE

1576 2064

An Act amending the act of May 17, 1921 (P.L.789, No.285), known as The Insurance Department Act of 1921, providing for limited lines travel insurance. (Representatives PICKETT AND DeLUCA) - Rules, June 21, 2017

OVER

This bill provides for limited lines travel insurance.

#### SECOND CONSIDERATION JUDICIARY BILLS

HOUSE 111 1699

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives CUTLER, DEAN, DRISCOLL and others) – Judiciary, June 27, 2017

OVER

This bill is a summary of proposed legislation and is prepared only as general information for use by the Republican Members and staff of the Pennsylvania House of Representatives.

HOUSE

/ <mark>4</mark> 1497 An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in protection from abuse, further providing for relief. (Representatives MARSICO, READSHAW, KNOWLES and others) – Judiciary, June 22, 2017

OVER

This bill amends the Protection From Abuse Act to add another type of relief for the plaintiff by allowing the court to order the defendant to refrain from abusing the plaintiff's cat or dog.

**HOUSE 479** 

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in intergovernmental cooperation, further providing for ordinance, for content of ordinance, for joint purchases with private educational establishments, for required review of specified agreements and for effect of joint cooperation agreements. (Representatives SCHEMEL, BENNINGHOFF, A. HARRIS and others) – Local Government, June 29, 2017

VOTE



This bill provides for ordinance, for content of ordinance, for joint purchases with private educational establishments, for required review of specified agreements and for effect of joint cooperation agreements.

**HOUSE 480** 

**50**4

An Act amending the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, in corporate powers, further providing for intergovernmental cooperation. (Representatives SCHEMEL, BENNINGHOFF, A. HARRIS and others) – Local Government, June 29, 2017

VOTE



This bill provides for intergovernmental cooperation.

#### **SECOND CONSIDERATION** LOCAL GOVERNMENT BILLS

**HOUSE** 481

An Act amending Title 11 (Cities) of the Pennsylvania 505 Consolidated Statutes, in corporate powers, further providing for municipal authorities and cooperation with other political subdivisions. (Representatives SCHEMEL, BENNINGHOFF, A. HARRIS and others) - Local Government, June 29, 2017

VOTE



This bill provides for municipal authorities and cooperation with other political subdivisions.

**HOUSE** 641

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in assessments of persons and 1712 property, providing for senior property tax freeze. (Representatives GROVE, SCHWEYER, JAMES and others) - Local Government, June 7, 2017

OVER

This bill establishes an Optional Senior Property Tax Freeze program.

#### SECOND CONSIDERATION PROFESSIONAL LICENSURE BILL

**HOUSE** 1001

An Act regulating home inspectors; establishing the Home Inspection Licensing Board; providing for licensure and practice, 2093 for disciplinary action, for remedies and for penalties; making an appropriation; and repealing provisions relating to home inspections. (Representatives HELM, KORTZ, BIZZARRO and others) - Rules, June 28, 2017

VOTE



This bill creates a freestanding act known as the Home Inspector Licensing Act to establish the Home Inspector Licensing Board within the Department of Labor and Industry.

#### SECOND CONSIDERATION STATE GOVERNMENT BILL

**HOUSE** 

An Act amending Title 65 (Public Officers) of the Pennsylvania Consolidated Statutes, in lobbying disclosure, further providing for registration, for reporting, for prohibited activities, for penalties and for registration fees, fund established, system and regulations. (Representatives CUTLER, NEUMAN, MATZIE and others) - State Government, June 26, 2017

VOTE



This bill provides for registration, for reporting, for prohibited activities, for penalties and for registration fees, fund established, system and regulations.

### SECOND CONSIDERATION TOURISM AND RECREATIONAL DEV. BILL

HOUSE **544** 

An Act amending the act of February 2, 1966 (1965 P.L.1860, No.586), entitled "An act encouraging landowners to make land and water areas available to the public for recreational purposes by limiting liability in connection therewith, and repealing certain acts," further providing for liability for landowners to recreational users; and providing for attorney fees and court costs. (Representatives MOUL, GREINER, PICKETT and others) - Rules, June 28, 2017

VOTE



This bill provides for liability for landowners to recreational users.

#### SECOND CONSIDERATION TRANSPORTATION BILL

**SENATE 589** 

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for the definition of "stinger-steered automobile" or "boat transporter"; and, in size, weight and load, further providing for fire apparatus, for length of vehicles and for maximum gross weight of vehicles. (Senators LANGERHOLC, TOMLINSON, EICHELBERGER and others) - Transportation. June 29, 2017

VOTE



This bill amends Title 75 by providing a weight exemption for natural gas vehicles to exceed the gross vehicle weight, by no more than 2,000 pounds.

SENATE 365

An Act amending the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, in corporate powers, further providing for personal property. (Senators GORDNER, VULAKOVICH, COSTA and others) – Appropriations, June 22, 2017 Fiscal-Note Attached

OVER

This bill provides for personal property.
