SECOND CONSIDERATION COMMERCE BILLS

HOUSE **593**

An Act amending Title 64 (Public Authorities and Quasi-Public Corporations) of the Pennsylvania Consolidated Statutes, in 625 Commonwealth Financing Authority, further providing for Second Stage Loan Program. (Representatives THOMAS, DRISCOLL, McNEILL and others) - Rules, January 24, 2018

OVER

This bill provides for Second Stage Loan Program.

HOUSE 1213

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in consolidated county assessment, further providing for short title and scope of chapter and for appeals by taxing districts and providing for standards of redress in appeals. (Representatives KAMPF, GODSHALL, McGINNIS and others) - Commerce, November 21, 2017

OVER

This bill provides for short title and scope of chapter and for appeals by taxing districts.

HOUSE

1846

An Act amending the act of December 22, 2005 (P.L.474, No.94), known as the Breach of Personal Information Notification Act, 2588 further providing for definitions and for notification of breach; providing for notification; further providing for notice exemption; and further providing for civil relief. (Representatives ELLIS, IRVIN, RABB and others) - Commerce, January 22, 2018

OVER

This bill provides for the Breach of Personal Information Notification Act.

SECOND CONSIDERATION COMMERCE BILLS

HOUSE 1847

An Act amending the act of November 29, 2006 (P.L.1463, No.163), known as the Credit Reporting Agency Act, further providing for definitions and for fees; providing for credit monitoring and consumer reports; and prohibiting the waiver of rights; and further providing for civil relief. (Representatives DRISCOLL, THOMAS, MILLARD and others) - Commerce, January 22, 2018

OVER

This bill provides for the Credit Reporting Agency Act.

SECOND CONSIDERATION CONSUMER AFFAIRS BILL

HOUSE 179

An Act amending Title 66 (Public Utilities) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in contract carrier by motor vehicle and broker, further providing for declaration of policy and definitions; and, in violations and penalties, further providing for unauthorized operation by carriers and brokers. (Representatives DAY, KNOWLES, D. COSTA and others) - Consumer Affairs, November 21, 2017

OVER

This bill amends Title 66 to increase penalties for unlicensed household goods movers operating in the Commonwealth.

SECOND CONSIDERATION FINANCE BILLS

HOUSE 332

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, further providing for classes of income. (Representatives GROVE, BLOOM, NELSON and others) – Finance, November 13, 2017

OVER

This bill provides for classes of income.

HOUSE 1105

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in realty transfer tax, further providing for definitions and for exempt parties. (Representatives RYAN, BARRAR, BOBACK and others) - Rules, January 24, 2018

OVER

This bill amends the Tax Reform Code to clarify the realty transfer tax exemption for veteran's organizations.

SECOND CONSIDERATION FINANCE BILLS

HOUSE 1401 2610

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, providing for volumetric severance tax; and making a related repeal. (Representatives DiGIROLAMO, DeLISSIO, MURT and others) - Finance, January 24, 2018

OVER

This bill amends the Tax Reform Code to provide a natural gas severance tax.

HOUSE 1406 1772

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in personal income tax, repealing provisions relating to contribution for Korea/Vietnam Memorial National Education Center and further providing for operational provisions. (Representatives COX, PETRARCA, DRISCOLL and others) - Finance, October 26, 2017

OVER

This bill repeals provisions relating to contribution for Korea/Vietnam Memorial National Education Center and further providing for operational provisions.

SECOND CONSIDERATION HEALTH BILLS

HOUSE 358

An Act providing for a volunteer health care practitioner certification; and imposing powers and duties on the Department of Health. (Representatives BAKER, PICKETT, MURT and others) - Health, November 27, 2017

OVER

This bill creates the Volunteer Health Care Practitioner Act.

HOUSE

An Act prohibiting certain benefit packages for children's health care and medical assistance to include gender or sex reassignment surgery or gender or sex transition services. (Representatives TOPPER, BAKER, BARRAR and others) – Health, December 4, 2017

OVER

This bill creates the Taxpayer-Funded Genera or Sex Reassignment Services Act.

SECOND CONSIDERATION HUMAN SERVICES BILL

HOUSE 1024

An Act amending the act of October 7, 2010 (P.L.484, No.70), known as the Adult Protective Services Act, in reporting suspected abuse by employees, providing for Statewide adult abuse registry. (Representatives BENNINGHOFF, BIZZARRO, BOBACK and others) - Human Services, December 13, 2017 5

OVER

This bill establishes a statewide adult abuse registry within the Department of Human Services.

SECOND CONSIDERATION INSURANCE BILLS

HOUSE **1286**

An Act amending the act of March 20, 2002 (P.L.154, No.13), known as the Medical Care Availability and Reduction of Error (Mcare) Act, in medical professional liability, providing for punitive damages study. (Representatives MENTZER, ZIMMERMAN, HICKERNELL and others) – Insurance, December 5, 2017

OVER

This bill provides for punitive damages study.

HOUSE **1576**

An Act amending the act of May 17, 1921 (P.L.789, No.285), known as The Insurance Department Act of 1921, providing for limited lines travel insurance. (Representatives PICKETT AND DeLUCA) - Rules, October 26, 2017

OVER

This bill provides for limited lines travel insurance.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, changing and adding provisions relating to selection of justices and judges. (Representatives CUTLER, DEAN, DRISCOLL and others) – Judiciary, November 21, 2017

OVER

This bill is a summary of proposed legislation and is prepared only as general information for use by the Republican Members and staff of the Pennsylvania House of Representatives.

SECOND CONSIDERATION JUDICIARY BILLS

HOUSE

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in protection from abuse, **further providing for relief.** (Representatives MARSICO, READSHAW, KNOWLES and others) - Judiciary, November 13,

OVER

This bill amends the Protection From Abuse Act to add another type of relief for the plaintiff by allowing the court to order the defendant to refrain from abusing the plaintiff's cat or dog.

HOUSE 383

An Act amending Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes, in ownership of property 386 and legal title and equitable estate, further providing for right to dispose of a decedent's remains. (Representatives READSHAW, BARBIN, KORTZ and others) - Rules, November 27, 2017

OVER

This bill amends the Probate, Estates and Fiduciaries Code to provide for "majority rule" in decisions regarding the disposition of a decedent's remains.

SECOND CONSIDERATION LIQUOR CONTROL BILL

HOUSE

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for authority to issue liquor licenses to hotels, restaurants and clubs, for sale of malt or brewed beverages by liquor licensees, for retail dispensers' restrictions on purchases and sales and for premises to be vacated by patrons. (Representatives MARSHALL, MILLARD, MULLERY and others) - Liquor Control, December 4, 2017

OVER

This bill amends Title 47 to allow club license holders to sell six packs to their members.

SECOND CONSIDERATION LOCAL GOVERNMENT BILLS

HOUSE 641

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in assessments of persons and 1712 property, providing for senior property tax freeze. (Representatives GROVE. SCHWEYER. JAMES and others) - Local Government. **December 11, 2017**

OVER

This bill establishes an Optional Senior Property Tax Freeze program.

SECOND CONSIDERATION **LOCAL GOVERNMENT BILLS**

HOUSE

An Act amending the act of December 18, 1984 (P.L.1005, No.205), known as the Municipal Pension Plan Funding Standard 1365 and Recovery Act, in standards for municipal pension systems, further providing for definitions and providing for special procedures for certain professional services contracts. (Representatives BRIGGS AND GODSHALL) - Rules, December 12,

OVER

This bill provides for definitions and providing for special procedures for certain professional services contracts.

SENATE 403

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in employees, further providing 1228 for commission members. (Senators BREWSTER, GREENLEAF, RESCHENTHALER and others) - Local Government, December 12, 2017

OVER

This bill amends Title 53 to remove the FBI from the Municipal Police Officers Education and Training Commission and replaces them with a member of the State FOP.

SECOND CONSIDERATION VETERANS AFFAIRS & EMERGENCY PREP. BILLS

HOUSE

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in grants to fire companies and emergency medical services companies, further providing for definitions, for award of grants and for requiring fire companies and emergency medical services companies to establish a social media policy in order to be eligible to receive grant funds. (Representatives BARRAR, SAINATO, BARBIN and others) - Veterans Affairs & Emergency Preparedness, January 24, 2018

OVER

This bill provides for social media policies for Fire and EMS Departments.

HOUSE

An Act authorizing the Commonwealth of Pennsylvania to join the Physical Therapy Licensure Compact; and providing for the form of the compact. (Representatives BARRAR, V. BROWN, P. COSTA and others) - Veterans Affairs & Emergency Preparedness, **January 24, 2018**

OVER

This bill establishes the Commonwealth participation in the Physical Therapists Compact, thereby allowing licensure reciprocity for military spouses that work in Pennsylvania.

THIRD CONSIDERATION LOCAL GOVERNMENT BILLS

HOUSE 479

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in intergovernmental cooperation, further providing for ordinance, for content of ordinance, for joint purchases with private educational establishments, for required review of specified agreements and for effect of joint cooperation agreements. (Representatives SCHEMEL, BENNINGHOFF, A. HARRIS and others) – Appropriations, October 26, 2017 Fiscal-Note Attached

OVER

This bill amends the PA Intergovernmental Cooperation Law to allow intergovernmental cooperation by resolution unless the authorizing statute requires an ordinance.

HOUSE 480

An Act amending the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, in corporate powers, further providing for intergovernmental cooperation. (Representatives SCHEMEL, BENNINGHOFF, A. HARRIS and others) – Appropriations, October 26, 2017 Fiscal-Note Attached

OVER

This bill amends the Second Class Township Code to delete the phrase "by ordinance" from the provisions governing intergovernmental cooperation agreements.

HOUSE

481

An Act amending Title 11 (Cities) of the Pennsylvania Consolidated Statutes, in corporate powers, further providing for municipal authorities and cooperation with other political subdivisions. (Representatives SCHEMEL, BENNINGHOFF, A. HARRIS and others) – Appropriations, October 26, 2017 Fiscal-Note Attached

OVER

This bill amends the Third Class Township Code to delete the phrase "by ordinance" from the provisions governing intergovernmental cooperation agreements.

HOUSE
