21 requirements, speed requirements, geofencing, rider
22 limit, fleet size and maintenance, pedestrian
23 interaction, parking and charging stations.

24 (ii) Data management and reporting.

25 (iii) Education, public awareness and public
26 participation.

27 (iv) Violations and enforcement.

28 (v) Fare structure.

29 (vi) Insurance.

30 (2) Notwithstanding any other provisions of law, a city
31 of the second class or an authorized municipality may adopt a
32 subsequent ordinance, policy or regulation consistent with
33 this section for the safety, operation and management of the
34 program.

35 (3) A city of the second class or an authorized
36 municipality shall notify the department of any ordinance,
37 policy or regulation adopted under this section.
