23 known as the State Lottery Law, of lottery prizes and

25 prior fiscal year and shall make the transfer under paragraph
26 (2), if applicable.

27 (2) If such balance is less than the balance from the
28 prior fiscal year determined in the same manner, the
29 department shall transfer an amount equal to the difference
