9 (a) In which his unemployment is due to failure, without  
10 good cause, either to apply for suitable work at such time and  
11 in such manner as the department may prescribe, or to accept  
12 suitable work when offered to him by the employment office or by  
13 any employer, irrespective of whether or not such work is in  
14 "employment" as defined in this act: Provided, That such  
15 employer notifies the employment office of such offer within  
16 [seven (7)] fourteen (14) days after the making thereof; however  
17 this subsection shall not cause a disqualification of a waiting  
18 week or benefits under the following circumstances: when work is  
19 offered by his employer and he is not required to accept the  
20 offer pursuant to the terms of the labor-management contract or  
21 agreement, or pursuant to an established employer plan, program  
22 or policy: Provided further, That a claimant shall not be  
23 disqualified for refusing suitable work when he is in training  
24 approved under section 236(a)(1) of the Trade Act of 1974.
