7 Section 1. Section 1304(a)(2) of the act of June 27, 2006
8 (1st Sp.Sess., P.L.1873, No.1), known as the Taxpayer Relief
9 Act, is amended to read:

10 Section 1304. Property tax; and rent rebate.

11 (a) Schedule of rebates.--

13 (2) The following apply:

14 (i) The base amount of any claim for property tax
15 rebate for real property taxes due and payable during
16 calendar year 2006 and thereafter shall be determined in
17 accordance with the following schedule:

Household Income	Amount of Real Property Taxes Allowed as Rebate
19 \$ 0 - \$ 8,000	[500] <u>\$750</u>
20 8,001 - 15,000	[500] <u>600</u>
21 15,001 - 18,000	[300] <u>400</u>
22 18,001 - 35,000	[250] <u>350</u>
23 <u>35,001 - 40,000</u>	<u>250</u>
24 <u>40,001 - 45,000</u>	<u>150</u>

26 (ii) The supplemental amount for a claimant with a
27 household income equal to or less than \$30,000 and an
28 eligible claim for property tax rebate for real property
29 taxes due and payable during the calendar year preceding
30 the first year in which a payment under section 505(b) is
31 made and each year thereafter and whose real property
32 taxes exceed 15% of the claimant's household income shall
33 be equal to 50% of the base amount determined under
34 subparagraph (i). A claimant who is a resident of a city
35 of the first class, a city of the second class A or a

1 school district of the first class A shall be ineligible
2 for the supplemental amount under this subparagraph.
